### Scope and Nature of the *ERISA* Section 103(a)(3)(C) Audit

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Valley Residential Services 401(k) Plan's ability to continue as a going concern, for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the *ERISA* Section 103(a)(3)(C) section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Valley Residential Services 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Valley Residential Services 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an *ERISA* Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by *ERISA***

The schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is a supplemental schedule and is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of *Labor's Rules and Regulations for Reporting and Disclosure* under *ERISA*. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under *ERISA*.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under *ERISA*.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of *ERISA* Section 103(a)(3)(C).

### 1. DESCRIPTION OF PLAN

The following brief description of the Valley Residential Services 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General.** The Plan is a qualified defined contribution plan covering substantially all employees of the participating company who have completed a year of service defined by the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*.

**Income Tax Status.** The Internal Revenue Service has determined and informed the Company by a letter dated March 22, 2021, that the Plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *Internal Revenue Code* and, therefore, believes that the Plan is qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Contributions.** Each participant makes voluntary contributions up to a maximum of 100 percent of the participant's salary or the annual limits published by the IRS, whichever is less. If the participant attained age 50 before the end of the year, then that participant may elect to defer additional amounts (called "catch up contributions") to the Plan for that year. The Company may make a discretionary matching contribution for elective deferrals on a pay period basis. The matching contribution for 2024 was roughly 66% percent of employee deferrals. The employee must work 1,000 hours and be employed on the last day of the year to receive the matching contribution.

**Participant Accounts.** Each participant's account is credited each pay period with the participant's contribution. Plan investment income and unrealized gains or losses are allocated to participant accounts daily. Earnings are allocated based upon account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits.** Upon retirement or termination of service, the balance of the participant's account will be distributed as a single lump-sum cash payment.

**Vesting.** Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on the elapsed time method, and credit is given on the anniversary of each participant's original hire date. Participants are vested at 25 percent per year starting with the second year of service. A participant is 100 percent vested after five years of service.

The Plan has allocated \$192,674 in vested benefits to participants who have terminated participation in the Plan as of December 31, 2024.

### 1. DESCRIPTION OF PLAN (CONTINUED)

**Forfeited Accounts.** Forfeitures of \$5,538 were used to reduce employer contributions in the current year (\$6,533 in 2023). At December 31, 2024, forfeited non-vested accounts totaled \$3,725 (\$4,277 in 2023).

**Administrative Expenses.** The Plan will pay some or all Plan related expenses except for a limited category of expenses known as "settler expenses." The expenses charged to the Plan may be charged pro rata to each participant in relation to the size of each participant's account balance or may be charged equally to each participant. Some types of expenses may be charged only to some participants based upon their use of a Plan feature or receipt of a Plan distribution. Administrative expenses may be paid by forfeitures.

**Plan Termination.** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of *ERISA*. In the event of Plan termination, participants would become 100 percent vested in the Company contribution portion of their account.

### 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of Accounting.** The financial statements of the Valley Residential Services 401(k) Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**Investment Valuation and Income Recognition.** Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent Events.** The Plan has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.

**Payments of Benefits.** Benefits are recorded when paid.

### 4. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1, or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

#### Level 1 Fair Value Measurements

The fair value of cash is valued at fair value due to the nature of cash always being valued at fair value.

#### Level 2 Fair Value Measurements

The fair value of pooled separate accounts is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

### 5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 6. RELATED PARTY TRANSACTIONS

Plan fees for investment management, recordkeeping, investment advising, and Plan auditing qualify as party-in-interest transactions. Investment management fees are only charged to participants that have elected to have a managed account. Fees paid by the Plan for these services in 2024 amounted to \$14,276.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of *ERISA*.
