### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Astorg 401(k) Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Astorg 401(k) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Other Matter**

### *Supplemental Schedule Required by ERISA*

The supplemental schedule of Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional

procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Note 1 – Plan Description

---

The following description of the Astorg 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of Star Holding Company, AutoiPacket, LLC, Astorg Auto of Charleston and Astorg Motor Company, Inc., Astorg Ford of Parkersburg, Inc., Astorg Imports, Inc., Astorg Pre-owned at Lakeview, Inc., and Astorg Auto of Parkersburg, LLC dba Astorg Hyundai of Parkersburg (collectively “the Company”). Effective June 1, 2024, Astorg Auto of Parkersburg, LLC dba Astorg Hyundai of Parkersburg adopted the plan. Employees are eligible to participate in the Plan upon attaining age 21 and completing one year of service or 1,000 hours. Certain employees are not eligible to participate, including members of a collective bargaining agreement, non-resident aliens, and leased employees. In addition, “Drivers” with Smith Motor Cars, Inc., who were not participating in the Plan as of December 31, 2004, are excluded from participation in the Plan. The administrator of the Plan is Astorg Auto of Charleston. Empower Retirement, LLC serves as the custodian. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2023, all employees of all participating employers became eligible to participate in the Plan upon completing six months of service for elective deferrals and employer matching.

#### *Contributions*

Each year participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, not to exceed the maximum allowable under the *Internal Revenue Code (IRC)*. Certain limitations are set for those classified as highly compensated employees (HCE). Participants may also elect to designate their contributions to the Plan as after-tax Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Effective January 1, 2020, if a deferral election is not received, participants will be automatically enrolled to defer 3% of their compensation. An annual increase of 1% will follow, up to a maximum of 6%. Participants direct the investments of all contributions into various investment options offered by the Plan. The Company’s contributions consist of a discretionary matching contribution equal to a percentage of the amount of the salary reduction elected by the employee. Contributions are subject to certain limitations. For the year ended December 31, 2024, the Company made a matching contribution of 39% of the participant’s matched employee contributions, not in excess of 6.5% of participant’s compensation to the Plan.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### *Vesting*

Participants are immediately vested in their employee contributions plus actual earnings thereon. Vesting in the employer contribution portion of their account plus actual earnings thereon is based on years of credited service, as follows:

Less than 1	10%
Less than 2	20%
Less than 3	40%
Less than 4	60%
Less than 5	80%
5 years or more	100%

### *Notes Receivable from Participants*

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50%, which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

### *Payment of Benefits*

On termination of service due to death, disability, retirement or other, a participant is to receive a lump-sum amount equal to the value of the participant's vested account balance. The Plan provides for hardship withdrawals for specific purposes outlined in the Plan document. A participant who has reached age 73 and is still employed may elect to commence retirement benefits as of that date. Additionally, the Plan requires involuntary cash-outs of \$7,000 or less upon termination of service.

### *Forfeitures*

Forfeitures are used to pay plan expenses or to reduce future employer contributions. Forfeited, nonvested accounts totaled \$34,621 and \$28,475 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeitures of \$5,786 were used to reduce employer contributions.

## **Note 2 – Significant Accounting Policies**

---

### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting.

### *Use of Accounting Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosures. Accordingly, the actual amounts could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a settlement date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes from participants are valued at their unpaid principal balances plus any accrued interest which approximates fair value. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### *Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by HCE limits imposed by the Plan are recorded as a liability with a corresponding reduction in contributions.

### *Benefit Payments*

Benefits are recorded when paid.

### *Subsequent Events*

Subsequent events have been evaluated through October 10, 2025, the date the financial statements were available to be issued.

### Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Unit value calculated based on the observable net asset value of the underlying investment.

### Note 5 – Investment Contract with Insurance Company

The Plan holds a guaranteed investment contract where Empower Retirement maintains the contributions in the general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment issuer is financially obligated to repay the principal and the specified interest rate to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the contract value of the investment contract held by the Plan:

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The investment has a portfolio investment rate design in which all deposits in the investment are credited with the same interest rate on a daily basis, with no set maturity. Such interest rates are reviewed on a quarterly basis for resetting. There is a minimum interest rate of 1.0%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial plan termination, or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

---

### Note 6 – Related Party Transactions and Parties-in-Interest

---

Certain investments of the Plan are various funds managed by Empower Retirement, the Custodian of the Plan. Such investment transactions, therefore, qualify as exempt party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee received compensation from the Plan. The Company pays certain administrative fees on behalf of the Plan, including legal, accounting, trustee, and administrative fees and provides certain administrative services to the Plan at no cost.

---

### Note 7 – Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

---

### Note 8 – Income Tax Status

---

The Plan adopted a pre-approved profit sharing plan with a deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the *IRC*. Although the Plan has been amended since receiving the volume submitter plan's opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

---

### Note 9 – Risks and Uncertainties

---

The Plan invests in various investment securities. Investments securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.



