INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Apollo Technology Group, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Apollo Technology Group, LLC 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023**

(1) DESCRIPTION OF PLAN

The following description of the Apollo Technology Group, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan sponsored by Apollo Technology Group, LLC (the “Company”) for the benefit of its employees over age eighteen. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (“ERISA”).

The Plan is administered by the Company’s Investment Committee (“Committee”). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions – Participating employees may contribute to the Plan up to the maximum allowed by law of their eligible annual compensation as defined in the Plan, as either a pre-tax or Roth deferred contribution. Participation in the Plan commences on the first day after becoming eligible. Participants may also contribute, as rollover contributions, amounts representing distributions from other qualified plans. Additionally, participants age 50 or older, who are making deferred contributions to the Plan, are allowed to make catch-up contributions, as defined in the Plan agreement. Participants direct the investment of all contributions into various investment options offered by the Plan. Participants may make changes to their elective deferral contribution rates each payroll period and may terminate their elective deferral at any time.

The Company makes a discretionary matching contribution of participants’ elective deferral contribution of 25% of the first 4% of eligible participant contributions. Additional profit-sharing amounts may be contributed at the option of the Company. During the year ended December 31, 2024, the Company made no discretionary profit-sharing contributions to the Plan. Contributions are subject to certain Internal Revenue Code (“IRC”).

Participant investment account options – The Plan currently offers a variety of pooled separate accounts as investment options for participants. Participants may change their investment designation with respect to their account balance and future contributions at any time.

Participant accounts - Each participant’s account is credited with the participant’s contributions, rollover contributions from other qualified plans, Company matching contributions, if any, the related earnings (losses) from investment options chosen by each individual and an allocation of administrative expenses. Allocations of earnings (losses) and expenses are based on account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are always fully vested in their contributions and rollover contributions plus actual earnings (losses) thereon. Participants are also 100% vested in Company matching contributions plus actual earnings (losses). Participants become 20% vested in their respective portion of the Company’s profit-sharing contributions after one year of service and vest an additional 20% annually thereafter until they are fully vested after five years of qualified service. In the event of retirement after attainment of age 62, death, disability or termination of the Plan, participants become fully vested.

(1) DESCRIPTION OF PLAN (CONTINUED)

Forfeitures – If a participant terminates employment for any reason other than death, disability or retirement, the unvested portion of the participant's account, if any, is forfeited. At both December 31, 2024 and 2023, forfeited nonvested accounts were \$122. Forfeitures may be used to reduce future employer contributions or pay Plan expenses.

Notes receivable from participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of benefits – On termination of service, retirement, death or disability, a participant may elect to receive either a lump sum amount equal to the value of his or her vested account or a series of cash payments if they have achieved retirement age.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest is recorded as earned on an accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of benefits – Benefit payments are recorded in the period in which the benefit is paid.

Administrative expenses – Costs of administering the Plan are paid by the Company except for investment management expenses and fees incurred for participant loans and distribution payments to participants. Fees for participant loans and distribution payments are charged to individual participant accounts.

(3) INFORMATION PREPARED AND CERTIFIED BY THE PLAN CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company, (John Hancock) the Plan custodian, has certified that the following data included in the accompanying financial statements is complete and accurate with respect to investments:

- Investments at fair value at December 31, 2023
- Notes receivable from participants at December 31, 2023
- Net appreciation in fair value of investments
- Interest income on notes receivable from participants

Non-interest bearing cash and notes receivable from participants at December 31, 2024 were not certified by John Hancock.

The Plan's independent public accountants did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements.

(4) FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(4) FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts are valued at the NAV of units of the separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily and there are no restrictions on redemptions. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner. Additionally, there are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Subtopic 820-10, the pooled separate accounts that were measured at NAV (or its equivalent) practical expedient have not been classified in the fair value hierarchy. No Plan investments are classified in the fair value hierarchy.

(5) RELATED PARTY TRANSACTIONS

Plan investments were pooled separate accounts managed by John Hancock. John Hancock is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third party administrator and other service providers of \$70,092 for the year ended December 31, 2024, which was not covered by revenue sharing. The Plan paid certain expenses related to the Plan's operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

(6) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be 100% vested in their profit-sharing contributions.

(7) TAX STATUS

The Internal Revenue Service has determined that the Plan is designed in accordance with applicable sections of the IRC and informed the Trustee of such in a letter dated June 30, 2020. The plan administrator has adopted the pre-approved plan and believes that the Plan and related trust are currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) RISKS, UNCERTAINTIES, AND CONCENTRATIONS

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024, there were no significant concentrations of the Plan's investments. At December 31, 2023, approximately 34% of the Plan's investments were invested in the BlackRock LifePath Index 2040 and the 500 Index fund.

(9) SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued. The following significant matters were identified for disclosure during this evaluation:

The Plan changed custodians from John Hancock to Empower Trust Company, LLC ("Empower") on January 1, 2025. On January 2, 2025, John Hancock transferred approximately \$10,007,000 in non-interest bearing cash and approximately \$184,000 of notes receivable to Empower.

Effective January 1, 2025 the name of the Plan was changed to Apex Water + Process 401(k) Plan. The Plan sponsor changed from Apollo Technology Group, LLC to Apex Water and Process Inc.

In January 2025, the following 401(k) plans merged into the Apex Water + Process 401(k) Plan:

- Weas Engineering, LLC Retirement Readiness 401(k) Plan
- Guardian CSC Corporation 401(k) Profit Sharing Plan and Trust
- Paychex Pooled Employer 401(k) Plan for Aqua Treat Chemicals, Inc.

In conjunction with these plans merging into the Apex Water + Process 401(k) Plan, approximately \$14,371,000 in participants accounts and \$27,000 of notes receivable from participants were transferred in.
