## Note 1 - Description of Plan

The following description of Railroad Construction Company, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

### **a. General**

The Plan is a single-employer defined contribution 401(k) profit sharing plan designed to provide benefits to eligible employees of Railroad Construction Company, Inc., the Plan sponsor. Employees are eligible to participate in the Plan, at date of hire, except those employees who are independent contractors or covered by a collective bargaining agreement which provides for retirement benefits. Entry date for elective deferrals is the first full payroll subsequent to the date of hire. Employees are eligible to receive a matching contribution upon attainment of age 18 and completion of a year of service. A year of service is defined as 1,000 hours of service during a plan year. Entry into the matching component of the Plan is the first full payroll when the eligibility requirement has been satisfied. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan assets are currently held by Principal Trust Company, Custodian of the Plan. Company contributions, participant elective deferrals, and participant accounts are also held by the Custodian, who invests cash received and income from investments based on written instructions from the Company and participants and makes distributions to participants. The Plan Trustees are responsible for oversight of the Plan and for determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

### **b. Contributions**

The Plan provides for automatic enrollment on the first full payroll subsequent to the employee's hire date. Unless the employee elects otherwise, 3% of their eligible compensation will be automatically deferred into the Plan. Each year, participants may contribute a percentage of their pre-tax annual compensation, subject to certain limitations as defined by the Plan and the Internal Revenue Code ("IRC"). The maximum participant deferrals for the years ended December 31, 2024 and 2023 were \$23,000 and \$22,500, respectively. Participants aged 50 and over are also eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified plans, providing they are made within 60 days of receipt of such amounts by an employee.

The Plan provides for matching contributions by the Employers to all eligible employees. During the years ended December 31, 2024 and 2023, the Plan's match was based on 100% of participant deferrals up to 3% of eligible compensation.

The Company, at its discretion, may also make non-elective contributions. During the years ended December 31, 2024 and 2023, the Company elected not to make discretionary contributions.

### **c. Participant Accounts**

Each participant's account is credited with the participant's contribution, allocation of the Company's contributions, and Plan earnings or losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations may be charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *d. Vesting*

Participants are 100% vested immediately in their elective deferral amounts, rollover contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution and the Company's matching contribution is based on years of continuous service. A participant is 100% vested upon: (1) disability; (2) death; (3) normal retirement at age 65; or (4) termination of the Plan. If a participant's employment with the Company is terminated before age 65 for any reason other than disability or death, the participant shall be entitled to an amount equal to the "vested percentage" of his or her account balance. A participant shall have a vested and non-forfeitable interest in the discretionary contribution and Company's matching contribution portion of his or her account balance determined by the number of years of credited service as follows:

0-1 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%

#### *e. Forfeited Accounts*

Forfeited non-vested accounts that can be used to reduce the Company's contributions and for administrative expenses of the Plan totaled \$-0- at December 31, 2024 and 2023. During the years ended December 31, 2024 and 2023, the Company's contributions were reduced by \$11,812 and \$3,258, respectively, from forfeited non-vested accounts.

#### *f. Investment Options*

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

#### *g. Notes Receivable from Participants*

Participants who are active employees may borrow against their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans, in the form of promissory notes, are secured by the balance in the participant's account, and bear interest at reasonable rates, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Loans must be repaid within five years. The Plan allows only two outstanding loans.

### *h. Benefits Paid to Participants*

On termination of service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or elect to rollover funds into an individual retirement account ("IRA") or other retirement account. If the participant does not elect a distribution upon termination and their vested account balance is between \$1,000 and \$5,000, the balance will be directed into an IRA.

Prior to termination, a participant may withdraw their pretax contributions in the event of undue financial hardship. The Plan also provides for in-service distributions for participants who have attained age 59 and one-half.

## Note 2 - Summary of Significant Accounting Policies

### *a. Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

### *b. Use of Estimates*

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *c. Reclassification*

Certain reclassifications may have been made to the 2023 financial statement presentation to correspond to the current year's format. Total net assets available for benefits are unchanged due to these reclassifications.

### *d. Investment Valuation and Income Recognition*

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *e. Notes Receivable from Participants*

Notes receivable from participants are stated at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Loans treated as distributions totaled \$-0- and \$30,568 for the years ended December 31, 2024 and 2023, respectively.

#### *f. Payment of Benefits*

Benefits are recorded when paid.

#### *g. Administrative Expenses*

Certain administrative expenses of the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### *h. Subsequent Events*

Subsequent to the Plan year ended December 31, 2024, the Plan was amended to allow two additional employers, Amtrac Railroad Contractors of Maryland Inc. and Railroad Construction Co. of Texas, Inc, to adopt and participate in the Plan. The amendment was effective January 8, 2025, which is also the date of adoption and participation for both employers. These employers adopted the Plan under a single plan arrangement and will participate in the Plan under the same terms and provisions as the existing employer. The amendment did not affect the rights or benefits of existing Plan participants or the structure of the Plan as of December 31, 2024. Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued, and concluded that no other subsequent events require disclosure.

### Note 3 - Information Certified and Provided by Plan Trustee (Unaudited)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan. The Plan administrator has obtained certifications from the trustee that information provided to the Plan administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedules related to the following assets, income, gains, and losses:

### Note 4 - Investments at Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### Self-Directed Brokerage Accounts and Individual Common Stocks

Valued at the closing price reported on the active market on which the individual securities are traded.

#### Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 5 - Group Annuity Contract

At December 31, 2024 and 2023, the Plan had an investment in a fully benefit-responsive group annuity contract with Principal Life Insurance Company. Under the terms of the contract, the contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. In the event that the Plan Sponsor terminates the contract and requests an immediate payout, the contract payout would be subject to a 5% termination fee. The Plan Administrator does not believe that the occurrence of any other such contract value events, which would limit the Plan's ability to transact at contract value with participants, is probable. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The crediting interest rate of the contract is based on a formula agreed upon with the issuer, as defined in the contract agreement, but cannot be less than zero. Such interest rates are reviewed and reset on a semi-annual basis. The key factors that influence future interest crediting rates could include the following: the level of market interest rates; the amount and timing of participant contributions, transfers, and withdrawals into/out of the contracts; and the duration of the underlying investments backing the contract.

The average yield based on actual earnings for this benefit-responsive contract was 4.85% and 1.55% for the years ended December 31, 2024 and 2023, respectively. The crediting interest rate to participants was 5.05% and 1.70% as of December 31, 2024 and 2023, respectively. Fully benefit-responsive group annuity contracts totaled \$395,435 and \$385,116 for the years ended December 31, 2024 and 2023, respectively.

The Contract is held by a qualified insurance company and its year-end balance has been certified by a qualified insurance company as complete and accurate in accordance with 29 CFR 2520.103-5. Accordingly, the Plan has elected the ERISA Section 103(a)(3)(C) audit option. Under this election, the independent auditor did not perform audit procedures with respect to the investment information certified by the insurance company but compared the information included in the financial statements with the certification and read the related disclosures.

### Note 6 - Related Party Transactions and Transactions with Parties-in-Interest

The Company paid expenses in connection with the administration of the Plan totaling \$24,500 and \$23,500 for the years ended December 31, 2024 and 2023, respectively.

Certain administrative functions are performed by employees of the Company who do not receive compensation for such functions.

Certain Plan investments are managed by Principal Trust Company, the Custodian of the Plan.

### Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, participants will become 100% vested in their accounts.

### Note 8 - Tax Status

The Plan has adopted a Prototype Non-Standardized Profit-Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service as of June 30, 2020. The Plan Administrator believes that the Plan, as designed, is qualified and the related trust is tax-exempt as of the financial statement date.

The Plan's management evaluates tax positions taken by the Plan and recognizes a tax liability or asset if an uncertain tax position was taken and it is more-likely-than-not that the tax position would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions. The Plan is no longer subject to income tax examinations for years prior to 2021.

### **Note 9 - Prohibited Transactions**

For the Plan year ended December 31, 2014, the Company failed to timely remit to the Plan's Custodian certain employee contributions totaling \$6,813 within the period described by the United States Department of Labor ("DOL") regulations due to administrative errors. For the Plan year ended December 31, 2018, the Company failed to timely remit to the Plan's Custodian certain employee contributions totaling \$800 within the period described by the DOL regulations due to administrative errors. For the Plan year ended December 31, 2019, the Company failed to timely remit to the Plan's Custodian certain employee contributions totaling \$391 within the period described by DOL regulations, due to administrative errors. For the Plan year ended December 31, 2021, the Company failed to timely remit to the Plan's Custodian certain employee contributions totaling \$5,045 within the period described by DOL regulations, due to administrative errors. For the Plan year ended December 31, 2022, the Company failed to timely remit to the Plan's Custodian certain employee contributions totaling \$700 within the period described by DOL regulations, due to administrative errors.

### **Note 10 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
