In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.



## INDEPENDENT AUDITOR'S REPORT (CONTINUED)

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### *Other Matter — Supplemental Schedules Required by ERISA*

The supplemental schedules, Schedule H, Line 4a - Schedule of Delinquent Participant Contributions and Schedule H, Line 4i - Schedule of Assets (Held at End of Year), are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. **Description of Plan:**

The following description of the Safariland, LLC 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan was established on July 28, 2012, and restated effective January 1, 2022. The Plan is a 401(k) defined contribution plan covering all employees of Safariland, LLC and subsidiaries (the “Company”). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Effective January 1, 2024, the Plan was amended to provide a Qualified Automatic Contribution Arrangement (“QACA”) in accordance with Internal Revenue Service (“IRS”) Code Section 401(k)(13).

#### *Eligibility*

Employees who are age 18 or older are eligible to participate in the Plan, except union employees, nonresident aliens, and leased employees. Prior to June 17, 2024, eligible employees could enroll immediately following the date the employee satisfied the Plan’s eligibility requirement. Effective June 17, 2024, the Plan was amended to allow employees to participate in the Plan on the first payroll date after completing 30 days of service.

Effective January 1, 2024, the Plan was amended to implement an automatic enrollment provision whereby employees must elect out of the plan if they do not wish to participate. The automatic enrollment provision provides for a 3% salary deferral for the first 2 years, followed by an annual 1% increase up to a maximum of 6%.

#### *Contributions*

Participants may elect to contribute up to 100% of their annual compensation, as defined by the Plan and subject to certain limitations set by the Internal Revenue Code (“IRC”). In addition, employees who have attained age 50 by the end of the Plan year may make catch-up contributions up to limits defined by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Effective January 1, 2024, the Company amended the Plan to provide a QACA safe harbor enhanced matching contribution equal to 100% of a participant’s elective deferrals up to 6% of the participant’s compensation, with a true-up at the end of the year. An additional employer discretionary matching contribution may be made at the option of the Company annually, not to exceed 4% of compensation. During 2024, the Company did not make a discretionary matching contribution.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contributions, allocations of Company contributions, and participant earnings. Participant earnings are based on an allocation of Plan earnings respective to each participant’s account balances and investment selections. Any related administrative expenses based on participant earnings or account balances are deducted from the participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

**1. Description of Plan (Continued):**

*Investment Options*

Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Plan offers a selection of mutual funds, a money market fund, a selection of common collective trusts, and a guaranteed investment contract as investment options for participants.

*Vesting*

Participants are immediately 100% vested in their elective deferrals, including catch-up contributions and rollover contributions from other plans, as well as employer discretionary matching contributions, plus actual earnings thereon.

Vesting in the Company's safe harbor enhanced matching contributions plus actual earnings thereon is based on years of continuous service. A minimum of 1,000 hours of service during a Plan year is required to receive credit for a year of service. A participant is 100% vested after completing 2 years of continuous service. All employer contributions become fully vested in the event of death, disability, or reaching normal retirement age while under the Company's employment.

*Forfeited Accounts*

Forfeitures of nonvested participant balances may be used to pay Plan expenses and reduce future employer contributions. At December 31, 2024, there were \$21,391 forfeited non-vested account balances available to be used. There were no forfeited nonvested participants accounts as of December 31, 2023, and no forfeitures were used to pay Plan expenses or reduce employer contributions during the year ended 2024.

*Notes Receivable from Participants*

Participants may borrow a minimum of \$1,000, up to 50% of their vested contributions and related earnings, not to exceed \$50,000. Participants are permitted one outstanding loan at a time. Loans are secured by the balance in the participant's account and must be repaid in level payments through payroll deductions typically within a 5-year period, except for loans for the purchase of a principal residence which may be repaid over a reasonable period of time not to exceed a maximum of 10 years. The loans bear interest at 2% above the prime rate.

*Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum distribution equal to the vested balance in the individual participant's account. Additionally, hardship withdrawals and certain other in-service withdrawals are also permitted by the Plan if certain criteria are met. Participants may elect to receive an in-service distribution after attaining the age of 59 ½. Account balances that are under \$5,000 may be automatically distributed upon termination of service as a lump sum without the consent of the participant.

**1. Description of Plan (Continued):**

*Administrative Expenses*

In accordance with Plan provisions, the Company or the Plan may pay administrative expenses of the Plan. Recordkeeping and other administrative services expenses are paid by the Plan and allocated to participant accounts. Plan expenses charged for transactions that are participant specific are deducted from the respective participant account.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction in the investment return for such investments.

**2. Summary of Accounting Policies:**

*Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

*Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are presented at fair value, except fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Contract value is the relative measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on the sales of securities are reported on the average cost method.

*Notes Receivable from Participants*

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributed based upon the terms of the Plan document. The loans are secured by the balance in the participants' accounts.

**2. Summary of Accounting Policies (Continued):**

*Payment of Benefits*

Benefits are recorded when paid.

*Risks and Uncertainties*

The Plan provides various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**3. Fair Value Measurements:**

Financial Accounting Standards Board, Accounting Standard Codification Topic 820 ("ASC 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Money Market:* Valued at the amount of cash balances on deposit, which approximates fair value.

*Common Collective Trust:* The Plan invests in a common collective trust which owns investment contracts that may invest in conventional, synthetic, and separate account investment contracts issued by life insurance companies, banks, or other financial institutions. The investment in the common collective trust was valued at net asset value ("NAV") based on the fair value of the underlying securities within the investment in accordance with ASC 820. It is possible that redemption rights may be restricted in the future in accordance with the underlying trust agreements, which could impact the fair value of the Plan's interests in the trust.

*(a)* In accordance with ASC 820, certain investments that were measured at net asset value (“NAV”) have not been classified in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Guaranteed Investment Contract:**

The Plan invests in a group annuity contract with the Standard Insurance Company (“Standard”). Standard maintains the contributions in a separate account product. The account is credited with an interest rate that is determined by the yield of the separate accounts, the market value gain or loss of the contract, and the anticipated cash flow for the next policy period. Standard is contractually obligated to repay the principal plus interest at a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula that is stipulated in the contract and agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis and re-set as needed.

Certain events limit the ability of the Plan to transact at contract value with Standard including the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options, or (3) the Company establishes another savings program, pension or profit sharing plan to which Plan participants are eligible to contribute by payroll deduction. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

**5. Information Certified by the Plan’s Trustee:**

The following investments included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the dividends and interest income, net appreciation in fair value of investments, and interest on notes receivable from participants included in the statement of changes in net assets available for benefits for the year ended December 31, 2024, have been derived from information certified as complete and accurate by Charles Schwab Trust Bank, the trustee of the Plan, in accordance with 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

**6. Party-In-Interest Transactions:**

USI Consulting Group Inc., the Plan recordkeeper, is considered a party-in-interest to the Plan. During 2024, fees paid to USI Consulting Group for administrative and recordkeeping services amounted to \$221,182 and are included in administrative expenses in the accompanying statement of changes in net assets available for benefits.

Pivot CPAs, the Plan auditor, is considered a party-in-interest to the Plan. During 2024, fees paid to Pivot CPAs amounted to \$16,000 and are included in administrative expenses in the accompanying statement of changes in net assets available for benefits.

Included in the Plan assets are notes receivable from participants. At December 31, 2024 and 2023, notes receivable from participants amounted to \$1,103,491 and \$867,629, respectively. For the year ended December 31, 2024, interest income related to notes receivable from participants amounted to \$83,911. These transactions qualify as party-in-interest transactions permitted under provisions of ERISA.

**7. Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts.

**8. Tax Status:**

The Plan operates under the USI Consulting Group Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan (the “USI Prototype Plan”). The IRS issued a determination letter dated June 30, 2020 stating that the form of the USI Prototype Plan was in accordance with Section 401 of the IRC for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Management has evaluated the Plan’s tax positions and concluded that as of December 31, 2024, the Plan had taken no uncertain tax positions that require recognition of a liability (or asset) in the financial statements. With few exceptions, the Plan is no longer subject to income tax examination by the U.S. federal, state or local tax authorities for tax years before 2021.

**10. Non-Exempt Transactions:**

The Company determined that during the 2023 Plan year it failed to remit certain employee deferrals to the Plan. The failed remittances were \$4,502 including lost earnings and were corrected during 2024. Late or delinquent deferrals constitute prohibited transactions as defined by ERISA and are included in the accompanying Schedule H, Line 4a – Schedule of Delinquent Participant Contributions.

**11. Subsequent Events:**

Effective January 1, 2025, the Company transferred sponsorship of the Plan to its parent company, Cadre Holdings, Inc., and changed the Plan name to Cadre Holdings, Inc. 401(k) Plan. There were no changes to the Plan provisions or coverage as a result of the name and sponsor change.

Effective January 1, 2025, as a result of Company acquisitions, the benefit plans of Pajarito Scientific Corporation (“PSC”) and NucFil, LLC dba NFT (“NFT”) were merged into the Plan and their employees became eligible to participate in the Plan. Participants’ balances in the amount of \$9,762,827 from the PSC benefit plan and participants’ balances of \$8,299,120 from the NFT benefit plan were transferred into the Plan’s asset on January 2, 2025.

Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be filed, and has determined, except as disclosed above, that there were no material events requiring recognition or disclosure.
