Notes to Financial Statements

Note 1: Description of Plan

The following description of the Briggs & Stratton, LLC 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Briggs & Stratton, LLC and its subsidiaries (the "Company") under the provisions of Section 401(a) of the Internal Revenue Code ("IRC"), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 ("ERISA"), as amended.

The Plan is administered by the Briggs & Stratton, LLC Retirement and Savings Plan Committee, which is appointed by the Board of Directors of the Company. Fidelity Management Trust Company ("Fidelity") is the Plan Trustee and record keeper.

Eligibility

Substantially all domestic employees of the Company are eligible to participate in the Plan. Eligibility to participate in the Plan is subject to certain provisions based on covered groups. Employees become eligible to make contributions after they have completed 45 days of service following their date of hire.

The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation with a 1% increase annually on the first day of each succeeding Plan year to a maximum of 9%. Contributions are invested in a default investment fund until the participant makes an investment election.

Contributions

Participants may contribute a portion of their compensation, as defined in the Plan, subject to the limits established by the Internal Revenue Service ("IRS"). Participants may also contribute distributions from other qualified defined benefit or defined contribution plans ("rollovers").

Company matching contributions vary by covered group. All non-bargaining participants receive 100% of the first 2% of their contributions. Additionally, participants receive 50% of contributions above 2% up to 6% of pay (not to exceed 4% of annual eligible compensation). All bargaining participants receive 100% of the first 3% of contributions. Additionally, bargaining participants receive 50% of contributions above 3% up to 5% of pay (not to exceed 4% of annual eligible compensation). All participants are eligible to receive a Company matching true-up contribution. The Company matching true-up contribution is funded annually subsequent to the Plan year end. The Company's matching contribution was \$7,358,907 during 2024.

Note 1: Description of Plan (Continued)

Contributions (Continued)

The Company also makes a non-elective contribution if a participant were an employee of the Company at any time during the Plan year. Company non-elective contributions vary by covered group. All non-bargaining participants receive a non-elective contribution of 3% of annual eligible compensation. All bargaining participants receive a non-elective contribution based upon the participant's age and years of service. The Company's non-elective contribution was \$6,660,437 during 2024.

Investment Options

Contributions are allocated among the available investment options as directed by each participant. By designating these investment alternatives for participants, allowing frequent fund transfers, and providing the necessary fund information to participants, it is intended that the Plan be treated as an ERISA 404(c) Participant-Directed Account Arrangement.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's matching contribution, (b) the Company's non-elective contribution and (c) Plan earnings (losses), which includes a charge for administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

All participant, Company matching, and Company non-elective contributions, plus actual earnings (losses) thereon, vest immediately.

Payment of Benefits

Upon death, disability, retirement or termination of service, a participant may generally elect to receive either a lump-sum distribution, installments over a period of years, or defer the distribution to a later date. In certain circumstances, participants may qualify to receive a hardship distribution. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Administrative Expenses

The majority of administrative expenses of the Plan are paid by the Plan. Participant accounts are charged a flat fee quarterly and additional fees for notes receivable and certain distributions. Certain expenses are occasionally paid by the Company, which are excluded from these financial statements.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Notes Receivable from Participants

At the discretion of the Plan Administrator, participants may borrow from their accounts a minimum of \$1,000 and a maximum of \$15,000 of their account balance, not to exceed 50% of their vested balance. The participant may only have one note outstanding at any one time. The notes are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator, which are commensurate with prevailing market rates. The Plan Administrator determines the term of participant notes made for the purpose of acquiring a primary residence, which may be up to 20 years and a maximum of \$50,000. The term of other participant notes is five years or less. Principal and interest are paid through monthly payroll deductions. Interest rates on the notes range from 4.25% to 9.50%, depending on when the note was issued.

SECURE 2.0 Act of 2022

The SECURE Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the plan. Plan management will determine the optional provision to elect in the future.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Fair Value Measurements

GAAP has established a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions. The asset's or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make note repayments and the Plan Administrator deems the participant to be in default, the participant note balance is reduced and the benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The following is a description of the valuation methodologies used for investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Brokerage accounts: Accounts primarily consist of cash, common stocks, inverse ETFs and Bitcoin (digital assets) that are valued on the basis of readily determinable market prices.

Mutual funds: Valued at the daily closing price as reported by the mutual fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Notes to Financial Statements

Note 3: Fair Value Measurements (Continued)

Common commingled trust ("CCT"): The fair value of CCT represents the NAV of the fund shares. NAV is based on the value of underlying assets owned by the funds minus liabilities, and then divided by the number of shares outstanding as determined by the Trustee. The net asset value per share of the CCT is not publicly quoted and the values are not dependent on the input of significant judgment or assumptions by management. The primary investment objectives are to provide preservation of principal, maintain a stable interest rate, and provide daily liquidity at contract value for participant withdrawals and transfers. Under the trust agreement, the Plan must give the Trustee 24 months' notice of intent to redeem all or a portion of its participation in the trust. After 24 months' notice is given, units may be redeemed at any time upon 10 business days' notice at the lesser of market value or the contract value of the redeemed units.

The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value.

Note 4: Tax Status

The Plan has received a favorable determination letter from the IRS, asking for determination that the Plan is designed in accordance with the applicable requirements of the IRC. The Plan has been amended since applying for a favorable determination letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 5: Party-In-Interest Transactions

The Plan invests in several mutual funds managed by affiliates of Fidelity. Transactions related to these mutual funds and notes receivable from participants are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under ERISA regulations.

Note 6: Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and disclosure under ERISA.
