## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Governance

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Alto 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined contribution plan established January 1, 2022 covering the employees of Alto Experience, Inc. and its affiliated employers, Alto Operations Texas LLC, Alto Operations Florida LLC, Alto Operations California LLC, and Alto Operations Virginia LLC (a controlled group, referred to herein as “the Company”) who have six months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

**ELIGIBILITY**

Employees of the Company are eligible to participate in the Plan on the first day of the month coinciding with or next following the completion of eligibility requirements. Eligibility provisions apply to participant and Company contributions. Nonresident aliens and union member employees are excluded from Plan eligibility.

**CONTRIBUTIONS**

Deferrals are limited to 70% of pretax or after tax (Roth) annual compensation as defined by the Plan with a limit as defined by ERISA. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe harbor matching contributions to eligible participants equal to 100% of elective deferrals that do not exceed 4% of the compensation. For the year ended December 31, 2024, the Company made safe harbor matching contributions totaling \$162,610. The Company may also make a discretionary non-elective contribution, as defined by the Plan agreement. During the year ended December 31, 2024, no discretionary non-elective contributions were made.

**PARTICIPANT ACCOUNTS**

Each participant’s account is credited with the participant’s contributions and the Company’s safe harbor matching contributions, as well as allocations of the Company’s discretionary non-elective contributions. Allocations of Plan earnings and administrative expenses are based on participant account balances as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participant loans are not allowed in the Plan.

**VESTING**

Participants are immediately vested in their contributions and the Company’s safe harbor matching contributions plus actual earnings thereon. Vesting in the Company’s discretionary non-elective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

**NOTE 1 – DESCRIPTION OF PLAN – CONTINUED**

**VESTING – CONTINUED**

Participants become 100% vested upon death, disability, or retirement.

**PAYMENT OF BENEFITS**

On termination of service due to death, disability, or retirement, and other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or installments. Hardship distributions are permitted for employees and fully vested Company contributions, plus actual earnings thereon. In-service distributions are permitted from vested accounts based on certain Plan provisions. Participants can elect to receive their distributions either in cash or as a direct rollover to another tax-qualified plan.

**FORFEITURES**

Any portion of the balance in a participant's account that is not vested will become a forfeiture upon the distribution of the entire vested account balance or upon the occurrence of a break in service, as defined by the Plan agreement. Forfeitures may be used to pay administrative fees or reduce discretionary employer contributions. There were no forfeited non-vested accounts at December 31, 2024 and 2023, respectively.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**USE OF ESTIMATES**

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**EXPENSES**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of the fair value of investments.

**SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lower priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	<p>Inputs to the valuation methodology include:</p> <ul style="list-style-type: none"> <li>• Quoted prices for similar assets or liabilities in active markets;</li> <li>• Quoted prices for identical or similar assets or liabilities in inactive markets;</li> <li>• Inputs other than quoted prices that are observable for the asset or liability;</li> <li>• Inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li> </ul> <p>If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. The funds held by the Plan are registered with the Securities and Exchange Commission (SEC) and are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Insurance company general account:*

The fair value of the fixed account option is reported to the Plan by Empower Trust Company and represents contributions made to the fund plus earnings, less participant withdrawals and administrative expenses.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by Empower Trust Company (Empower). Empower is the Custodian for the Plan and therefore, these transactions qualify as party-in-interest transactions. All such party-in-interest transactions are covered by an exemption from the “prohibited transactions” provisions of ERISA and the Internal Revenue Code (IRC).

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

**NOTE 7 – TAX STATUS**

The Plan has adopted a prototype non-standardized pre-approved profit-sharing plan with the IRC Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the form of the Plan is acceptable under Section 401 of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
