Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Brach Eichler, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan has implemented applicable provisions from the Setting Every Community Up for Retirement Enhancement ("SECURE") Act and the Coronavirus Aid, Relief, and Economic Security ("CARES") Act. On December 20, 2023, the IRS issued Notice 2024-02 (the "Notice"), under which the IRS extended the deadline to at least the end of 2026 (from 2025) for required and discretionary amendments related to legislation that was passed under the SECURE 2.0 Act and other related guidance. The Plan Sponsor intends to amend the Plan Document prior to the required deadline and in accordance with Internal Revenue Service ("IRS") guidance.

General

The Brach Eichler, LLC 401(k) Plan (the "Plan") was established on April 15, 2009. The Plan covers eligible employees of Brach Eichler, LLC (collectively, the "Company"). As of April 30, 2021, the Plan was amended and restated.

The Plan, which is a defined contribution plan under the Employee Retirement Income Security Act of 1974 ("ERISA"), is administered by the trustees appointed by the Board of Directors of the Company.

As of December 31, 2024, all investments of the Plan were and are held by Fidelity Management Trust Company (the "Trustee"). The Trustee holds the Plan's assets in a single trust and invests the assets among several investment options designated by the participant.

Participant Eligibility

All employees are eligible to participate immediately after meeting the age requirement of 21.

Contributions

The Plan permits participants to defer up to 100% of eligible compensation on a pre-tax basis or post-tax basis under Section 401(k) or Section 402A, respectively, of the Internal Revenue Code (the "Code"). Pre-tax and post-tax contributions were limited to a maximum of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively, or such other limit prescribed by Section 402 of the Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500 for each of the years ended December 31, 2024 and 2023. All contributions are made through payroll deductions and can be changed or stopped as of the beginning of each payroll period. Rollover contributions from other qualified plans or annuity contracts are permitted.

Matching Contributions

The Company may make discretionary matching contributions to the Plan in order to match all or a portion of a participant's elective deferrals. The formula, the amount of the contribution, and the frequency of the contribution, will be determined at the Company's discretion. Matching contributions may also be made with respect to any "catch-up contributions" made to the Plan.

Safe Harbor Contributions

In order to satisfy certain testing requirements, the Company may make a safe harbor profit sharing contribution to the Plan that is equal to at least 3% of the compensation of each eligible participant for the allocation period. The Company may use this contribution to offset the allocation of any non-safe harbor profit sharing contribution that would otherwise be allocated to a participant's account. For the Plan years ended December 31, 2024 and 2023, the Company's safe harbor contributions amounted to \$667,738 and \$596,864, respectively. As of December 31, 2024 and 2023, the Company's safe harbor contributions were still outstanding and are booked as a receivable on the statement of net assets available for benefits.

1. DESCRIPTION OF PLAN (CONTINUED)

Non-Safe Harbor Contributions

The Company may make a discretionary non-safe harbor contribution equal to a uniform percentage or dollar amount. Each year, the Company will determine the formula for the non-safe harbor contribution. For the Plan years ended December 31, 2024 and 2023, the Company's profit sharing contribution amounted to \$927,161 and \$884,456, respectively. As of December 31, 2024 and 2023, the Company's profit-sharing contributions of \$919,661 and \$884,456, respectively, were outstanding and are recorded as receivables on the statements of net assets available for benefits.

Vesting

Participants are 100% vested in the value of their cumulative contributions, safe harbor, and the discretionary non-safe harbor contribution and earnings thereon. Vesting in the value of the Company matching contributions and earnings thereon is subject to years of service with 100% vesting at 6 years of service. If a participant terminates his or her employment with the Company, the non-vested portion of company matching contributions is forfeited. Such forfeitures are used to reduce future Company contributions and plan expenses.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution (if any) and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. The expenses charged to the Plan may be charged pro-rata to each participant in relation to the size of each participant's account balance or may be charged equally to each participant.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or elect partial payments in amounts that you request from time to time. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$1,073 and \$1,052, respectively. These accounts will be used to reduce future employer contributions and plan expenses. Employer contributions allocated to participants during 2024 and 2023 were not reduced by funds from the forfeited non-vested accounts.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting - GAAP

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with generally accepted accounting principles.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires Plan administrators to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received for an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Investments Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation included the Plan gains and losses on investments bought and sold as well as those held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan Document. Certain administrative expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

3. FAIR VALUE MEASUREMENTS

In accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC), Fair Value Measurements and Disclosures, fair value is defined as a market-based measurement, not an entity-specific measurement. The objective of a fair value measurement is to estimate the price at which an orderly transaction to sell the asset or to transfer the liability would take place between market participants at the measurement date under current market conditions (that is, an exit price at the measurement date from the perspective of a market participant that holds the asset or owes the liability). A fair value measurement assumes that the transaction to sell the asset or transfer the liability either occurs in the principal market (or in its absence, the most advantageous market) for the asset or liability.

The Fair Value Measurements Topic of the FASB ASC establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The measurement of fair value focuses on the price that would be received to sell the asset or paid to transfer the liability regardless of whether an observable liquid market price existed (an exit price). An exit price valuation will include margins for risk even if they are not observable. As the Plan is released from risk, the margins for risk will also be released through net realized capital gains (losses) in net income. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Observable market based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement. Level 3 assets and liabilities measured at fair value are based on one or more of three valuation techniques:

- Market Approach - Prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities;
- Cost Approach - Amount that would be required to replace the service capacity of an asset (i.e. current replacement cost);
- Income Approach - Techniques that convert future amounts to a single present amount based on current market expectations about those future amounts (including present value techniques, option-pricing models, and lattice models).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. For some assets and liabilities, observable market transactions or market information may be available. For other assets and liabilities, observable market transactions and market information might not be available. When a price for an identical asset or liability is not observable, a reporting entity measures fair value using another valuation technique that maximizes the use of relevant observable inputs and minimizes the use of unobservable inputs. Because fair value is a market-based measurement, it is measured using the assumptions that market participants would use when pricing the asset or liability, including assumptions about risk. As a result, a reporting entity's intention to hold an asset or settle or otherwise fulfill a liability is not relevant when measuring fair value.

The following is a description of the techniques and inputs used for each major class of assets measured at fair value:

Mutual Funds: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded and are classified within Level 1 of the valuation hierarchy.

Money Market Funds: Valued based on the funds' reported closing net asset value ("NAV") as of the last business day of the plan year. The money market funds held by the Plan are considered to be actively traded and are classified within Level 1 of the valuation hierarchy.

Self-Directed Brokerage Accounts: Accounts primarily consist of mutual funds and common stocks that are valued based on the closing price reported on the active market where the individual securities are traded and are classified within Level 1 of the valuation hierarchy.

Common Collective Fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective fund, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INCOME TAX STATUS

The Plan has received an IRS opinion letter dated June 30, 2020, stating that the Plan, in form, is acceptable under the applicable requirements of the Internal Revenue Code (the "Code"). The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and therefore believe that the Plan is qualified and the related trust is tax-exempt.

4. INCOME TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. PARTY-IN-INTEREST TRANSACTION

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. From time to time, certain Plan investments are managed by Fidelity, the trustee of the Plan, and therefore these transactions qualify as party-in-interest transactions. No such investments were held as of December 31, 2024. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions. Total fees and commissions paid by the Plan for the investment management and plan administration services amounted to \$14,930 for the year ended December 31, 2024.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. The Plan has not considered Company contributions to the Plan or benefits accrued or paid by the Plan for participants as party-in-interest transactions.

6. RISK AND UNCERTAINTIES

The assets of the Plan are primarily financial instruments which are monetary in nature. Accordingly, interest rates have a more significant impact on the Plan's performance than do the effects of general levels of inflation. Interest rates generally do not move in the same direction or with the same magnitude as prices of goods and services as measured by the consumer price index. Investments are subject to risk conditions of the individual investment's objectives, stock market performance, interest rates, economic conditions and world affairs. Due to the level of risk associated with the Plan's investments, it is reasonably possible that changes in the values of the Plan's investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

The Plan is subject to risks associated with unforeseen or catastrophic events, including terrorist attacks, natural disasters, geopolitical events, and the emergence of a pandemic, such as COVID-19, or other public health emergencies, which could create economic, financial, and business disruptions across economies and financial markets. The extent of the impact of such events on the Plan and financial results, will depend on the future developments, including the duration and nature of event, and the related impact on consumer confidence and spending, all of which are highly uncertain.

7. INFORMATION CERTIFIED BY TRUSTEE

The December 31, 2024 and 2024 statements of net assets available for benefits, the investment activities included on the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Fidelity Management Trust Company (the trustee of the Plan) in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments, and cash as of December 31, 2024 and 2023, and the net appreciation in the fair value of investments, interest and dividends for the year ended December 31, 2024.

8. PLAN TERMINATION

The Company intends to continue the Plan indefinitely; however, it may discontinue its contributions and terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all participants have a non-forfeitable right to the entire value of their accounts.

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
