To the Plan participants

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TSG Cennox, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

1. DESCRIPTION OF PLAN

The following description of the TSG Cennox, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of Plan provisions.

General

The Plan was established effective January 1, 1999, as a defined-contribution plan covering all employees of TSG Cennox, LLS (the Company), with the exception of non-resident aliens and union employees. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan is administered by the trustees. The trustees contracted with an independent third-party administrator to perform recordkeeping responsibilities. Empower Annuity Insurance Company of America (EAICA) serves as custodian of the group annuity contract and Empower Trust Company, LLC (Empower) serves as the custodian of the mutual funds and the common collective trust (CCT) funds held by the Plan.

Eligibility

An employee is eligible to participate in the Plan upon completion of 12 months of service and attainment of 21 years of age. Enrollment of eligible participants occurs on the first day of each quarter following the date the participant completes the eligibility requirements.

Contributions

Participants may contribute up to 100% of their annual compensation as pretax contributions, Roth 401(k) contributions, or a combination thereof, not to exceed the limitation set forth in Section 402(g) of the Internal Revenue Code (IRC). Participants may make catch-up contributions during any calendar year ending on or after the participant's 50th birthday. Participants may also make rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe harbor matching contributions equal to 100% of salary deferrals up to the first 3% of compensation and 50% of deferrals between 3% and 5% of compensation. The Company may also elect to make discretionary nonelective contributions for participants employed by the Company on the last day of the Plan year. Discretionary nonelective contributions, which are computed annually, are allocated to each participant's account based on the ratio of a participant's compensation to all participants' compensation. The Plan also provides that the Company may make a discretionary matching contribution, determined each year, of a percentage of an employee's eligible compensation that is contributed to the Plan as deferral contributions. There were no discretionary nonelective or discretionary matching contributions made during 2024. The Company contributions are invested directly in the various investment options, as directed by the participant.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings or losses. Earnings and losses are allocated by fund

based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. Upon the occurrence of a distribution event, the benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

Vesting

Participants are immediately vested in their elective contributions, and Company safe-harbor matching contributions, plus or minus any earnings or losses on such contributions. A participant becomes 100% vested in all Company contributions upon death, disability or attaining normal retirement age, as defined by the Plan document. For all other purposes, vesting in the Company's discretionary matching contributions and discretionary nonelective contributions made on the participant's behalf is based on the following schedule:

Participants are credited with a year of service based on the elapsed time method, as defined by the Plan document.

Notes Receivable from Participants

Participants may borrow from their fund accounts any amount greater than \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance incurred by the participant during the 12-month period ending on the day before the loan is made, or 50% of the participant's vested account balance. Loan repayments are calculated on a fully amortized basis. Loans are collateralized by the vested balance in the participants' accounts and bear interest at the prime rate, as stated in the Wall Street Journal, plus 1.00%. The loans are general purpose loans with terms from twelve to sixty months.

Payment of Benefits

In the case of a participant's retirement, death, permanent disability or termination of employment, the participant or his or her designated beneficiary may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, unless a participant is required to receive lifetime required minimum distributions (RMDs), in which case participants may elect to receive the RMDs in installments. Distributions are subject to the applicable provisions of the Plan agreement.

Participants may elect to receive a distribution of their vested account balance as a lump-sum distribution upon attainment of 59½ years of age.

Prior to age 59½, hardship withdrawals are permitted from all participant's accounts, with the exception of Company discretionary nonelective or matching contributions.

A mandatory distribution is required if the account balance is less than \$1,000 or subject to automatic rollover if less than or equal to \$5,000.

Forfeitures

All Company contributions credited to a participant's account, but not vested, are forfeited by the participant upon distribution of the fully vested value of his or her account. Forfeitures are used to pay Plan expenses, and thereafter, to reduce future Company contributions. No forfeitures were used during the year ended December 31, 2024. The balance in the forfeiture account as of December 31, 2024 and 2023, was \$32,319 and \$31,292, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, with the exception of the fully benefit-responsive group annuity contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements and Note 5 for discussion of contract value measurements.

Net appreciation in fair value of investments includes realized gains and losses on investments sold during the year as well as unrealized appreciation (depreciation) of investments held at the end of the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain

investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Benefit Payments

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are expensed when they are incurred. Investment related expenses are included in net appreciation in fair value of investments. The Plan entered into a revenue sharing agreement with EAICA. Under the terms of the revenue sharing agreement, EAICA will fund and allocate to a plan expense account revenue credit calculated based upon the agreement terms. The plan expense account is utilized to pay certain Plan expenses.

Subsequent Events

In 2025, management elected to change trustee and recordkeeper from Empower to John Jancock Retirement. The assets will transfer on December 1, 2025.

Management has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued and has determined that there are no additional subsequent events that require disclosure under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 855, *Subsequent Events*.

3. FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements and Disclosures* (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Common collective trust (CCT) funds: These funds are valued at the net asset value (NAV) of the units of the CCT fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments or trading restrictions for the funds.

Pooled separate accounts: The unregistered pooled separate accounts are divided into investments called sub-accounts. Each sub-account invests in shares of an underlying mutual fund. Sub-account values are measured in terms of accumulation units. The accumulation units of a sub-account are assigned a unit value on a daily basis. Each sub-account is valued based on the net asset value per share of the underlying fund held in the sub-account.

The methodologies described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INFORMATION CERTIFIED BY THE CUSTODIANS

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower and EAIC, the Plan's custodians.

5. GROUP ANNUITY CONTRACT

The Plan maintains traditional fully-benefit responsive guaranteed investment contracts with EAICA. EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contracts issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The interest crediting rate is based on the underlying assets of the portion of the Great-West general account that is used to determine the accounts crediting rate compared to the minimum interest crediting rate and prevailing market conditions. The crediting interest rate is reset at least annually. The crediting interest rate earned by the contract for 2024 and 2023, was 3.00%.

The contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value, as reported to the Plan by EAICA, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its

financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. The guarantees are based on the insurance company's ability to meet its financial obligations from the assets of the insurance company.

In certain circumstances, the amount withdrawn from the fixed accounts would be payable at fair value rather than at contract value. These circumstances include termination of the Plan, a material adverse change to the provisions of the Plan, or if the Plan withdraws from the Fixed Account in order to change to a different investment provider. The circumstances described that could result in a payment of benefits at fair value rather than contract value are not probable of occurring in the foreseeable future.

6. TAX STATUS

The Plan adopted a non-standardized preapproved profit-sharing plan with CODA sponsored by CCH Incorporated DBA ftwilliam.com. The prototype plan has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, the accompanying financial statements do not include a provision for income taxes.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balances.

8. PARTY-IN-INTEREST TRANSACTIONS

The Plan holds units of a fixed account and a pooled separate account managed by EAICA, a custodian; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Additionally, for the year ended December 31, 2024, the Plan paid administrative and recordkeeping fees of to the Plan's recordkeeper and third-party administrator. Investment advisory fees were paid out of the plan expense account held by EAICA.
