Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Choice Logistics, Inc. 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Choice Logistics, Inc. 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the information in the aforementioned financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Choice Logistics, Inc. 401(k) Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note 1 - Description of the Plan

The following description of the Choice Logistics, Inc. (Employer/Plan Sponsor) 401(k) Savings Plan ("Plan") provides only general information. A more complete description of the Plan's provisions is included in the plan document (Note 5).

a) General

The Plan is a defined contribution plan covering substantially all employees who have attained age 21 and completed two months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Sponsor oversees management and governance of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

b) Contributions

The Plan provides for both pre-tax (traditional) and post-tax (Roth) employee deferral contributions. Participants may contribute up to 100% of their annual compensation (as defined), which is subject to certain statutory limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions received from other qualified plans and certain IRA's (rollover contributions). Participants direct the investment of their contributions (including Employer matching contributions) into investment options offered by the Plan, which currently includes various mutual funds and insurance investment contracts.

Employees are automatically enrolled into the Plan for a contribution based on 3% of eligible compensation; they may affirmatively elect to contribute a different amount (or elect not to contribute). For continuing employees, this automatic withholding percentage will increase by 1% each succeeding year, although withholding of more than 6% requires an affirmative election. Contributions are automatically invested in a designated fund until changed by the participant. The Employer currently provides matching contributions, which is essentially 50% of the first 6% of base compensation that a participant contributes to the Plan.

Contributions are primarily funded each bi-weekly payroll period. Participants may change their investment direction at any time throughout the year.

c) Participant Accounts

Each participant's account is credited/charged with a) the participant's contribution, b) the Employer's matching contribution, c) Plan earnings (losses) and d) benefits/expenses paid by the Plan. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. A participant is entitled to the benefit available from his or her vested account value.

d) Vesting

Participants vest immediately in their contributions and the earnings thereon.

Vesting in Employer contributions and the earnings thereon is based on the following schedule:

e) Notes Receivable from Participants

Participants may borrow from their investment fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of the vested portion of their account balance. Notes are secured by the participant's account balance, bear interest at rates ranging from 4.25% to 9.5% and mature through 2029. The interest rate on notes is fixed at the prime rate plus 1% at loan inception and remains in effect over the loan term. Principal and interest are generally paid ratably through bi-weekly payroll deductions.

f) Payment of Benefits

Benefits may be paid upon termination of service, death, disability, attaining age 59 ½ or for serious financial hardship. A participant will receive his/her vested account value in a lump-sum.

Benefits from rollover contributions accounts may be withdrawn at any time.

Benefits are recognized when paid.

g) Forfeitures

Forfeitures of non-vested account balances may be applied to reduce Employer matching contributions and to pay plan expenses. Forfeitures approximating \$25,000 were used to reduce Employer matching contributions during 2024. Forfeited nonvested accounts approximated \$24,000 and \$25,000 as of December 31, 2024 and 2023, respectively.

Note 2 - Summary of Significant Accounting Policies

a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

b) Investment Valuation and Income Recognition

Investments held by a defined contribution plan are reported at fair value, except for fully benefit-responsive investment contracts, which are recorded at contract value (Notes 4 and 6). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4). The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the custodian.

Interest income is recorded on the accrual basis.

Net appreciation in the fair value of investments in mutual funds includes the Plan's net gains and losses on mutual funds bought and sold as well as held during the year.

c) Notes Receivable from Participants

Loans to participants are measured and reported at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded. Delinquent participant loans are recorded as benefits paid to participants based on the terms of the plan document.

d) Expenses

Certain operating expenses are paid by the Employer, and those expenses are excluded from these financial statements. The Employer reserves the right to charge such future expenses to the Plan. Investment related expenses are charged against the net appreciation in fair value of investments.

e) Plan Termination

Although it has not expressed the intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and, subject to the provisions of ERISA, terminate the Plan. In such an event, participants would become 100% vested in their employer contributions.

f) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

g) Date of Management's Review of Subsequent Events

Subsequent events were evaluated through October 8 2025, which is the date the financial statements were available to be issued.

Note 3 - Information Prepared and Certified by Principal Trust Company

The following information included in the accompanying financial statements (including the notes to the financial statements) and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the custodian, Principal Trust Company. The custodian holds the Plan's investments and executes transactions therein.

Note 4 - Fair Value Measurements

The Plan's investments, except for the fully benefit-responsive investment contracts (Notes 2(b) and 6), are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain investments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets that the Plan has the ability to access and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1) and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 1 inputs were available to the Plan and were used for all plan assets reported at fair value.

Level 1 Fair Value Measurements

Mutual funds: Mutual funds are valued based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments in mutual funds.

Note 5 - Income Tax Status

The Plan is based on a prototype plan document offered by an affiliate of the custodian, which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). While management did not elect to obtain an individual determination letter from IRS, it believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the financial statements.

The Plan has determined all benefits associated with positions taken for tax purposes would, more likely than not, be sustained upon review by the taxing authorities and therefore has not recognized a liability for unrecognized tax benefits. Tax returns (Form 5500) are filed in the U.S. federal jurisdiction. The Plan Sponsor believes the plan is no longer subject to tax examinations for years prior to 2022, and there are no examinations currently in progress.

Note 6 - Investment Contracts with Insurance Company

The Plan has entered into traditional fully benefit-responsive guaranteed investment contracts with the custodian through investment in the Principal Guaranteed Option and Principal Fixed Income Guaranteed Option (Notes 2(b) and 4). The custodian maintains the contributions in a general account and is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The custodian bears the risk that the return on the underlying investments will be sufficient to support the guaranteed rate during each guarantee period.

The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Note 6 - Investment Contract with Insurance Company (Continued)

Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals, and expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Given these provisions, the custodian and Employer consider these contracts to be fully benefit-responsive.

There are no reserves against contract value for credit risk of the custodian or otherwise. The minimum crediting interest rates are based on formulas agreed upon with the custodian, and as of December 31 was 2.55% (2024) and 1.90% (2023) for the Principal Guaranteed Option and 4.75% (2024) for the Principal Fixed Income Guaranteed Option. Such interest rates are reviewed approximately every six months for resetting. The Plan Sponsor is not aware, nor does it believe occurrence is probable, of any events that might limit the ability of the Plan to transact, or allow the custodian to terminate the contracts requiring the Plan to settle, at an amount other than contract value over time.

Note 7 - Related Party Transactions

The investments are managed by the custodian and therefore qualify as party-in-interest transactions under ERISA. All expenses were paid to the custodian. These transactions are exempt from the prohibited transaction rules of ERISA.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities which are exposed to risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that the value of investment securities will fluctuate in the near term and that such changes may materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
