INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Pioneer Products, Inc. 401(k) Profit Sharing Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Pioneer Products, Inc. 401(k) Profit Sharing Plan and Trust ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions, as further described in Note 1 to the financial statements, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits do not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

ERISA-Required Supplementary Information

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - The Pioneer Products, Inc. 401(k) Profit Sharing Plan and Trust ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024, through October 10, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Pioneer Products, Inc. is the plan sponsor, employer and the plan administrator. Prior to July 1, 2024 Reliance Trust Company ("Reliance") was the custodian of the plan's common/collective trusts and mutual fund investments. Effective July 1, 2024 Transamerica Trust Company ("Transamerica Trust") replaced Reliance as the custodian of the plan's common/collective trusts and mutual fund investments. Transamerica Life Insurance Company ("Transamerica Life") is the custodian of the plan's stable value core option investment. Reliance, Transamerica Trust and Transamerica Life are collectively referred to as the "custodians". Transamerica Retirement Solutions, LLC ("Transamerica Retirement") is the investment agent that maintains investment and participant records. PPG Retirement Plan Services Ltd. is the third-party administrator and performs various compliance tests as tax counsel. Two employees of the plan sponsor are the trustees.

Investments - The plan administrator determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Earnings on investments bought, sold and held during the years is reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

The following is a description of the valuation methodologies used for investments measured at fair value.

Interest-bearing cash - Value at cost plus accrued interest, which approximates fair value, and consists of cash deposits in an interest-bearing savings account at a Federal Deposit Insurance Corporation ("FDIC") insured bank at Transamerica Life. The FDIC provides limited insurance on cash deposits. As employee benefit plan accounts, the deposits are insured up to the FDIC limit for each participant account rather than the aggregate account balance. Certain participant accounts may exceed the FDIC limit; however, the plan does not expect to experience any losses on its cash deposits. The cash deposits may be withdrawn at any time without prior notice or penalty.

Common/collective trusts - Valued at the net asset value ("NAV") based on units of the common/collective trusts, which are all included within a combined direct filing entity. The NAV, as provided by Transamerica Trust/Reliance Trust, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the common/collective trusts less their liabilities. This practical expedient would not be used when it is determined to be probable that the common/collective trusts will sell the investment for an amount different than the reported NAV.

Mutual funds - Valued at the daily closing price as reported by the funds. Mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily NAV and are deemed to be actively traded.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

Transamerica Life pays interest and guarantees the plan's capital deposit regardless of the activity in the general account. The investment is not considered a Guaranteed Investment Contract or Common Collective Trust as there are no specific underlying securities and no stated minimum or maximum interest rate. The investment, as a deposit liability of Transamerica Life with no underlying assets, has no direct investments on behalf of the plan. The investment value is based on the general unallocated account of Transamerica Life and the risk of investment is based on Transamerica Life's insurance ratings. The effective annual interest rate is established every six months. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six month period. The average yield earned by the fund was 1.58% and 1.18% in 2024 and 2023.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Transamerica Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. Although plan participants may direct withdrawals at any time without restrictions, a hold can apply in the event the plan sponsor requests a full distribution from the investment. As of the date these financial statements were available to be issued, the plan has no intention to request a full distribution.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date these financial statements are available to be issued, the plan administrator is not aware of any events that might limit the ability of the plan to transact at contract value with the contract issuer or that would limit the ability of the plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General - The plan was established as a defined contribution plan with a 401(k) salary deferral arrangement on September 1, 1993. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - An employee is allowed to join the plan upon attainment of age 18 and completion of 2 months of service. Upon obtaining eligibility, employees may enter the plan on the first day of the following month.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid and can be made as follows:

- a. Participants may contribute up to 100% of their annual wages subject to certain limitations (elective deferral contributions). Newly eligible employees hired after July 31, 2022 are automatically enrolled in the plan and have 6% of their compensation withheld as elective deferral contributions (auto-enroll). Employees that are auto-enrolled have the option to increase, decrease or stop the elective deferral contribution at any time. The plan also permits Roth elective deferral contributions.
- b. Employee rollover contributions are accepted by the plan from other qualified plans.
- c. A discretionary employer matching contribution may be made. Through June 30, 2023, the discretionary matching contribution was 25% of the first 3% of employee compensation contributed as elective deferral contributions. Effective July 1, 2023, the discretionary matching contribution was 50% of the first 4% of employee compensation contributed as elective deferral contributions. Matching contributions are funded weekly, coinciding with the employer's payroll.
- d. A non-elective contribution may be made at the employer's discretion. There were no such contributions in 2024 or 2023.

Participant accounts - Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions, rollover contributions and an allocation of the employer contributions. Participants are allowed to transfer funds between the various investment options on a daily basis and change their deferral percentage each pay period.

Vesting - Participants are always 100% vested in their account balances.

Payment of benefits - Benefits are recorded when paid. Payments may commence upon termination of employment, death, disability or attainment of normal retirement age (defined as age 62). Participants may receive their distribution in the form of a single lump sum or installment payments. In-service withdrawals can commence upon attaining the age of 62. Hardship withdrawals are permitted under certain circumstances.

Administrative fees - Certain administrative fees of the plan are paid by the employer. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for loan and distribution fees and nonparticipant directed charges for services and administrative and advisory fees. The nonparticipant directed charges are allocated to participants on an account value basis.

Notes receivable from participants - Participants can take out loans against their accounts with the approval of the plan administrator. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance, or \$50,000. Participants may only have one loan outstanding at any given time. The repayment term generally cannot exceed 5 years except when the loan is for the purchase of a principal residence. As of December 31, 2024, the notes receivable from participants had various repayment schedules through July 2029, with interest from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximate fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by the custodians. The custodians also provide certain administrative services to the plan pursuant to service agreements between the plan sponsor and the custodians and therefore, these qualify as party-in-interest transactions. Direct fees paid by the plan to the custodians, recorded as administrative expenses, were \$46,000 in 2024 and \$43,000 in 2023. In addition, the custodians receive indirect compensation from mutual fund providers for services provided to the funds. This indirect compensation is used to offset certain amounts that would be otherwise owed to the custodians for administrative services to the plan.

Activity related to notes receivable from participants also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan at any time subject to the provisions of ERISA.

5. INCOME TAX STATUS

The plan is operating under a PPG Retirement Plan Service Ltd. pre-approved profit-sharing plan that received a favorable opinion letter on June 30, 2022, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) if the plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for uncertain tax positions taken and determined that the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY THE CUSTODIANS

Management has obtained certifications from the plan's custodians (as defined in note 1), qualified institutions under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate:

- a. Investments held by the plan and the fair values and contract values of such, and notes receivable from participants as of December 31, 2024 and 2023;
- b. Dividends from investments, the net appreciation (depreciation) in fair values of investments, and interest income on notes receivable from participants during 2024 and 2023; and
- c. Contributions to, investment income (loss) credited to, benefits paid from, and transfers between investment accounts for the years ended December 31, 2024 and 2023.
