INDEPENDENT AUDITOR'S REPORT

To the Trustees of the
Beau Townsend Ford, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Beau Townsend Ford, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Beau Townsend Ford, Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedules Required by ERISA

The supplemental schedule of Assets Held for Investment Purposes as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Beau Townsend Ford, Inc. 401(k) Plan were prepared in conformity with accounting principles generally accepted in the United States of America as applied to defined contribution plans and in accordance with the terms of the Trust Agreement. A summary of the Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

Plan Description

The Beau Townsend Ford, Inc. 401(k) Plan was established January 1, 1991.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). It was established for the purpose of providing retirement benefits to all eligible employees of Beau Townsend Ford, Inc.(the "Company").

Contributions

All employees became eligible upon attaining age 21 (amended to 18 during 2022) and reaching six (amended to three months during 2022) months of service. A participant may make contributions by entering into a salary reduction agreement with the Company whereby they authorize the Company to reduce their earnings by such percent or dollar amount, as they shall specify, subject to the Plan specified limits. Participants who have obtained the age of 50 before the end of the Plan year are eligible to make additional catch up contributions. Participants may also contribute after-tax Roth elective contributions. The Company may pay the expenses of administering the Plan. Any expenses not paid by the Company shall be paid from Plan assets. The Company may also make discretionary matching and profit sharing contributions to the Plan. For the 2024 and 2023 Plan years, the Company made discretionary matching contributions of \$-0- and \$50,000, respectively

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's elective deferrals, rollover contributions, and allocation of Plan earnings.

Vesting

Participants are 100% vested in their voluntary accounts immediately. Vesting in the remainder of their account is based on years of continuous service. A participant becomes 100% vested after six years of credited service.

Payment of Benefits

On termination of services or retirement, a participant will receive benefits in the form of a lump-sum amount to the value of the participant's vested account balance or periodic payments not exceeding the participant's life expectancy. In-service hardship withdrawals are also allowed as defined in the Plan agreement. Benefits are recorded when paid.

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with the accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts and disclosures of net assets available for benefits as of the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value based on quoted market prices, which represent the net asset value of shares held by the Plan. Unrealized gains or losses are allocated to participant's accounts. Security transactions are recorded on trade dates; the specific identification method is used in computing gains or losses. Loans to participants are valued at cost, which approximates fair value.

Fidelity Bond

The Plan is insured by a fidelity bond totaling \$500,000.

Excess Contributions

Contributions made by certain active participants during a plan year are returned to them in order to satisfy the relevant nondiscrimination provisions of the Plan. Excess deferral contributions of \$103,772 and \$29,608 were payable as of December 31, 2024 and 2023, respectively.

Income Taxes

The Plan is a qualified plan under Section 401 of the Internal Revenue Code. The Plan has received a favorable letter of determination from the Internal Revenue Service for the Plan. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Companies' management believe the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Administrative Expenses

The Plan sponsor absorbs significant costs of the Plan Administration.

Participant Loans

Participants may borrow from their account a minimum of \$1,000 up to a maximum of 50% of their vested account balance, not to exceed \$50,000, reduced by their highest outstanding loan balance during the preceding twelve months. Participants are limited to one outstanding loan at a time. Loan transactions are treated as transfers between an investment fund and the loan fund. Loans must be repaid within five years unless the purpose is to acquire, construct or reconstruct a principal residence. Each loan is secured by the balance in the participant's account and bears a rate of interest commensurate with local prevailing rates. Payments must be made at least quarterly by payroll deduction. For loans outstanding at December 31, 2024, the interest rates were 4.25% - 9.50%.

Fair Value Measurements

The Fair Value Measurements and Disclosures Topic of the Financial Accounting Standards Board Accounting Standards Codification, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB Accounting Standards Codification are described below:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

Unallocated insurance contract: Values at fair value by discounting the related cash flows based on current yields of similar investments with comparable durations considering the credit-worthiness of the issuer.

Money market and mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the plan are deemed to be actively traded. Value of interests in registered investment companies (mutual funds) are valued at the net asset value (NAV) of shares held by the plan at year end (Level 1).

Common collective trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by Empower Trust Company, LLC, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Forfeited Accounts

The non-vested portion of former participant’s accounts may be used to pay administrative expenses of the Plan or to reduce the future amount of employer contributions.

Subsequent Events

Subsequent events were evaluated by management through October 13, 2025, which is the date the financial statements were available to be issued.

All common collective trusts held by the Plan are direct filing entities (DFE). The Plan is not required to disclose the investment strategies of DFEs that file a Form 5500 annual report directly with the Department of Labor.

NOTE 3 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a non-benefit responsive investment contract with Nationwide Life. Nationwide Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at fair value, as reported to the Plan by Nationwide Life. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. However, participant directed exchanges are restricted; therefore, the investment contract is not considered benefit responsive and is presented at fair value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The net rate, crediting rate and average yield earned by the Fund for the years ended December 31, 2024 was 2.7%.

NOTE 4 – RELATED PARTY TRANSACTIONS

Certain administrative services are provided by the Company at no cost to the Plan and certain administrative costs incurred by the Plan are paid by the Company.

Certain Plan investments are shares of mutual funds and an unallocated insurance contract managed by Nationwide and Nationwide Life and Empower Annuity Insurance Company. Nationwide Life was the custodian of the Plan and, therefore, these transactions qualify as party-in-interest. The Plan moved to Empower Trust Company, LLC during the year ended December 31, 2024, therefore, unallocated insurance contracts with Empower Annuity Insurance company transactions qualify as party-in-interest as well. The Plan paid fees totaling \$40,823 and \$71,971 during the Plan years ended December 31, 2024 and 2023, respectively
