### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of Lochmandy Motor Sales, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Lochmandy Motor Sales, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Lochmandy Motor Sales, Inc. and Lochmandy Savings Place (collective "the Company") who are age twenty and one-half or older and have completed 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2020, the Plan was amended and restated to reflect the inclusion of a new participating employer, Lochmandy Lowery Dealer Development, LLC. Upon the amendment/restatement, the Plan is maintained as a multiple-employer plan.

**Contributions**

Participants may make pre-tax contributions up to 100% of their eligible compensation, as defined by the Plan, limited to the federal statutory limit. The Plan allows participants who have attained age 50 by the close of the Plan year to make additional "catch-up" elective deferral contributions of \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified plans. The Company may make a discretionary matching contribution. The Company may also make a discretionary profit-sharing contribution. Employees must complete at least 1,000 hours of service and be actively employed on the last day of the Plan year to be eligible to receive an employer contribution. For the year ended December 31, 2024, the Company made no discretionary profit-sharing contributions. Contributions are subject to certain limitations.

**Participant Accounts**

Individual accounts are maintained for each participant. Each participant account is credited with the participant contribution, the Company discretionary contribution (if any), the Company matching contribution (if eligible) and the applicable earnings or losses for the investments selected by the participant. Each account is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of credited service. Participants are fully vested after six years of credited service. A participant is fully vested upon death, disability, and reaching normal retirement age of 60 as defined in the Plan. The non-vested balance is forfeited upon termination of service.

**Participant Notes Receivable**

The Plan agreement includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant that is deemed creditworthy. The maximum loan amount is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. The loans are secured by the participant's account balance and bear interest at a rate commensurate with prevailing rates. The loans are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

**Investment Options**

Participants may direct contributions into a variety of selected investment options offered by the Plan. Participants may change their investment options at any time.

**Earnings**

Earnings include net asset appreciation, dividends and interest earned during the year, net of investment expenses.

**Payment of Benefits**

Upon retirement, death, disability, or termination of service, a participant (or participant's beneficiary) may elect to receive a single lump sum or periodic payments equal to the value of the participant's vested account. Hardship withdrawals are also permitted by the Plan if certain criteria are met.

**Forfeitures**

Forfeitures represent the non-vested portion of a participant's account plus earnings thereon that are not fully distributable to participants who terminate employment before they are 100% vested. Forfeitures may be used to reduce future employer matching contributions to the Plan or to pay administrative expenses of the Plan. For the year ended December 31, 2024, \$3,955 of forfeitures were used to reduce employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts total \$0 and \$1, respectively.

**Administrative Expenses**

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4, *Fair Value Measurements*, for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest.

**Contributions**

Contributions from Plan participants and the matching contributions from the Employer match are recorded in the year in which the employee contributions are withheld from compensation. Additional discretionary employer matching contributions are recognized when declared by the Company.

**Benefits Paid to Participants**

Benefit payments to participants are recorded upon distribution.

**Management Evaluation of Subsequent Events**

Plan management has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.

**NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, 1st Source Bank, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) 820, Fair Value Measurements, establishes a framework for measuring fair value and expands disclosures about fair value investments. ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis and recognized in the accompanying Statements of Net Assets Available for Benefits. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end.

*Common collective trust fund:* The investments include a stable value fund. The fair values of participation units held in the stable value fund are based on NAV after adjustments to reflect all fund investments at fair value, including direct and indirect interests in fully benefit-responsive contracts. The stable value fund generally permits redemptions daily. If the fund experiences periods of insufficient liquidity, then the stable value fund may defer honoring any payment request until liquidity is sufficient. The fair values of the Plan's interest in the stable value fund are based on quoted market prices in active markets and securities and contracts are valued using observable inputs. The Plan is permitted to redeem investment units at NAV on the measurement date.

The objective of the Morley Stable Value Fund, the primary common collective trust fund in the Plan, is to provide a low-risk, moderate-yield investment. Withdrawals for benefit payments and participant directed transfers to noncompeting options are made to plan participants promptly, to the extent possible, but within 30 days after notification has been received. The Morley Stable Value Fund reserves the right to delay plan sponsor-initiated redemptions for up to 365 days, subject to certain conditions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 6 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain employees of the Company provide administrative services for the Plan and are not reimbursed for their services from the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan.

**NOTE 7 - RISKS, UNCERTAINTIES, AND CONCENTRATIONS**

The Plan invests in various investment securities. Investment securities in general are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. The financial statements have been prepared using values and information currently available to the Plan.

The Plan holds certain investments that each represent 15 percent or more of the total investments held by the Plan. As of December 31, 2024 and 2023, approximately 27% and 30% of the Plan's total investments is held in one investment, respectively.

**NOTE 8 - INCOME TAX STATUS**

The Plan is a prototype non-standardized profit-sharing plan that is covered under an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Authoritative accounting standards require the Plan to examine its tax positions for uncertain positions. Management is not aware of any tax positions that are more likely than not to change in the next 12 months or that would not sustain an examination by applicable taxing authorities.

The Plan's policy is to recognize penalties and interest as incurred in its statement of changes in assets available for benefits.
