Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of TUV Rheinland 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 - Description of Plan

The following description of the TUV Rheinland 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of TUV Rheinland of North America, Inc. (the "Company") and participation in the Plan can commence immediately. Participants must complete one year of service (with a minimum of 1,000 hours) to be eligible for discretionary nonelective contributions. Collective bargaining, nonresident aliens and residents of Puerto Rico are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan administrator is responsible for the oversight of the Plan. The Plan administrator, along with the custodians and independent advisory firm, determine the appropriateness of the Plan's investment offerings, monitor investment performance and report to the Board of Directors.

Contributions

Each year, participants may make salary deferral contributions to the Plan based upon a percentage of pre-tax annual compensation, as defined in the Plan. Eligible employees may elect to make additional after-tax Roth contributions as permitted by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may, at its discretion, make matching contributions to the Plan. For the year ended December 31, 2024, the Company elected to match 100% of elective deferrals, up to a maximum contribution equal to 6% of eligible compensation. Participants also direct the investment of Company contributions. Although additional profit sharing amounts may be contributed at the option of the Company's Board of Directors, there were no such contributions for 2024. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and Company contributions as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. In the event of termination due to death or total and permanent disability, participants shall become 100% vested in the Company contribution portion of their account. For all other participants, vesting in the Company contribution portion of their account is based on credited years of service, as defined in the Plan, according to the following schedule:

Any participant who had a balance transferred from the OpenSky Corporation 401(k) Profit Sharing Plan & Trust into this plan as part of the merger of the two plans will continue to be covered under the vesting schedule for the OpenSky Corporation 401(k) Profit Sharing Plan & Trust for only these accounts transferred over as part of the merger. The vesting schedule for previous matching and nonelective contributions for those transferred accounts is 25% after 1 year of service, 50% after 2 years of service, 75% after 3 years of service and 100% after 4 years of service. Other prior Matching (non-Safe Harbor) contributions previously funded to the OpenSky Corporation 401(k) Profit Sharing Plan & Trust will be subject to the following vesting schedule: less than one Year of Service at 0%; 20% after one Year of Service; 40% after two Years of Service; 60% after three Years of Service; 80% after four Years of Service; and 100% after five Years of Service. Any contributions made to this plan on behalf of these transferred participants subsequent to the transfer will be vested under the TUV Rheinland 401(k) Profit Sharing Plan vesting schedule.

Any Participant who had a balance transferred from the TRIS 401(k) Plan into this plan as part of the merger of the two plans will continue to be covered under the vesting schedule for the TRIS 401(k) Plan for only these accounts transferred over as part of the merger. The vesting schedule for previous matching and nonelective contributions for those transferred accounts is 20% for 1 year of service, 40% for 2 years of service, 60% for 3 years of service, 80% for 4 years of service, 100% for 5 years of service. Any contributions made to this plan on behalf of these transferred participants subsequent to the transfer will be vested under the TUV Rheinland 401(k) Profit Sharing Plan vesting schedule.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. The loan interest rate, determined at the time of the loan, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

On termination of service for any reason, participants will receive benefits equal to the value of the vested interest in his or her account. Participants with a vested account balance less than \$1,000 will receive a mandatory lump-sum distribution. For terminated participants with a vested account balance greater than \$1,000 but less than \$7,000, the Plan administrator will make a direct rollover

of the participant's account to an individual retirement account designated by the Plan administrator. Participants with a vested account balance greater than \$7,000 may elect to receive their benefits either as a lump-sum or installment payments or defer payment of benefits until a later date.

Participants who are at least 59 1/2 years of age or who have become disabled may withdraw all or a portion of the balance in their account prior to termination for any reason. Withdrawals from certain portions of a participant's account balance may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$40,408 and \$25,346, respectively. These forfeited balances will be used to pay administrative expenses or reduce future employer contributions. During 2024, forfeitures of \$114,255 were used to offset employer contributions.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Discretionary nonelective contributions are recorded in the year in which elected.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as incurred.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Contain investments in common stock which is valued at the closing price reported on the active market on which the individual securities are traded.

Common collective trust: Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Empower Trust Company, LLC and Empower Annuity Insurance Company of America.

Note 5 - Fully benefit-responsive investment contract

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America totaling \$9,122,271 and \$10,729,915 as of December 31, 2024 and 2023, respectively. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7 - Tax status

The prototype plan document, which the Plan has adopted via a nonstandardized adoption agreement, obtained its latest opinion letter dated November 14, 2022, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving its opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Related party and party-in-interest transactions

Certain Plan investments were invested in funds managed by Empower Trust Company and Empower Annuity Insurance Company of America. Empower Trust Company and Empower Annuity Insurance Company of America are the custodians and, therefore, these transactions qualify as party-in-interest transactions. The Plan allows participants to take loans against their account balances, which are also considered exempt party-in-interest transactions. Indirect fees paid to the custodians for certain investment management services are included in the net appreciation in fair value of investments. In addition, the Plan paid professional fees related to investment advisory services and audit fees which are considered exempt party-in-interest transactions. Fees paid directly by the Plan for professional fees and to the custodians for investment management and administrative services amounted to \$84,166 for the year ended December 31, 2024. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

The Plan entered into a revenue sharing agreement with Empower Trust Company to establish an expense budget account for purposes of paying certain Plan expenses. The expense budget account totaled \$16,046 and \$171 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, the Plan received revenue sharing credits in the amount of \$35,927 into the expense account budget account, which is included in net appreciation in fair value of investments in the statement of changes in net assets available for benefits. Pursuant to the agreement, the expense budget is treated as a Plan asset and must be used only for appropriate Plan expenses. The Plan utilized \$35,927 of funds from the expense budget account to pay expenses for the year ended December 31, 2024.

Note 9 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
