As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**1. Description of Plan:**

The following description of Moab Valley Healthcare, Inc. Retirement Plan (the Plan) is provided for general information only. Participants should refer to the plan agreement for more complete information.

**General** – The Plan is a defined contribution 403(b) plan covering qualifying employees of Moab Valley Healthcare, Inc. doing business as Moab Regional Hospital (the Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The effective date of the Plan was January 1, 2016.

**Eligibility** – All employees are eligible to participate in the Plan for purposes of making deferral contributions and rollover contributions to the Plan from the date of hire. Employees who have reached the age of 18, have worked at least 1,000 hours in the plan year, and are employed on the last day of the plan year, are eligible for the discretionary matching contributions and nonelective contributions.

**Contributions** – Participants may make voluntary tax-deferred contributions to the Plan through payroll deductions of up to the Internal Revenue Service (IRS) maximum allowable contribution. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Each plan year, the Sponsor may make matching contributions and/or nonelective contributions to eligible participants in the Plan in the amounts determined by the Sponsor at its discretion. The Sponsor approved a matching contribution of up to three percent and a nonelective contribution of one percent of eligible compensation for the years ended December 31, 2024 and 2023. The Plan includes an auto-enrollment provision, whereby all employees of the Sponsor who have not made a contrary election are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rates at three percent. The deferral rate will be increased each January 1 by one percent of compensation up to a maximum rate of six percent of compensation. Participants may direct contributions to any of the available options offered by the Plan.

**Participant accounts** – Each participant's account is credited with the participant's contributions and allocations of (a) the Sponsor's contribution, and (b) the Plan's earnings and losses, and charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are immediately vested in their salary deferral contributions and employer contributions, plus actual earnings thereon.

**Benefit payments** – Normal retirement under the Plan occurs at age 65. The Plan provides for retirement distributions to persons under age 59½, if certain conditions are met, as specified in the plan document. Participants or their beneficiaries are eligible to receive payment of benefits in the event of the participant's retirement, death, disability, or termination of the Plan. Benefits are distributed according to provisions set forth in the plan document. If participants' account balances are less than \$1,000, they shall be distributed in a lump-sum payment. If the vested amount exceeds \$1,000, participants may elect the benefits to be distributed in a lump-sum payment, annual installments, or an annuity distribution.

**1. Description of Plan (continued):**

**Notes receivable from participants** – Participants may borrow from the Plan, upon approval of the plan administrator. The amount of the note cannot be less than \$1,000 and is limited to one-half the total value of the participant’s vested account balance, up to \$50,000. Principal and interest are paid ratably through payroll deductions. The term of the note may not exceed five years. The note is secured by the balance in the participant’s account and bears interest at one percent above the current prime interest rate.

**Plan termination** – Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, the participants would become 100 percent vested in their accounts.

**2. Summary of Significant Accounting Policies:**

**Basis of accounting** – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment valuation and income recognition** – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held, during the year.

The fair value of the Plan’s assets is based on quoted market prices determined by pricing services from Newport Group Retirement Services, Inc., Ascensus, LLC, and other reliable sources. Shares of registered investment companies (mutual funds) are reported at fair value based on the quoted market price of the fund, which represents the net asset value of the shares held by the fund at year end. See Note 4 for discussion of fair value measurements.

**Benefit payments** – Benefits are recorded when paid. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 and 2023.

**Administrative expenses** – The Sponsor pays certain administrative expenses on behalf of the Plan.

**Subsequent events** – In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 8, 2025, the date the financial statements were available to be issued.

**3. Information Certified by the Plan Custodians:**

Newport Trust Company and Ascensus, LLC, the custodians of the Plan, have supplied the plan administrator with certifications as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental Schedule H, Line 4i – schedule of assets (held at end of year) as of December 31, 2024.

**4. Fair Value Measurements:**

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value.

**Mutual funds (including money market mutual funds)** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. Fair Value Measurements (continued):**

*Mutual funds (including money market mutual funds) (continued)* – The methods used by the Plan to estimate the fair value of its assets may produce a fair value calculation that may not be indicative of net realizable value, or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Changes in fair value levels* – The availability of observable market data is monitored to assess the appropriate classifications of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

**5. Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**5. Risks and Uncertainties (continued):**

The Plan has a concentration of investments in Vanguard Target Retirement 2030, Vanguard Target Retirement 2035, and Vanguard Target Retirement 2040. A change in the value of these funds could cause the value of the Plan's net assets available for benefits to change due to this concentration. In addition, as a result of funds being selected by participants, certain other funds may individually represent a concentration of greater than 10 percent of the Plan's investments at fair value in the statements of net assets available for benefits.

Although these individual funds maintain a level of diversification by investing in multiple equity, debt, or other instruments, there may be a concentration of risk because the funds are invested at the direction of a single fund manager. At December 31, 2024 and 2023, Vanguard Target Retirement 2030, Vanguard Target Retirement 2035, and Vanguard Target Retirement 2040 each individually represented greater than 10 percent of the Plan's investments at fair value.

**6. Plan Tax Status:**

The plan terms have been drafted in reliance on the sample language provided by the IRS in the draft Listing of Required Modifications issued April 4, 2009. The Plan is required to operate in conformity with the Internal Revenue Code (IRC) to maintain the exclusion from tax for plan participants. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. The plan administrator uses a plan document sponsored by Newport Group Retirement Services, Inc. and Ascensus, LLC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are no audits for any tax periods in progress.

**7. Party-in-interest Transactions:**

The Plan's advisory committee consists of employees of the plan sponsor. There are no transactions between the parties other than contributions to the Plan, if eligible.

Certain plan investments are shares of mutual funds managed by Newport Group Retirement Services, Inc. and Ascensus, LLC. Newport Group Retirement Services, Inc. and Ascensus, LLC performed administrative services for the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan amounted to \$100,886 for the year ended December 31, 2024.

The plan auditor performs the required annual audit of the Plan.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.
