Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Charles Perry Partners, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

(1) **Description of Plan:**

The following description of the Charles Perry Partners, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

(a) **General**—The Plan is a defined contribution 401(k) Profit Sharing Plan that covers substantially all employees of Charles Perry Partners, Inc. (the Company) who have attained the age of 18. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

(b) **Contributions**—Each year, participants may contribute up to 100% of pretax or post-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. For the year ended December 31, 2024, the Company made a safe-harbor matching contribution to the Plan (100% of the first 1%, then 50% from 1% to 6%, with 3.5% being the maximum contribution) based upon the participants' eligible compensation. The Company may also make non-elective or profit-sharing contributions. The Company did not make any non-elective contributions or profit-sharing contributions during 2024. Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

(c) **Participant accounts**—Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The Company currently offers various pooled separate accounts, one common collective trust fund, and a guaranteed interest account as investment options for participants. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) **Vesting**—Participants are vested immediately in their contributions plus actual earnings thereon. Participants are fully vested in the Company's discretionary non-elective matching contributions and profit-sharing contributions after six years of credited service. Participants are fully vested in the Company's safe harbor matching contributions after two years of credited service. There are special vesting rules for participants employed as of June 30, 2009 with immediate vesting on the Company's matching contributions made from June 30, 2009 through May 31, 2014. Participants become immediately 100% vested in the Company's contribution portion of their accounts upon death or disability.

(e) **Notes receivable from participants**—Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balances in the participants' accounts and bear interest rates of 4.25% to 9.50% with terms ranging from one to five years, unless for the purchase of the participant's principal residence. Principal and interest is paid ratably through weekly payroll deductions.

(1) **Description of Plan:** (Continued)

(f) **Payment of benefits**—Upon termination of service, retirement, disability, or death, participants may receive a distribution equal to their vested account balance. Distributions may be paid in the form of a lump-sum payment. The participant’s contributions may also be withdrawn for certain hardship situations.

(g) **Forfeited accounts**—Forfeited accounts may be used to pay administrative fees and to reduce the future employer contributions. As of December 31, 2024 and 2023, there were forfeited non-vested balance remaining of \$48,608 and \$34,555, respectively. During 2024, there were no forfeitures used to reduce employer contributions and contributions receivable.

(h) **Administrative expenses**—The Plan permits payment of administrative expenses to be made from the Plan’s assets and for them to be allocated either proportionately based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. However, certain operating expenses of the Plan, such as audit fees, are paid by the Company. Plan administration and investment management fees reduce the participants’ account balances. Expenses relating to specific participant transactions (e.g., loan setup, distribution request, etc.) are charged directly against the appropriate participant’s account.

(2) **Summary of Significant Accounting Policies:**

(a) **Basis of accounting**—The accompanying financial statements of the Plan are presented on the accrual method of accounting.

(b) **Investment valuation and income recognition**—The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Interest and dividend income are recorded when paid. Net appreciation (depreciation) in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

(c) **Notes receivable from participants**—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

(d) **Payment of benefits**—Benefits are recorded when paid.

(e) **Use of estimates**—The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

(f) **Subsequent events**—The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 10, 2025, the date the financial statements were available to be issued.

(3) Information Certified by the Custodian:

All information related to investments and participant notes receivable, as disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, participant notes receivable held as of December 31, 2024 and 2023, and the net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable for the year ended December 31, 2024, was obtained by management from Voya Retirement Insurance and Annuity Company (Voya), the Plan's custodian, and certified by Voya as complete and accurate.

(4) Investments and Fair Value Measurements:

FASB *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted market prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable that reflect the Plan's own assumptions about assumptions that market participants would use in pricing the assets, based on the best information available in the circumstance.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Common collective trusts (CCT) – Valued at net asset value (NAV) of the units held by the Plan at year end. The NAV, as provided by the trustee, is based on the fair value of the underlying investments of the trust less its liabilities. The CCTs are traded daily at their NAV, and are therefore classified as Level 1 in the fair value hierarchy

Pooled separate accounts (PSA) – Valued at net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the custodian, is based on the fair value of the underlying mutual funds held by the fund less its liabilities. The PSAs are traded daily at their NAV, and are therefore classified as Level 1 in the fair value hierarchy.

(4) Investments and Fair Value Measurements: (Continued)

Guaranteed interest accounts – Valued at the NAV of shares held by the Plan at year end. The NAV, as provided by the custodian, represents the estimated fair value determined by the contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates. Participant transactions (purchases and sales) may occur daily. The guaranteed interest account seeks fixed income with stability of principal.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no purchases, issues, or transfers in or out of Level 3.

(5) Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

(6) Income Tax Status:

The Plan adopted a pre-approved profit-sharing plan that obtained a favorable determination letter from the Internal Revenue Service dated June 30, 2020. A favorable determination letter qualifies the Plan under Section 401(a) of the Internal Revenue Code (IRC). The Plan has been amended since the date of the letter; however, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by tax authorities and may change upon examination.

(7) Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(8) Parties-in-Interest:

Voya is the custodian of the Plan assets and derives fees based on the asset values, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. EGPS provides record keeping services, which is included in administrative expense. Except as described in Note 1(h), the Company pays any other fees related to the Plan's operations.
