### Report on the Audit of the Financial Statements

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Buerkle Companies Employee Savings and Retirement Plan (the Plan) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established March 1, 1985 and most recently amended effective July 1, 2022. The Plan covers all employees of Buerkle Company (the Company) who meet certain eligibility requirements. The Plan excludes nonresident aliens and leased employees. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Employees are eligible to contribute after reaching the age of 18 and completing three months of service. Company contributions are made for employees who have reached the age of 18 and have had three months of service. Employees covered by a collective bargaining agreement are eligible for Company Contribution after 30 days of continuous employment with a single employer, except if hired during May or June eligible after 60 days of continuous employment. Eligible employees begin participation on the first day of the month coinciding with or following the date the eligibility requirements are met.

**Contributions**

Each year, participants may contribute a percentage of pre-tax and/or after-tax (Roth) annual compensation, as defined in the Plan, up to 100% of their compensation or the maximum allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

New employees who meet the eligibility requirements are automatically enrolled in the Plan on the first of the month after completing three months of service unless the employee elects not to participate. Automatic contributions for these employees are deducted at a rate of 4% of Plan compensation.

The Company will make a matching contribution of 50% of a participant's elective deferral up to 6% of a participant's compensation for eligible employees for each payroll period. The Company may elect to make a profit sharing contribution at the discretion of the Company's Board of Directors. Participants must be employed on the last day of the year to receive a profit sharing contribution. There were no profit sharing contributions made in 2024 and 2023. Contributions are subject to certain limitations.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Contributions (Continued)**

Effective November 15, 2021, the following employer contributions were added for eligible union employees:

- Employer seed money contributions, for certain union employees who were employed as of November 15, 2021, of \$900 per year during 2021 through 2025.
- Employer union contributions, for certain union employees employed as of November 15, 2021, of 6% of eligible compensation.
- Employer union match contributions, for union employee employed as of November 15, 2021 and future eligible union employees, of 50% of deferrals up to a maximum of 6% of eligible compensation.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service. A participant is fully vested upon reaching normal retirement age, upon death, or upon permanent disability.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, and allocations of (a) the Company's match contribution, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participant accounts are valued on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits**

Employees may elect to receive the value of their account as a lump sum distribution upon termination, retirement, death, or disability, or they may elect to receive their benefits as a joint and survivor or life annuity payable monthly. If the vested account exceeds \$5,000 they may defer the distribution of benefits. If a participant terminates employment and has an account balance less than \$5,000, the participant's account will automatically be rolled into an IRA in their name. The Plan permits distributions in the event of financial hardship, as defined in the Plan. The Plan also permits in-service withdrawals, beginning at age 59½.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes receivable terms range from 1 to 5 years or up to 30 years for the purchase of a primary residence. The notes receivable are secured by the vested balance in the participant's account and bear interest at a fixed rate which is equal to 2% over the prime rate as listed in *The Wall Street Journal* in effect on the date the note is requested. Principal and interest is paid ratably through weekly or semi-monthly payroll deductions.

**Forfeited Accounts**

Forfeited nonvested accounts may be used to pay Plan expenses or to reduce future Company matching contributions. Forfeited nonvested accounts at December 31, 2024 and 2023 were \$4,033 and \$24,224, respectively. Forfeitures used to reduce matching contributions for the years ended December 31, 2024 and 2023 were \$38,146 and \$11,679, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

**Contributions**

Contributions from participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Benefit Payments**

Benefit payments are recorded upon distribution.

**Administrative Expenses**

The Company pays certain administrative expenses on behalf of the Plan.

**Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Minnesota Life Insurance Company (MN Life), the qualified institution through December 31, 2023, has supplied the Plan administrator with a certification as to the completeness and accuracy of investment information and notes receivable presented in the accompanying statement of net assets available for benefits as of December 31, 2023 and the statement of changes in net assets available for the year then ended.

The Standard Insurance Company (The Standard), the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of investment information and notes receivable presented in the accompanying statement of net assets available for benefits as of December 31, 2024, the statement of changes in net assets available for the year then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts* – Investments in pooled separate accounts are valued based on the net asset value (NAV) of units which are based on market prices of the underlying investments held by the Plan at year-end. NAV is a readily determinable fair value and is the basis for current transactions.

**NOTE 5 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The prototype Plan has been restated since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 5 PLAN TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 7 PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments were managed by The Standard, the qualified institution, as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions.

**NOTE 8 GENERAL ACCOUNT WITH INSURANCE COMPANY**

Effective in October 2019, the Plan invested in a benefit-responsive fund with MN Life. MN Life was subsequently acquired by The Standard, who maintains the contributions in a general account. The accounts were credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The contract met the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by The Standard represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor, or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 9 RISKS AND UNCERTAINTIES**

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


