NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024

Note 1—Description of the Plan

The following description of the Parc Auto Group Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan established by Parc Auto LLC (the “Company” or “Plan Sponsor”), effective January 1, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration – The Plan is administered by the Company, which serves without compensation. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

Eligibility – Employees are eligible to participate in the Plan upon reaching the age of 21 and when they have completed six consecutive months of service. The Plan excludes nonresident aliens, certain union employees under collective bargaining agreements and individuals incorrectly classified as non-employees.

Contributions – Participants may elect to contribute a portion of their compensation as a pre-tax deferral or Roth deferral subject to certain Internal Revenue Code (“IRC”) limitations. The sum of participants pre-tax and Roth contributions is subject to the annual limitation of \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions subject to the annual limitation of \$7,500. Catch-up contributions are 401(k) elective deferral contributions in excess of any limit on such contributions under the plan. Participants may also contribute amounts representing distributions from other qualified retirement plans. The Plan provides for automatic enrollment provision for newly eligible employees. Such employees will be automatically enrolled at a deferral rate of 3% of compensation, unless they opt out or elect a different percentage. Automatic elective deferrals will increase by 1% per year, up to a maximum of 10% of compensation, unless otherwise elected by employee. The Company makes safe harbor matching contributions equal to 100% up to 3%, plus 50% of the next 2% of compensation that each participant contributes to the Plan.

Participant Accounts – Each participant’s account is credited with the participant’s contributions, the Company’s matching contribution, if any, and Plan earnings. Each participant’s account is charged with an allocation of Plan losses and any applicable administrative expenses, as defined. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Upon enrollment in the Plan, a participant may direct contributions into various investment options offered by the Plan. Participants may change their investment options at any time during the Plan year.

Vesting – Participants are immediately vested in their contributions, matching contributions plus actual earnings thereon.

Payment of Benefits – Vested amounts contributed through salary/wage reductions may be withdrawn by or distributed to a participant only upon: (1) termination of service, (2) death, (3) disability, (4) retirement, or (5) a hardship distribution. For terminated employees, if vested balance is \$5,000 or less, the balance may be automatically distributed in the form of lumpsum cash. In-service distributions are allowed for participants over the age of 59½, but only if the participant is fully vested in their account. Certain income tax penalties may apply to withdrawals or distributions prior to retirement. Hardship withdrawals are also allowed as defined in the Plan agreement.

Note 1—Description of the Plan (continued)

Forfeited Accounts – Forfeitures are retained in the Plan and will be used to reduce administrative expenses under the Plan or reduce future Employer contributions to the Plan. As of December 31, 2024, forfeited nonvested account balance as \$36. During the year ended December 31, 2024, no forfeitures were used to reduce future Employer contributions and administrative expenses to the Plan.

Administrative Expenses – The Company provides certain administrative and accounting services to the Plan at no cost. Most administrative expenses are paid directly by the Company, including audit and legal fees, and are excluded from the accompanying financial statements.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of the investments includes the Plan’s realized and unrealized gains and losses on investments bought and sold, as well as held, during the year. Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned daily and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits – Benefit payments are recorded when paid.

Notes Receivable from Participants – Notes receivable are not permitted under the Plan, with exception of notes receivables transferred from other qualified retirement plans. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred.

Administrative Expenses – Administrative expenses of the Plan are paid by the Company or Plan participants, as defined in the Plan document.

Fair Value Measurements – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction value between market participants on the measurement date. The framework for measuring fair value provides a fair value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

Note 2—Summary of significant accounting policies (continued)

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies, and

Level 3 – Inputs to the valuation methodology are unobservable inputs in the situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds – Mutual funds are valued based on the same securities traded on a national exchange at the last reported sales price on the last business day of the Plan year; investments traded in the over-the-counter market and listed securities for which no sale was reported on the last day of the Plan year are valued at the last reported bid price. These assets are classified as Level 1 assets within the fair value hierarchy.

Money Market Account – The underlying assets are generally comprised of short-term securities representing high quality, liquid debt, and monetary assets. The Custodian establishes the market and quotes the price, on a daily basis, that is available to market participants, which is a market approach to valuation. The money market account is classified within Level 1 of the valuation hierarchy.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Recently Issued Pronouncements – Plan management is not aware of any recently issued accounting pronouncements that would have a material impact on the Plan's financial statements.

Note 3—Information certified by the qualified institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the "qualified institution", has certified the following information included in the accompanying financial statements is complete and accurate:

Note 5—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, the assets of the Plan will be distributed to the participants in accordance with the Plan provisions.

Note 6—Transfers of assets

During the year ended December 31, 2024, the Plan received net transfers of assets totaling \$2,138,657 from a qualified retirement plan. The transfers are presented as a separate line item on the statement of changes in net assets available for benefits and are excluded from contributions, investment income, and benefit payments.

The Plan administrator has verified that all transfers comply with ERISA provisions and applicable IRS regulations. No nonexempt transactions were identified in connection with these transfers. The transferred assets were recorded at fair value on the date of receipt and are included in the Plan's net assets available for benefits as of year-end.

Note 7—Related party and party-in-interest transactions

Investment transactions with the qualified institution qualify as party-in-interest transactions as defined by ERISA. Certain administrative expenses, consisting of qualified institution expenses and investment management and accounting fees, are paid by the Company, and are excluded from these financial statements.

During the year ended December 31, 2024, the Plan paid \$675 to the related parties-in-interest for custodial and trust services, recordkeeping, and asset management services. The Company also performs services for the Plan without compensation. Notes receivable from participants qualify as party-in-interest transactions.

Note 8—Tax status

The Plan adopted a prototype standardized profit-sharing plan which received a favorable opinion letter from the IRS on June 30, 2020, which stated the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not received an opinion letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax. Therefore, the Plan continues to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or an asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9—Risks and uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 10—Subsequent events

The Plan has evaluated subsequent events for potential recognition and disclosure through October 10, 2025, the date the financial statements were available to be issued.

Effective February 1, 2025, the Plan was amended to modify the eligibility service requirement for participation. Under the revised provision, employees must complete twelve consecutive months of service to become eligible, replacing the previous requirement of six consecutive months of service.
