INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cota & Cota, Inc. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024, is presented for the purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets which provide benefits under the Plan and are certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 - Description of the Plan

The following description of the Cota & Cota, Inc. Profit Sharing Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan established August 1, 1972 by Cota & Cota, Inc. ("the Company") and most recently amended and restated January 1, 2022 covering substantially all full-time employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and is a qualified retirement plan under Internal Revenue Code (IRC) 401(a) and other code sections. The Trustees are responsible for oversight of the Plan.

Eligibility:

Employees who have one year of service and are age 18 or older are eligible to participate in the Plan. The Plan excludes the following categories of employees for participation: employees covered under a collective bargaining agreement (i.e. union employees), and non-resident employees.

Contributions:

Each year participants may contribute up to the maximum amount allowed by law, as defined in the Plan. Participants are allowed to make pre-tax contributions and rollover contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Profit-sharing contributions are at the option of the Company. To be eligible for profit-sharing contributions, an eligible employee must be employed at year end and have completed 1,000 hours of service in the applicable year. The Company's profit-sharing contributions for the year ended December 31, 2024 and 2023 totaled \$400,000 and \$500,000, respectively. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Rollovers:

At the discretion of the Plan administrator, participants may deposit distributions received from other qualified plans (rollovers) into the Plan. The participant's rollover amounts are credited to a separate account. Participants are 100% vested in their rollover accounts, together with earnings received thereon.

Investment Elections:

Participants direct the investment of their and the Company's contributions into various investment options offered by the Plan.

Participant Accounts:

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contributions and (b) plan earnings and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, deferrals, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit provided from the participant's vested account.

Vesting:

Participants are immediately vested in all employee contributions plus earnings thereon. Vesting on the accounts attributable to Company contributions is based on years of service. A participant is 20% vested after two years of credited service, 40% vested after three years of service, 60% vested after four years of service, 80% vested after five years of service and 100% vested after six years of credited service. Any participant who attains normal retirement age, becomes disabled, or dies, becomes fully vested regardless of length of service.

Payment of Benefits:

Upon retirement, death, disability, or termination of service, a participant may elect to receive a lump sum payment equal to the vested portion of his or her account. Participants also may choose to remain invested in their account. In-service and hardship withdrawals are allowed upon meeting the statutory requirements.

Forfeited Accounts:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,423 and \$14,270, respectively. These accounts were used to pay Plan expenses, or to pay future Plan expenses.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires Plan's management to make estimates and assumptions that affect the reported amounts of plan assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits:

Benefits are recorded when paid.

Contributions:

Contributions from Plan participants are recorded in the year the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition:

The Plan's investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis, and interest income, if any, is recorded on an accrual basis. Dividends, if any, are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on the investments bought and sold as well as held during the year.

Administrative Expenses:

The Plan is responsible for payment of investment expenses and fees; however, the Company may pay the Plan expenses related to legal, accounting and general administration.

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Note 3 - Certified Information

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, including non-interest bearing cash and investments at fair value held at December 31, 2024 and 2023 and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (John Hancock), the custodian of the Plan.

Note 4 - Fair Value Measurements

The Fair Value Measurement Topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The three levels of the fair value hierarchy are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following are descriptions of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts (PSA): PSAs invest in a variety of domestic stocks, international stocks, mutual funds, bonds and other securities. The majority of the underlying securities have observable level 1 quoted pricing inputs. While the underlying assets values are generally based on publicly quoted prices, the net asset value (NAV) of each separated PSA is not valued using publicly quoted prices. The NAV provided by the Custodian is used as the practical expedient to estimate fair value. PSAs can be redeemed on a daily basis and each PSA has its own investment strategy. Participants should refer to the individual PSA's prospectus for a complete description of the PSA and its investment strategy.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in the Company's contributions.

Note 6 - Tax Status

The Company has adopted the ASCENSUS LLC'S Non-Standardized Pre-Approved Profit Sharing/Money Purchase Coda that has received an opinion letter from the IRS dated June 30, 2020, stating that the pre-approved plan document was in compliance with the applicable requirements of the IRC. Accordingly, the Plan's net investment income (loss) is exempt from income taxes. The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Although the Plan has been amended since adopting the pre-approved plan documents, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 7 - Related-Party/Party-In-Interest Transactions

Certain Plan investments are held in investments managed by the custodian, John Hancock Insurance Company, as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$2,092 in 2024. Plan fees were reduced by application of forfeitures of employer matching balances.

Certain employees and officers of the Company, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

Note 8 - Risks, Uncertainties and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account

balances and the amounts reported in the statement of net assets available for benefits. At December 31, 2024 approximately 18.5% of the Plan's investments were invested in the John Hancock Multimanager Growth Lifestyle Fund A.
