1. Description of Plan

The following description of the Shaheen Automotive Group 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The purpose of the Plan is to provide financial assistance during a participant's retirement years or to provide benefits in the event of disability, death, or termination of employment prior to retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC). The Plan covers substantially all full-time, part-time, and leased employees of Shaheen Automotive Group Inc.; Shaheen Chevrolet, Inc.; Team One Chevrolet Buick GMC Truck, Inc.; and Shaheen Parts Warehouse, Inc. (collectively referred to as the Company). On-call drivers are ineligible to participate in the Plan.

Employees are automatically enrolled in the Plan at a 4% deferral rate unless they are excluded employees, or they elect to opt out. Deferrals increase by 1% each April 1st for participants automatically enrolled in the Plan, until a 10% deferral rate is achieved, or the participant changes the deferral election, as defined in the Plan agreement.

Contributions

As defined in the plan document, participants can contribute a portion of their pretax annual compensation into the Plan through a salary deferral agreement. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan also allows for voluntary catch-up contributions for participants age 50 and over. Additional voluntary contributions are not allowed. For each Plan year, the Company may also contribute on the participant's behalf matching contributions, profit sharing contributions, and/or qualified nonelective contributions. For the Plan years 2024 and 2023, there was a Company matching contribution, but there were no profit sharing contributions. The Company's matching contribution was calculated as follows: the lesser of 1% of eligible compensation or 25% of employee contributions on a quarterly basis. All contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Participants direct the investment of their contributions as well as the Company contributions made on their behalf into various investment options offered by the Plan.

Each participant account is credited with their contributions, the Company contributions made on their behalf, and Plan earnings and administrative expenses, which are allocated proportionately among all participants based on their investment in each fund.

Vesting

Participants are immediately 100% vested in their contributions plus any actual earnings thereon. Under the Plan, employees acquire a vested and nonforfeitable interest in a percentage of their account attributable to the Company's contributions as determined by the following schedule.

Participants become fully vested even if they have not met the above requirements at normal retirement age, death prior to normal retirement date, or total and permanent disability prior to normal retirement date.

Payment of Benefits

On termination of service due to retirement, disability, death, or employment termination, a participant may elect to have their vested account balance distributed as a lump-sum distribution, as periodic installment payments over a period which does not exceed the life expectancy of the participant/beneficiary, or to receive a combination of a lump-sum distribution and installment payments. Upon attainment of age 59 1/2 or the occurrence of a hardship, as defined by the plan document, a participant may withdraw all or any portion of their vested account balance.

Payment of Benefits (continued)

Participants have the option of electing to roll their vested account balance directly into another qualified retirement plan or an individual retirement account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The payment of benefits is subject to certain IRS guidelines. Benefits are recorded when paid.

Notes Receivable from Participants

Participants may borrow from their fund accounts the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at a market rate.

Hardships, Forfeitures, and Plan Termination

The Plan allows for hardship withdrawals. Hardship withdrawals are subject to the guidelines within the plan document.

The Plan experienced forfeitures of employer contributions of \$52,877 during the 2024 plan year and \$19,480 during the 2023 plan year. Forfeited nonvested accounts totaled \$0 as of December 31, 2024 and \$20,333 as of December 31, 2023. Forfeitures may be used to pay plan expenses, offset employer contributions, or be re-allocated to participants. The Company's practice is to re-allocate forfeitures to participants.

The Company anticipates and believes the Plan will continue to operate without interruption, but reserves the right to suspend contributions, discontinue contributions, or amend, modify, or terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, all participants become 100% vested in their entire account balance.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair market value, except the guaranteed investment contract, which is valued at contract value. Shares of mutual funds are valued at quoted market prices in an active market, which represent the value of shares held by the Plan at year end. The pooled separate accounts are valued at fair value based on the net asset value (NAV), as reported by the trustee. The NAV is based on the fair value of securities held by the investment. Certain investments include restrictions on the number of transfers allowed in a specified time period. See Notes 4 and 5 for details on the guaranteed investment contract and fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The change in aggregate fair value and the cost of investments purchased, sold, and held is reflected in the statements of changes in net assets available for benefits as net realized and unrealized appreciation/depreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Administrative Expenses

The contract administrator and investment management fees are paid by the Plan. All other administrative expenses are paid by the Company, who is also the Plan Sponsor. A portion of the operating expenses and management fees are paid by the Plan using revenue sharing credits which are included in other income on the statements of changes in net assets available for benefits. The revenue sharing credit balance was \$6,823 as of December 31, 2024 and \$53,502 as of December 31, 2023, and is held in the fully benefit responsive contract balance on the statements of net assets available for benefits. The expenses and fees paid using revenue sharing credits were \$60,649 as of December 31, 2024 and \$38,531 as of December 31, 2023.

Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued.

3. Financial Data Certified by the Trustees

The Plan's financial information and data was certified by Lincoln Financial Group Trust Company, Inc. (Lincoln) for the year ended December 31, 2023 and the period from January 1, 2024 through April 30, 2024 and by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) from May 1, 2024 through December 31, 2024, the trustees of the Plan, in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the investment balances, notes receivable from participants, interest and dividend income, and net realized and unrealized appreciation/depreciation in fair value of investments included in the financial statements and supplemental schedule were obtained from data that has been prepared and certified as complete and accurate by the trustees.

4. Guaranteed Investment Contract with Principal Life Insurance Company

The Plan holds a fully benefit-responsive investment contract with Principal Life Insurance Company, the Principal Guaranteed Option. The contributions to the Principal Guaranteed Option are maintained in group annuity contracts. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by the Trustee.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

A 10% surrender charge will also apply if the cumulative participant transfers from the Principal Guaranteed Option exceeds \$50,000 and 25% of the Plan's interest in the contract during the 12-month period immediately preceding the Plan sponsor-level surrender of the Plan's interest in the contract. If this scenario occurs, the surrender charge will be billed to the Plan sponsor. Management noted the occurrence of each of these events is not probable.

There are not any events that allow the Principal Life Insurance Company to terminate the contract with the Plan and settle at amounts that differ from contract value; however, the Principal Life Insurance Company can freeze the contract by declaring a contribution cessation date. There are no unfunded commitments related to the investment contract.

There are no reserves established to offset contract value for credit risk. The contract interest rates are reviewed on a semiannual basis. The approximate average yield and minimum crediting interest rate are as follows:

5. Fair Value Measurements

As defined in current authoritative guidance, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The guidance applies to all financial instruments that are measured and reported on a fair value basis. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques the Plan is required to provide information according to the fair value hierarchy. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values.

Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

- Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.
- Level 2 – Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets and liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 – Significant unobservable inputs that reflect a company’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

There have been no changes in the methodologies used as of December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Federal Income Tax Status

The Plan obtained a favorable determination letter dated June 30, 2020, in which the IRS determined that the Plan, as then designed, was in compliance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally, tax years 2021 through the current year remain open to examination. The Plan does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

7. Risks and Uncertainties

The Plan invests in various investment securities. These investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

8. Party-in-Interest Transactions

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan paid Lincoln, the record keeper prior to May 1, 2024, \$62,677 during 2024 and \$48,180 during 2023. The Plan paid Principal, the record keeper after May 1, 2024, \$47,040 during 2024.

Prior to May 1, 2024, certain Plan investments were managed by Lincoln National Life Insurance Company, a related entity to Lincoln. Lincoln was the trustee; therefore, these transactions qualify as party-in-interest transactions. Effective May 1, 2024, certain Plan investments are managed by Principal Life Insurance Company, a related entity to Principal. Principal is the trustee; therefore these transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. Merrill Lynch is the Plan investment advisor and consultant, which is also considered a party-in-interest. The Plan's auditor is also deemed a party-in-interest under ERISA.
