**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Birds Eye Holdings, LLC and Affiliated Companies 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

NOTES TO FINANCIAL STATEMENTS

**1. DESCRIPTION OF PLAN**

The following description of the Birds Eye Holdings, LLC and Affiliated Companies 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan's provisions. The administrative committee is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, monitoring investment performance, and reporting to the Plan's Board of Trustees.

Eligibility - The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), covering substantially all full-time employees of Birds Eye Holdings, LLC; Max Aerostructures, LLC; and CD Investors, LLC (collectively, Company) excluding collective bargaining (union) employees, non-resident aliens and part-time, temporary or seasonal employees whose regularly scheduled service is less than 1,000 hours per Plan year. Employees become eligible to participate when they have attained the age of 21 and have completed one month of employment. Employees are treated as participants on the first day of the month immediately following satisfaction of eligibility requirements.

Contributions - The Plan provides that the active participants may make voluntary contributions of pre-tax, after-tax or a combination thereof to the Plan, between 1% of eligible compensation and the maximum allowed by the Internal Revenue Code (\$23,000 for 2024) as adjusted for applicable percentages of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 for 2024). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company's matching contribution is 50% of the first 6% of participant's eligible contributions. Participants direct the investment of their contributions, as well as their portion of the Company's contributions, into various investment options offered by the Plan.

The Plan utilizes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contribution invested in a designated balanced fund until changed by the participant. Participants will have their deferral rates increased by 1% each year, up to a maximum deferral rate of 10%, unless the participant specifically elects otherwise.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of the Company's contribution, Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their voluntary contributions plus the earnings thereon. Participants shall be fully vested with respect to Company contributions upon early or normal retirement age, death, or disability. Otherwise, vesting is based on continuous years of service. A participant is fully vested in their matching contributions after five years of credited service.

Normal Retirement - Normal retirement age is 65 years of age.

**1. DESCRIPTION OF PLAN (CONTINUED)**

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$25,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1% as of the date of the note. Principal and interest are paid ratably through regular payroll deductions. Notes receivable may not exceed five years unless the note is for the purpose of purchasing a personal residence, in which case the term may be up to 15 years.

Payment of Benefits - On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, periodic installments if the balance is greater than \$5,000 or in annual installments for required minimum distributions only. After notification and in accordance with the Plan document, terminated employees with remaining account balances less than \$1,000 will receive an automatic cash out of their vested balance. Those with account balances greater than \$1,000 but not exceeding \$7,000 will have their vested account balances distributed as automatic rollovers to individual retirement arrangements.

Forfeitures - Forfeitures can be used to pay administrative expenses of the Plan or reduce the Company's matching contribution. At December 31, 2024 and 2023, forfeited nonvested accounts were \$2,996 and \$7,154, respectively. In 2024, \$22,729 of forfeitures were used to pay Plan administrative expenses.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting and Use of Estimates - The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect: (1) the reported amounts of assets and liabilities, (2) disclosures such as contingencies and (3) the reported amounts of revenues and expenses included in such financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition - Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Contributions - Contributions from Plan participants and the Company matching contributions are recorded in the year in which the participant contributions are withheld from compensation.

Benefit Payments - Benefits are recorded when paid.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Administrative Expenses - Certain administrative expenses for the Plan are paid by the Company and are not included in these financial statements. Fees related to the administration of the notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Some investment related expenses are included in net change in fair value of investments.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction in contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Subsequent Events - These financial statements considered subsequent events through October 6, 2025, the date the financial statements were available to be issued.

**3. INFORMATION CERTIFIED BY INTRUST BANK, N.A. (UNAUDITED)**

The following is a summary of the investment information as of December 31, 2024 and 2023, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by INTRUST Bank, N.A. (Intrust) and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Intrust that information provided to the Plan Administrator by Intrust related to the following is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information below, the fair values in Note 4, and the values in the supplemental schedule related to the following assets.

Intrust also certified to the completeness and accuracy of \$351,853 of net change in fair value of investments and dividends and interest of \$90,121, related to the above-mentioned Plan assets for the year ended December 31, 2024.

**4. INVESTMENTS AND FAIR VALUE MEASUREMENTS**

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The guidance describes three levels of inputs that may be used to measure fair value:

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Mutual Funds (including Money Market Funds)* - These investments are valued using a quoted price in an active market.

*Common Trust Fund* - This investment is valued at Net Asset Value (NAV). The NAV, as provided by Intrust, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common trust fund, the investment advisor reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly manner.

**5. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan assets are managed by Intrust (party-in-interest) and, therefore, these transactions qualify as party-in-interest transactions. The various funds' operating expense ratios ranged from .04% to .74% as of December 31, 2024. The Plan paid \$25,027 for administrative expenses for the year ended December 31, 2024.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, the interests of the participants in the Plan shall be fully vested at the time of termination and Intrust shall liquidate all assets of the trust and continue to administer the trust in accordance with its provisions until all obligations have been satisfied.

**7. TAX STATUS**

The Plan adopted a Non-Standard Pre-Approved Profit Sharing Plan (pre-approved plan) designed to qualify under section 401 of the Internal Revenue Code. The Plan has obtained a copy of a favorable determination letter for the pre-approved plan dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator and the Plan's tax counsel believe the Plan is designed and is being operated in compliance with the applicable provisions of the IRC, and therefore, believe that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management evaluated the Plan's tax positions and concluded that it had taken no uncertain tax positions that require recognition or disclosure in the financial statements. No provision or liability for income taxes has been included in the financial statements.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
