## Independent Auditor's Report

To the Plan Administrator and Plan Participants of the  
ION Intermediate Holdings, LLC 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the ION Intermediate Holdings, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

### **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). 

Their report dated April 1, 2025 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**1. Description of the Plan**

The following description of the ION Intermediate Holdings, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of Plan provisions.

On June 24, 2019, the Plan Sponsor, formerly named e+CancerCare, was acquired by ION Intermediate Holdings, LLC. In conjunction with this acquisition, the Plan Sponsor name and the 401(k) plan name both changed to ION Intermediate Holdings, LLC and ION Intermediate Holdings, LLC 401(k) Plan, respectively. The Plan documents under the former plan name remain in effect.

On April 15, 2020, the Plan merged the Integrated Oncology Network 401(k) Plan and GammaWest Brachytherapy 401(k) Safe Harbor Retirement Savings Plan into the Plan.

On May 1, 2021, the Plan merged the Southwest Urology 401(k) Profit Sharing Plan into the Plan.

On February 17, 2023, the Plan merged the Fairbanks Urology, LLC 401(k) Profit Sharing Plan and Trust into the Plan.

On March 1, 2023, the Plan merged the cCare 401(k) Profit Sharing Plan into the Plan.

**General**

The Plan is a defined contribution plan covering all employees except pro re nata (“PRN”) employees, of ION Intermediate Holdings, LLC (the “Company”, “Sponsor”, or “Employer”). PRN employees are utilized on an as needed basis. The Plan is subject to the provisions of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (“ERISA”).

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are predominately held and managed by Empower Trust Company, LLC and Empower Annuity Insurance Company of America collectively, the trustee and qualified institution for the Plan, which invests contributions and Plan earnings, executes investment transactions as directed by the participant and provide certain recordkeeping services. Empower Retirement, LLC acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

**Eligibility**

Employees may become a participant of the Plan immediately when they are age twenty-one or older. An eligible employee may enter the Plan on the next monthly entry date after all entry requirements have been met.

**Contributions**

Participants may contribute up to the lesser of Form W-2 compensation, excluding fringe benefits, bonuses and commissions, or the statutory maximum to the Plan through a pretax salary deferral, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute

amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, with annual increases of 1% each January 1st up to a 10%, and their contributions invested in a designated balanced fund until changed by the participant. The Plan provides a safe harbor matching contribution equal to 100% of the first 3% plus 50% of the next 2% of base compensation that a participant contributes to the Plan. The Plan also provides for discretionary profit sharing contributions that can be made by the Company. No discretionary profit sharing contributions were made to the Plan during the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions, Company’s safe harbor matching contributions, Company’s discretionary profit sharing contributions, as well as an allocation of the Plan’s net earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their contributions and company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company’s prior matching contributions and discretionary profit sharing contributions portion of their accounts is based on years of continuous service and are subject to a three year graded vesting schedule. These funds are one-third vested after one year of service, two-thirds vested after two years of service and fully vested after three years of service. A participant’s employer matching contribution transferred from the Integrated Oncology Network 401(k) Plan effective April 15, 2020 are subject to a five year graded vesting schedule. These funds are vested 20 percent after one year of service, 40 percent after two years of service, 60 percent after three years of service, 80 percent after four years of service and fully vested after five years of service.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant’s vested interest in his or her account or paid directly to an eligible retirement plan specified by the participant in a direct rollover. For termination of service due to other reasons, a participant may elect any of the aforementioned options or roll over the account balance into an IRA or new employer’s qualified plan.

**Hardship Withdrawals**

As permitted by the Internal Revenue Code (“IRC”), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant’s balance, whichever is less.

**Notes Receivable from Participants**

Notes receivable from participants are not allowed by the Plan unless they are transferred into the Plan as a result of a merger. Loan balances were transferred into the Plan on May 1, 2021 and

March 1, 2023, as a result from Plan mergers. Notes receivable from participants represents only loan balances transferred as a result of Plan mergers and subsequent payments. The loans are secured by the balance in the participant's account. Principal and interest is paid ratably through monthly payroll deductions. No new loans are allowed by the Plan.

**Plan Termination**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time. The Company has the right at any time, by action of its Board of Directors, to terminate the Plan subject to provisions of ERISA. Upon Plan termination or partial termination, participants will become fully vested in their accounts.

Refer to Subsequent Event Note 10 for additional information regarding events occurring after the reporting period that may affect the Plan.

**Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$83,609 and \$108,366, respectively. These amounts may be used to reduce future employer contributions or to pay Plan administrative expenses. During 2024, \$20,778 of forfeitures were used to pay Plan administrative expenses, and \$101,535 of forfeitures were used to reduce employer contributions related to the match true-up.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Contributions**

Contributions from plan participants, along with the related safe harbor matching and discretionary contributions from the Company, are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Net Appreciation/Depreciation in Fair Value of Investments**

Net realized and unrealized appreciation/depreciation are recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments.

**Investment Valuation and Income Recognition**

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (“NAV”). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for further discussion of fair value measurements, contract value, and NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend rate. Net appreciation or (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Benefit Payments**

Benefits are recorded when paid.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan’s financial statements.

**3. Unaudited Information Certified by the Plan Trustee**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held and notes receivable from participants as of December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was prepared by or derived from information certified by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, the “Trustee”) and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Trustee stating that such information is complete and accurate within the meaning of 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Investment information related to a portion of the self-directed brokerage accounts held at December 31, 2024 and 2023, and the related investment income for the year ended December 31, 2024, was not certified by the Trustee.

#### 4. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2      Inputs to the valuation methodology include

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation

techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each general type of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – The fair values are determined utilizing quoted market prices reported on the active market on which they are traded.

*Collective Investment Trust* – Valued at the net asset value of units of the trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate the fair value of the underlying investments held by the trust, less its liabilities. This practical expedient is not applied when it is probable that the trust will sell the investment for an amount different from the reported NAV. There are no redemption restrictions for participants; the redemption notice period applies only to the Plan. If the Plan initiates a full redemption of the collective investment trust, the trustee may, at its sole discretion, impose a sixty-day redemption notice for any employer-initiated withdrawal of assets. The Plan has no contractual obligation to make additional investments in the collective investment trust. For presentation purposes, the collective investment trust is not classified within the fair value hierarchy but is included in the reconciliation of investments measured at fair value.

*Self-Directed Brokerage* – The fair values of common stock, mutual funds, and exchange-traded funds are determined using quoted market prices from active markets on which the securities are traded. Interest-bearing cash held within the brokerage accounts is valued at its net asset value, typically \$1 per share, based on quoted prices in active markets. All investments held within the self-directed brokerage account are classified as Level 1 under the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Fully Benefit-Responsive Investments at Contract Value**

Effective June 1, 2014, the Plan entered into a traditional fully benefit-responsive investment contract with Massachusetts Mutual Life Insurance Company. In connection with Empower Retirement's acquisition of Massachusetts Mutual Life Insurance Company's retirement plan business, the contract was subsequently transitioned to Empower Annuity Insurance Company of America. As of December 31, 2024 and 2023, the contract balances totaled \$2,082,313 and \$2,455,078, respectively. Empower maintains the contributions in its general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay principal and credit interest at a guaranteed rate established under the terms of the contract. The guaranteed crediting rate for amounts invested in the Guaranteed Interest Account (GIA) is reset every six months and may not be less than 1%. The contract does not permit the insurance company to terminate the agreement prior to its scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendment to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

**6. Tax Status**

The Plan sponsor adopted a non-standardized pre-approved plan document. The IRS has determined and informed the pre-approved plan sponsor, by an opinion letter dated on November 14, 2022, that the pre-approved plan document is designed in accordance with applicable sections of the Code. The Plan has not received a determination letter specific to the Plan itself. The Plan was not in compliance with certain provisions of the Plan document and Code. Plan management intends to take necessary corrective action to maintain the tax qualified status of the Plan; therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effect of a tax position is recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Parties-in-interest Transactions**

The Company, a party-in-interest, provides certain administrative services to the Plan at no charged. The cost of these services constitutes exempt party-in-interest transactions under ERISA. The Plan also maintains arrangements with various service providers, which qualify as party-in-interest transactions.

Certain Plan investments are managed by Empower Trust Company, LLC. Empower Trust Company, LLC and Empower Annuity Insurance Company of America, collectively is the Trustee for the Plan. Empower Retirement, LLC is the record-keeper and third party administrator for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants, along with the related interest income, are also classified as party-in-interest transactions.

**8. Prohibited Transaction**

During 2024 and 2023, the Company erroneously remitted the employees' deferral and loan repayments for several payroll periods to the Plan later than the period prescribed by the Department of Labor regulations. These delinquent remittances are considered nonexempt party-in-interest transactions. Plan management is in the process of correcting these delinquent participant contributions with lost earnings.

**10. Subsequent Events**

Effective January 1, 2025, the Plan was amended to change the Company's safe harbor matching contribution formula. Under the amended formula, the Company matches 200% of each participant's deferral contributions up to 1% of compensation, and 50% of deferral contributions exceeding 1% but not exceeding 5% of compensation.

Effective April 28, 2025, the Plan was amended to remove certain restrictions on the sources available for in-service distributions at age 59 ½.

Following the acquisition of ION Intermediate Holdings, LLC by Cardinal Health, Inc., ION Intermediate Holdings, LLC employees who transitioned to Cardinal Health became eligible to contribute to the Cardinal Health 401(k) Savings Plan (the "Cardinal Plan") effective April 7, 2025. On July 1, 2025, a majority of the Plan assets were transferred to the Cardinal Plan, with
