Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the GWTT 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note to Financial Statements

Note 1. Plan Description

The following description of the GWTT 401(k) Plan (the Plan) provides only general information. Participants should refer to the adoption agreement and basic plan document of the Standard Retirement Services, Inc. Defined Contribution Pre-Approved Plan for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established on January 1, 2014, covering eligible employees of Ground/Water Treatment & Technology, LLC (the Company or the Plan Sponsor). Employees are eligible to participate in the Plan upon the completion of two months of service and attainment of age 21, with the exception of union employees, nonresident aliens and residents of Puerto Rico. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of Internal Revenue Code (IRC) Section 401(k) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan trustee and third-party administrator is Standard Insurance Company (the Trustee or The Standard).

Contributions: Each year, participants may contribute up to a dollar limit, which is set by law, as stated in the IRC. The maximum amount participants were allowed to contribute for the year ended December 31, 2024, was \$23,000. Employees 50 years of age and older are also allowed to contribute an additional \$7,500 to the Plan for 2024. Participants will automatically be enrolled in the Plan on the first of the month following 60 days of employment, with a salary deferral rate of 3%, unless they have chosen to opt out during the 60-day period. The Company makes a discretionary matching contribution of 50% of participants' deferrals for each payroll period up to 6% of the participants' compensation for such period. In addition, the Company may also make employer non elective profit-sharing contributions. An eligible employee must work one year of service and be age 21 or older to receive employer matching and profit-sharing contributions. There were no employer non elective profit sharing contributions made in 2024 and 2023.

Payment of benefits: On termination of service, if a participant's vested balance does not exceed \$5,000, a participant may only elect to receive a lump-sum payment equal to his or her vested amount, reduced by federal income tax withholding. On termination of service, if a participant's vested balance exceeds \$5,000, a participant may elect to receive either a lump-sum payment, installments over a period of not more than the participant's assumed life expectancy, partial withdrawals of at least \$1,000 or may elect to rollover the equity balance.

Participant accounts: Each participant's account is credited with the participant's contributions and an allocation of the Company's contribution and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants' investment options: Participants must direct their salary deferral contributions to selected investments as made available and determined by the Plan Administrator. If a participant does not direct the investment of their applicable plan accounts, then their accounts will be invested in accordance with the default investment alternatives established under the Plan. Participants may change their investment options at any time throughout the year via website access or direct phone access to The Standard.

Vesting: Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. The portion of the participants' accounts attributable to the Company's match and employer non elective profit sharing contributions becomes 20% vested after two years of credited service, as defined, and continues to vest at the rate of 20% for each successive year of service until 100% vested after six years of service.

Note 1. Plan Description (Continued)

Forfeitures: Upon termination of service, any unvested interest of the employer contribution account will be forfeited. Forfeitures, if not used to pay administrative expenses, are used to reduce employer contributions. At December 31, 2024 and 2023, the forfeited nonvested account balances were \$0. For the year ended December 31, 2024, no forfeitures were used to defray employer contributions.

Notes receivable from participants: Participants may borrow from their funded account the lesser of \$50,000 (as adjusted by the Plan document) or up to 50% of their vested account balance. The minimum amount of any loan is \$1,000. Loans are secured by the balance in the participant's account and must be repaid in no more than five years. Participants may only have one loan outstanding at one time. Interest is charged by the Plan at the rate a bank or other professional lender would charge for making a loan in a similar circumstance. Interest rates on notes receivable from participants as of December 31, 2024 and 2023, range from 3.25% to 8.5% and loans mature through 2029.

Note 2. Summary of Significant Accounting Policies

A summary of the Plan's significant accounting policies is as follows:

Basis of accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Investment valuation and income recognition: The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Payment of benefits: Benefits are recorded when paid.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation. Participant contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction in contributions.

Administrative expenses: Recordkeeping, financial services and audit fees are paid through plan assets. Any other plan administrative expenses are paid by the Company.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are treated as distributions based upon the terms of the Plan agreement.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through October 14, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). FASB ASC 820 also provides that fair value may be measured at the net asset value (NAV) provided by the issuer for certain entities that calculate NAV per share.

Such investments recorded at NAV are not classified within this hierarchy. At December 31, 2024 and 2023, all fair value investments held by the Plan were measured at NAV as determined by the issuer based on the fair value of the underlying assets.

Separate Account A is a direct filing entity and is a separate account maintained by The Standard. The Standard owns the assets in Separate Account A and the separate account is not chargeable with liabilities arising out of any business that The Standard may conduct.

Separate Account A is divided into a series of investment funds, which consist of mutual funds and other investments. The investment funds are unitized, tracked and made available through the separate account for participants to self-direct their investment allocations. The participants and the Plan do not own a direct interest in the unitized investment funds. The investment funds' NAVs are used to derive the plan's NAV in Separate Account A. The initial unit value for each investment fund shall be arbitrarily set by The Standard. On a valuation date, which is normally each business day, the investment fund unit value is calculated with adjustments for dividends or capital gain distributions.

Note 5. Investment Contract with Insurance Company

The Plan has a traditional insurance investment contract with The Standard. With traditional investment contracts, the Plan owns only the contract itself and not the underlying assets. The insurance investment contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value was \$1,066,585 and \$1,503,815 as of December 31, 2024 and 2023, respectively.

The Standard maintains the contributions under the investment contract in the insurance company's general account. The insurance investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer and amounted to 1.99% and 1.86% for the year ended December 31, 2024 and 2023, respectively. Such interest rates are reviewed periodically for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Income Tax Status

The Plan is a non-standardized defined contribution pre-approved plan and an opinion letter was received dated June 30, 2020, stating that the Plan is acceptable under Section 401(a) of IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan, as amended, is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax exempt.

The Plan Sponsor's management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that required adjustments to the financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024. Therefore, no provision or liability for income taxes has been included in the financial statements.

Note 8. Related-Party and Party-in-Interest Transactions

The Plan's investments are comprised of a pooled separate account and an insurance investment contract managed by The Standard. Transactions with The Standard qualify as exempt party-in-interest transactions. The Plan issues notes receivable to participants, which are secured by the balances in the participants' accounts, which also constitute exempt party-in-interest transactions.

Note 9. Risks and Uncertainties

The Plan invests in a variety of investment vehicles. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risk factors in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
