### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CBC U 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). #### Note 1. Plan Description

The following brief description of CBC U 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering eligible union employees of CBC Latrobe Acquisition, LLC (the Plan Sponsor and Plan Administrator), IBY, LLC and Blues City Brewery, LLC (collectively, the Employers). The Employers are wholly owned subsidiaries of CBC Acquisition, LLC dba City Brewing Co., LLC. Eligible employees are employees who are members of the IUE Local 22B AFL-CIO (Local 22B), the IUE Local 144B AFL-CIO (Local 144B), the IAMAW District 947 Local 311 (Local 311), the IBEW Local 2295 (Local 2295), the UAW Local 509 (Local 509), the Teamsters Local Union 896 (Local 896) or the Bakery, Confectionary, Tobacco Workers and Grain Millers International Union (AFL-CIO-CLC) Memphis, Tennessee, Local 149 (Local 149) who have met the eligibility requirements and elect to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Sponsor has appointed Fidelity Management Trust Company (Fidelity) as trustee of the Plan. The trustee is responsible for maintaining custody of the Plan's assets, processing contributions and distributions and executing transactions to appropriate investment options.

**Eligibility:** Employees are eligible to participate in the Plan if they have completed one year of service. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service. Excluded employees include leased employees, nonresident aliens and those employees not belonging to Local 22B, Local 144B, Local 311, Local 2295, Local 509, Local 896 or Local 149. Employees may enter the Plan on the first day of the month coinciding with or following the date they satisfy the Plan's eligibility requirements.

**Contributions:** Participants may contribute up to 60% of eligible compensation, as defined in the Plan, up to the maximum allowed by the Internal Revenue Code. Participants elect to defer a percentage of their compensation, and these elections may be changed at any time. Participants are permitted to make pretax elective deferrals to the Plan, or they are permitted to designate a portion of their salary deferrals as Roth after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Employers' contributions are based on the respective union contracts with Local 22B, Local 144B, Local 311, Local 2295, Local 509, Local 896 and Local 149. For 2024, the Employer contributions to the Plan for members of Local 22B and Local 144B was equal to 5% of each participant's eligible compensation each pay period, and matching contributions equal to 100% of the first 1% of eligible compensation that participants elected to contribute to the Plan each pay period as deferral contributions, not including catch-up contributions. For 2024, the Employer contributions to the Plan for members of Local 311, Local 2295, Local 509 and Local 896 was equal to 6% of each participant's base pay rate for all hours worked. For 2024, the Employer contributions for members of Local 149 was a matching contribution equal to 100% of the first 3% of eligible compensation, and 50% of the next 2% of eligible compensation, contributed to the Plan as deferral contributions each pay period by participants, excluding catch-up contributions. The Employers may also contribute other discretionary matching contributions or nonelective contributions to the Plan. No such additional discretionary contributions were made for the year ended December 31, 2024.

#### Note 1. Plan Description (Continued)

**Participant accounts and investment options:** Individual accounts are maintained for each participant of the Plan. Each participant's account is credited or charged with the participant's contributions and the Employers' contributions based on the respective union contracts with Local 22B, Local 144B, Local 311, Local 2295, Local 509, Local 896 and Local 149, as well as allocations of the Employers' discretionary nonelective contributions, if any, Plan investment results and administrative expenses that are paid by the Plan. Allocations are based on eligible participant compensation, participant account balances or specified participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their salary deferral contributions and Employer contributions into various investment options offered by the Plan. Participants may elect to have all or part of their account balances and future contributions transferred from one investment option to another in any combination.

**Vesting:** Participants are vested immediately in their voluntary contributions, including actual investment earnings and losses thereon. Vesting in the Employers' contribution portion of their accounts is based on years of continuous service, as defined in the Plan document. Vesting of a participant's Employer contribution account occurs as set forth based on the following schedule:

Years of Vesting Service	Percentage
Less than 2	0%
2 or more	100%

Participants, who are former participants in the City Brewing Company Salaried 401(k) Plan, fully vest in their Employer contributions after one year of vesting service.

**Forfeited accounts:** Amounts not vested upon termination of employment are forfeited by participants and are used to fund future Employer contributions to the Plan or to pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$33,000 and \$18,000, respectively. No forfeitures were used in the year ended December 31, 2024.

**Payment of benefits:** On termination of service, a participant may elect distribution of the value of the participant's vested account balance under one, or any combination of, the following methods: (1) payment in a lump sum or (2) payment in installments over a period of time. Participant balances that are less than \$7,000 at the time of termination may be paid out in a lump sum without the need for participant consent. Balances between \$1,000 and \$7,000, which are paid out in a lump sum without participant consent, are rolled over into an individual retirement account designated by the Plan Administrator. Voluntary withdrawals of participant account balances while still employed with the Employers are allowed with respect to rollovers, at any time, and for any reason. The Plan also allows for in-service distributions to a participant upon a participant's attainment of age 59½ or under certain circumstances, including financial hardships, as defined.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The Plan's financial statements are presented on the accrual basis of accounting.

**Use of estimates in the preparation of financial statements:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and uncertainties:** Participants are allowed to invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities have occurred since December 31, 2024, or will occur in the near term, and that such changes could materially affect participants' account balances, and the amounts reported in the 2024 statement of net assets available for benefits.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors, trustee and other third parties. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

**Contributions:** Contributions from Plan participants and Employer contributions are recorded in the year related to participants' compensation (even if participants' deferrals are not yet withheld).

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid directly by the Employers and are excluded from these financial statements. Fees related to general administration are charged directly to participants' accounts and are included in administrative expenses. Investment-related expenses reduce total investment results.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through October 13, 2025, the date these financial statements were available to be issued.

#### Note 3. Plan Termination

Although they have not expressed any intent to do so, the Employers have the right under the Plan to change or discontinue their contributions and to terminate the Plan subject to the provisions of ERISA and the union contracts with Local 22B, Local 144B, Local 311, Local 2295, Local 509, Local 896 and Local 149. In the event of Plan termination, participants will become 100% vested in their accounts.

#### Note 4. Information Certified or Provided by Fidelity

The following is a summary of the Plan's investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Fidelity, the trustee. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following investments:

Fidelity also certified to the completeness and accuracy of \$1,542,768 of net appreciation in fair value of investments, and \$627,949 of interest and dividends from the aforementioned investments for the year ended December 31, 2024.

#### Note 5. Fair Value Measurements

Accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Mutual funds and money market mutual fund:** Mutual funds and the money market mutual fund are valued at the unadjusted quoted market prices for identical assets in active markets for the shares of the funds held by the Plan at year-end.

**Collective fund:** The collective fund is valued at the net asset value (NAV) of the shares of the fund held by the Plan at year-end, as reported by the fund's investment managers. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. The practical expedient would not be used if it is determined to be probable that the Plan will sell the fund for an amount different from the reported NAV. The underlying assets of the collective fund include fixed-income securities, corporate bonds, mortgage-backed securities, asset-backed securities, bond funds and money market funds.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain assets could result in a different fair value measurement at the reporting date.

The Plan follows guidance on how entities should estimate fair value of certain alternative investments. The fair value of investments within the scope of this guidance can be determined using NAV per share as a practical expedient, when the fair value is not readily determinable, unless it is probable that the investment will be sold at something other than NAV.

#### Note 6. Tax Status

The Plan has adopted a non-standardized pre-approved plan sponsored by FMR LLC. FMR LLC has received an opinion letter, dated June 30, 2020, from the Internal Revenue Service, as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan. The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain income tax positions that require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7. Related-Party and Party-in-Interest Transactions and Administrative Expenses

The Plan has investments in mutual funds, a money market mutual fund and a collective fund, which are managed by affiliates of Fidelity. Fidelity is the trustee of the Plan's assets. Transactions with the aforementioned trustee qualify as party-in-interest transactions. Certain expenses paid by the Plan to the trustee, as well as other service providers, are included in administrative expenses in the accompanying statement of changes in net assets available for benefits.

Certain administrative functions are performed by employees of the Employers. No such employees receive compensation from the Plan. Certain other administrative expenses are paid directly by the Employers and are excluded from these financial statements.
