To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of NSI 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about NSI 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

1. DESCRIPTION OF THE PLAN

The following description of the NSI 401(k) Plan (the "Plan") is provided for general informational purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a qualified voluntary defined-contribution plan covering essentially all employees of NSI Industries Holdings Inc.; NSI Industries, LLC; and NSI Real Estate, LLC (collectively, the "Company" or "Employer"). These entities are related by common ownership and are collectively considered a single controlled group under the Internal Revenue Code ("IRC") and, therefore, the Plan is a single-employer plan. The Plan was established on January 1, 1994. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 ("ERISA"). Fidelity Management Trust Company ("Trustee" or "Fidelity") is the trustee of the Plan. NSi Holdings, Inc. is the Plan Administrator.

Effective January 1, 2023, Remke Industries, Inc. Employees Savings Plan and Duro Dyne National Corp 401(k) Plan merged into the Plan. The funds deposited from each plan were approximately \$7,600,000 and \$6,200,000, respectively, of which \$95,112 was received in 2024 and is included on the statement of changes in net assets available for benefits as transfers in. Effective October 1, 2023, Sealed Unit Parts Co., Inc. 401(k) Plan merged into the Plan. The funds deposited from Sealed Unit Parts Co., 401(k) Plan were approximately \$7,500,000.

Effective April 2023, the Plan was amended to allow for Roth contributions.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0

Eligibility

All employees, excluding collective bargaining (union), certain nonresident aliens who have no earned income within the United States, and independent contractors of the Company, are eligible to participate in the Plan upon completion of one month of service and the attainment of 21 years of age. Participants meeting these criteria are eligible for participation in the Plan as of the next election date, which is the first day of each calendar month.

Employees who meet the Plan's eligibility requirements will be automatically enrolled with a default contribution rate of 6%.

Contributions

Participants may elect to contribute up to 100% of their pre-tax compensation, as defined in the Plan, up to the maximum limits provided under the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or contributory plans. The Company matches 100% of the first 1% of eligible compensation contributed by participants to the Plan and 50% of the next 5% of eligible compensation contributed to the Plan by participants. This match is subject to safe harbor provisions, meaning that participants are fully vested in all safe harbor matching contributions after two years of eligible service. The Plan allows for profit-sharing contributions. During 2024, there were no profit-sharing contributions made.

Investment options

Participants direct the investment of contributions into various investment options offered by the Plan. Participants may change or transfer their investment options at any time via telephone or the Internet.

Participant accounts

Each participant's account is credited with the participant's contributions, including rollovers, Company safe harbor contributions, an allocation of Employer discretionary contributions, and Plan earnings, and is charged with the benefits paid to participants, Plan losses, and an allocation of administrative expenses. Plan earnings and losses are allocated to the participants' accounts in proportion to the respective account balances within each investment fund. The profit-sharing contribution, if any, is allocated based on a participant's compensation during a respective year. The benefit to which a participant is entitled is the vested value of the participant's account.

Vesting

Participants are immediately vested in their contributions, rollover contributions plus any applicable earnings or losses thereon. The Company safe harbor match has a two year vesting cliff. The following vesting schedule applies to any Employer profit-sharing contributions made by the Company. Participants vest in any Employer profit-sharing contributions and any earnings or losses thereon based on years of service as follows:

Payment of benefits

Upon retirement or termination from employment due to death, disability, or other reason, as defined under the Plan, a participant's entire vested interest in the Plan, including the Company and participant's contributions, is payable in a lump sum, regardless of the number of years of participation. Installment payments are available only if the participant is subject to lifetime required minimum distributions. Participants with a vested account balance greater than \$7,000 may defer payment of benefits until a later date.

Notes receivable from participants

Participants may borrow up to the lesser of 50% of their vested account balance or \$50,000 with a minimum loan amount of \$1,000. The loan repayment terms are for a maximum of five years. Participants may have no more than two loans outstanding from the Plan at one time. Payments, including principal and interest, are made through automatic payroll deductions. The interest rate is based on the prime rate, at the date of loan issuance, set by the Trustee, plus 1%. The principal and interest paid are allocated to the appropriate funds according to the participant's investment election at the time of payment.

Forfeited accounts

The Plan provides that forfeitures of Employer discretionary contributions of terminated participants' nonvested accounts are first used to pay Plan expenses. Any remaining forfeitures reduce the Employer's matching contributions. During the year ended December 31, 2024, no forfeitures were used to offset administrative expenses or employer contributions. At December 31, 2024 and 2023, the forfeiture account amounted to \$276,759 and \$110,504, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Sponsor to make estimates and assumptions that affect certain reported amounts of assets and liabilities therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees related to participant notes receivable are recorded as administrative expenses and are expensed when incurred. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Contributions

Contributions from participants are recorded based on the date the contributions have been separated from the participants' pay by the Company, which is the pay date. The Company's matching and profit-sharing contributions are recorded in the year they are earned and to coincide with the year in which the Company records the contributions in its general ledger. Rollovers are recognized when received by the trustee.

Payment of benefits

Benefits and withdrawals are recognized when paid.

Expenses

Participant's accounts absorb the costs charged for originating participant loans. Other administrative costs are paid by the Plan, as provided by the Plan document, and accounted for in these financial statements. When expenses are paid by the Plan, the amount of the expense is divided pro rata by all participants based on account balances. Additionally, participants pay individually for any specific services they may use. This expense per participant is then allocated to each participant's account.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE - UNAUDITED

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of DOL's and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- All information regarding assets held by the Plan at December 31, 2024, included in the Schedule of Assets (Held at End of Year) - Form 5500, Schedule H, Part IV, Line 4i.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provide by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

5. FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan holds an unallocated insurance contract with Lincoln National Life Insurance Company. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of this investment at December 31, 2024 and 2023, was \$2,482,963 and \$1,376,678, respectively.

The guaranteed investment contract is designed to accrue interest based on a crediting rate established by the contract issuer. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Additionally, certain events might limit the ability of the Plan to transact at contract value with the contract issuer.

Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
- Premature termination of the contract
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the Plan Sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

6. TAX STATUS

On June 30, 2020, the Internal Revenue Service ("IRS") stated that the prototype plan adopted by the Plan, as then designed, qualifies under IRC Section 401. The prototype plan has been amended since receiving the opinion letter. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan provides various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. The Plan made direct payments to the third-party administrator of \$85,895 for the year ended December 31, 2024.

9. PLAN TERMINATION

Although the Company has not expressed any intent to do so, it may terminate the Plan at any time, subject to the provisions of ERISA. If the Plan is terminated, the amounts credited to the participants' accounts would become fully vested and distributed to the participants or their beneficiaries under the terms of the Plan document.

10. CONTRIBUTION REMEDIATION

Plan management has determined that a population of highly compensated employees were improperly restricted from making additional contributions to the Plan based on a payroll processing error. The Plan Sponsor has self-corrected this error including correcting the employer match and lost earnings. The total amount of the correction was approximately \$7,629 and was paid to participants in April 2025.

11. SUBSEQUENT EVENTS

The Plan has evaluated all subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the CPI Employee Retirement Plan merged with the Plan. The funds deposited from this plan were approximately \$11.3 million.
