### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional

omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental schedule H, Part IV, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## 1. Description of the Plan

The following description of The Food Pantry Profit Sharing Investment Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

### a. General

The Plan is a defined contribution plan that covers substantially all non-union employees at Food Pantry, Ltd. (the Company) meeting the Plan's requirement of three months of service, as defined. The Food Pantry, Ltd. Benefits Committee of the Company controls and manages the operation and administration of the Plan. State Street Bank & Trust Company is the Trustee of the Plan and its Recordkeeper is Transamerica Retirement Solutions Corporation (TRSC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### b. Contributions

Participants may make elective deferrals up to the maximum amounts allowed under the Internal Revenue Code (IRC) sections 415 and 402(g). The Board of Directors of the Company may authorize matching contributions each year. For the years ended December 31, 2024 and 2023, the Company matched one-half of each percent contributed by participants, up to the first five percent of compensation. In addition, the Board of Directors may approve discretionary bonus contributions; however, no such bonus contributions were made for the years ended December 31, 2024 and 2023.

Substantially all employees are eligible to participate in the Company's profit-sharing plan and initiate employee deferrals upon completion of three months of service. Employees become eligible for employer matching contributions upon completion of one year of service and 1,000 hours of service.

**1. Description of the Plan (continued)**

**c. Participant Accounts**

Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution and an allocation of the Company’s bonus contribution and the Plan’s earnings. Forfeitures will first be used to restore previously forfeited amounts to participant’s accounts. Any remaining forfeitures will be used first to offset plan expenses and then used to reduce future matching contributions. At December 31, 2024 and 2023, the forfeited nonvested accounts of \$39,638 and \$33,188, respectively, are held in a money market account that is reported under the mutual fund investment. Employer contributions and plan expenses were reduced by approximately \$13,000 from forfeited nonvested accounts in 2024.

**d. Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are fully vested in employer contributions upon normal retirement, death or permanent disability. Otherwise, vesting in the employer contribution account is based on the employee’s years of service as follows:

Less than 1 year	0%
1 but less than 2	33%
2 but less than 3	67%
3 or more	100%

Participants receive credit for a year of vesting service if they complete 1,000 hours of service during each plan year.

### e. Notes Receivable from Participants

Participants may borrow from their accounts in amounts not less than \$1,000 and limited to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the related participant's account and are repaid over a period not to exceed five years, or up to 10 years if used to acquire a primary residence. Principal and interest are paid ratably through payroll deductions. Participant loans bear interest at the prime rate plus two percent (ranging from 5.25 to 10.50 percent at December 31, 2024) and mature on various dates through January 2032.

### f. Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive benefits in the form of a lump sum.

## 2. Summary of Significant Accounting Policies

### a. Basis of Accounting

The accompanying financial statements have been prepared using accounting principles generally accepted in the United States of America (U.S. GAAP).

### b. Management's Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### c. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

## 2. Summary of Significant Accounting Policies (continued)

### d. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Food Pantry, Ltd. Benefits Committee determines the Plan's valuation policies utilizing information provided by investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### e. Payment of Benefits

Benefit payments to participants are recorded upon distribution.

### f. Expenses

Administrative expenses of the Plan are paid by either the Plan or the Plan Sponsor, as provided in the Plan document.

### g. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of participants' account balances and investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

### h. Subsequent Events

The Plan Administrator has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued, and it was determined that all subsequent events have been properly accounted for.

## 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset; and inputs that are derived principally from or can be corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued based on quoted market prices of each fund, which represents the net asset value (NAV) of shares held by the Plan at year end.

*Common collective trust:* Valued based on the NAV per unit. The NAV is used as a practical expedient to estimate fair value.

This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

### 4. Fair Value Measurements (continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Investment with Insurance Company – Group Annuity Contract

The Plan invested in the Transamerica Guaranteed Investment Option (TGIO). The TGIO, which is an investment option under the plan, is provided under a group annuity contract issued by Transamerica Life Insurance Company (TLIC). Such contract is a traditional investment contract (guaranteed investment contract), and it does not have a maturity date. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made, plus interest credited under the terms of the contract, less any withdrawals.

The TGIO is part of the general assets of TLIC. The plan does not own any underlying securities of TLIC's general account. The credit rating of TLIC at December 31, 2024 was A1 as reported by Moody's Investors Service. Subject to the terms of the Plan, participants may elect to withdraw all or a portion of their investments at this contract value. The plan has guaranteed benefits under the terms of the contract.

Interest shall accrue at the initial rate of interest declared by TLIC prior to the Contract Date until a new rate of interest is declared by TLIC. The Declared Rate, as defined, shall not be reduced for a period of at least six months following the most recent Reset Date, as defined, but the Declared Rate may be increased at any time. In no event may the Declared Rate be less than the Minimum Guaranteed Interest Rate, as defined. Interest based on the Declared Rate will accrue to the Contract Balance on a daily basis. At December 31, 2024 and 2023, the guaranteed minimum rate is 2.85 and 2.50 percent, respectively.

Certain events, such as employer initiated events, as defined, and participant elected withdrawals that do not constitute benefit responsive withdrawals, to the extent permitted by the Plan, limit the ability of the Plan to transact at contract value with TLIC. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

### 6. Exempt Party-in-Interest Transactions

All purchases and sales of investments managed by an affiliate of TRSC and State Street Bank & Trust Company are considered exempt party-in-interest transactions. Notes receivable from participants are also considered exempt party-in-interest transactions.

### **7. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of termination, participants would become fully vested in their employer contributions and the assets of the Plan would be allocated among the participants and their beneficiaries.

In 2021 and 2020, the Company downsized its operations, which resulted in a partial plan termination. All participants affected by the partial plan termination became fully vested in their accounts.

### **8. Income Tax Status**

Effective July 1, 2021, the Plan was restated and adopted under TRSC's non-standardized pre-approved plan, which received a favorable tax opinion letter on June 30, 2020 from the IRS.

The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and operated in compliance with the applicable provisions of the Internal Revenue Code ("IRC") and continues to qualify as tax-exempt. Hawaii income tax law conforms to the IRC, therefore, no provision for federal and state income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan years from December 31, 2021 are open for examination for federal tax purposes.
