Opinion

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTE A BASIS OF PRESENTATION AND SIGNIFICANT ACCOUNTING POLICIES

The following brief description of the Boy Scouts of America ("BSA") Employee Welfare Benefits Plan (the "Plan") provides only general information. Participants should refer to the Employee Benefit Handbook for a complete description of the Plan's provisions. As described in the Trust Termination paragraph, BSA terminated the Employee Welfare Benefit Trust (the Trust) through which benefits were paid in 2020. Benefits are now paid through the BSA general assets.

General - The Plan is a welfare plan providing medical, dental, vision, long-term and short-term disability benefits for Boy Scouts of America Local and National Council employees, retirees, survivors and those receiving/pending long-term disability benefits ("LTD beneficiaries"). The Chief Scout Executive is the Plan Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Eligibility and Benefits - Once the eligibility requirements are met, an employee can enroll or waive coverage under each benefit under the Plan. Employees will be eligible for the Plan if employed in a regular position scheduled for at least 30 hours of work per week for the entire year, or if employed in any position and actually worked 30 or more hours per week on average during the preceding stability period.

An employee and/or covered dependents can continue the medical, dental and vision coverage at retirement or survivorship if such retirement or survivorship occurred prior to December 1, 2005. If such event occurred on or after December 1, 2005, the employee must have had at least 10 years of benefit eligible service in order to continue benefits into retirement or for the employee's survivors to be eligible to continue benefits. LTD beneficiaries can continue medical, dental and vision coverage if they are receiving/pending LTD benefits. Effective January 1, 2011, the medical benefit ceased for the retiree and/or covered dependents who are age 65 or over.

Effective January 1, 2023, BSA retirees who were enrolled in a BSA Retiree Medical Plan prior to December 31, 2022 may continue their coverage until reaching age 65. Employees enrolled in a BSA Medical Plan on or after December 31, 2022 will no longer be offered retiree medical coverage upon their retirement. Survivors of employees or retirees whose date of death was on or after January 1, 2023 are eligible for coverage under the BSA Medical Plan.

Medical benefits under the Plan are designed to provide comprehensive coverage for medical and prescription expenses. These benefits are administered by UnitedHealthcare ("UHC").

The Long-Term Disability (LTD) portion of the Plan provides a long-term disability benefit of 60% of base salary after a waiting period of 120 days. An employee must be enrolled in the LTD portion of the Plan and submit a claim for approval to MetLife, who administers these LTD benefits.

The Short-Term Disability (STD) portion of the Plan, effective January 1, 2016, is funded entirely by an insurance policy with Unum Life Insurance Company of America (Unum), whose premiums are paid by after-tax contributions made by employees enrolled in such coverage. The Plan provides a short-term disability benefit of 25% of pre-disability earnings, with a maximum payment period of 17 weeks. An employee must be enrolled in the STD portion of the Plan and submit a claim for approval to Unum, who administers these STD benefits.

NOTE A BASIS OF PRESENTATION AND SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

The dental portion of the Plan provides assistance with covered dental expenses. Dental benefits under the Plan are administered by MetLife. Benefits are limited to a maximum of \$1,500 in any calendar year for each eligible covered person.

The vision care portion of the Plan is fully insured and administered by Vision Service Plan.

Contributions - The Medical, Dental, and Vision components of the Plan require enrolled employees, retirees, survivors, and STD & LTD beneficiaries of the local councils and the National Council to make monthly contributions based upon participant coverage elections. Participants should refer to the Employee Benefit Handbook for a more complete description of coverage information and premiums. For employees, the employer also contributes to any medical and dental coverage. For retirees, survivors, and LTD beneficiaries, the Plan contributes to any medical coverage. For LTD beneficiaries who are National Council employees, the employer continues to make a contribution for any dental coverage.

The sum of the medical and dental contributions is used to pay claims, administrative fees, and other expenses of the applicable benefits under the Plan. The vision contributions are used to pay the premium to Vision Service Plan.

Administration - The Organization, as the Plan Administrator, may, at its discretion, pay the Plan's administrative expenses. Any Plan expenses not paid by the Organization will be paid by the Plan. Substantially all Plan expenses other than administration expenses were paid by the Organization for years ended December 31, 2024 and 2023.

Termination - The Boy Scouts of America expects that the Plan will continue without interruption, but reserves the right to amend or terminate the Plan at any time and for any reason.

Basis of Accounting - The Plan maintained its accounts on the accrual basis of accounting. Consequently, contributions are recognized when earned, and premiums, claims, administrative fees, and other plan expenses are recognized when the obligations are incurred.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, payables for estimated claims incurred but not reported, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties - The present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, healthcare inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Subsequent Events - The Plan has evaluated subsequent events through September 3, 2025, the date the financial statements were available to be issued. No subsequent events occurred, which require adjustment or disclosure to the financial statements at December 31, 2024.

NOTE C TAX STATUS

The Plan Administrator believes the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code and therefore believes that the Plan was qualified and was tax exempt as of the financial statement dates.

The Plan believes that all significant tax positions utilized by the Plan will more likely than not be sustained upon examination. As of December 31, 2024, the tax years that remain subject to examination by the major tax jurisdictions under the statute of limitations are from the year 2021 forward (with limited exceptions). Tax penalties and interest, if any, would be accrued as incurred and would be classified as tax expense in the statement of changes in deficit in net assets available for plan benefits and benefit obligations.
