Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of City Brewing Company Hourly 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule, schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements, or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1. Plan Description

The following brief description of City Brewing Company Hourly 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering eligible union employees of CBC Acquisition, LLC dba City Brewing Co., LLC (the Plan Sponsor and Plan Administrator). Eligible employees are employees who are members of the Teamsters Union Local No. 695 (Local 695) or the International Brotherhood of Electrical Workers Local Union No. 953 (Local 953) who have met the eligibility requirements and elect to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Sponsor has appointed Fidelity Management Trust Company (Fidelity) as trustee of the Plan. The trustee is responsible for maintaining custody of the Plan's assets, processing contributions and distributions and executing transactions to appropriate investment options.

Eligibility: Full-time quality assurance and maintenance employees who are members of Local 695 are eligible to participate in the Plan on the first day of the month after they have completed 60 days of service. Employees who are members of Local 953 are eligible to participate in the Plan on the first day of the month following full-time employment. All other employees, if not specifically excluded, are eligible to participate in the Plan on the first day of the month after they have completed one year of service. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service. Excluded employees include employees not belonging to Local 695 or Local 953.

Contributions: Participants may contribute up to 60% of eligible compensation, as defined in the Plan, up to the maximum allowed by the Internal Revenue Code. Participants elect to defer a percentage of their compensation, and these elections may be changed at any time. Participants are permitted to make pretax elective deferrals to the Plan, or they are permitted to designate a portion of their salary deferrals as Roth after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Plan Sponsor contributions are based on the respective union contracts with Local 695 and Local 953. For 2024, the Plan Sponsor made contributions to the Plan for members of Local 695 equal to 5% of each participant's eligible compensation each pay period and matching contributions equal to 100% of the first 4% of eligible compensation contributed to the Plan as deferral contributions each pay period by participants, excluding catch-up contributions. For 2024, the Plan Sponsor made matching contributions to the Plan for members of Local 953 equal to 100% of the first 4.5% of eligible compensation contributed to the Plan as deferral contributions each pay period by participants, excluding catch-up contributions. The Plan Sponsor may also contribute other discretionary matching contributions or nonelective contributions to the Plan. No such additional discretionary contributions were made for the year ended December 31, 2024.

Participant accounts and investment options: Individual accounts are maintained for each participant of the Plan. Each participant's account is credited or charged with the participant's contributions and the Plan Sponsor's contributions, based on the respective union contracts with Local 695 and Local 953, as well as allocations of Plan Sponsor's discretionary nonelective contributions, if any, Plan investment results and administrative expenses that are paid by the Plan. Allocations are based on eligible participant compensation, participant account balances or specified participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Note 1. Plan Description (Continued)

Participants direct the investment of their salary deferral contributions and Plan Sponsor contributions into various investment options offered by the Plan. Participants may elect to have all or part of their account balances and future contributions transferred from one investment option to another in any combination.

Vesting: Participants are vested immediately in their voluntary contributions and Plan Sponsor contributions, including actual investment earnings and losses thereon.

Payment of benefits: On termination of service, a participant may elect distribution of the value of the participant's account balance under one, or any combination of, the following methods: (1) payment in a lump sum or (2) payment in installments over a period of time. Participant balances that are less than \$7,000 at the time of termination may be paid out in a lump sum without the need for participant consent. Balances between \$1,000 and \$7,000, which are paid out in a lump sum without participant consent, are rolled over into an individual retirement account designated by the Plan Administrator. Voluntary withdrawals of participant account balances while still employed with the Plan Sponsor are allowed with respect to rollovers, at any time, and for any reason. The Plan also allows for in-service distributions to a participant upon a participant's attainment of age 59½, or under certain circumstances, including financial hardships, as defined.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The Plan's financial statements are presented on the accrual basis of accounting.

Use of estimates in the preparation of financial statements: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties: Participants are allowed to invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities have occurred since December 31, 2024, or will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors, trustee and other third parties. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Contributions: Contributions from Plan participants and Plan Sponsor contributions are recorded in the year related to participants' compensation (even if participants' deferrals are not yet withheld).

Payment of benefits: Benefits are recorded when paid.

Note 1. Summary of Significant Accounting Policies (Continued)

Administrative expenses: Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to general administration are charged directly to participants' accounts and are included in administrative expenses. Investment-related expenses reduce total investment results.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 13, 2025, the date these financial statements were available to be issued.

Effective January 1, 2025, full-time employees who are members of Local 695 are eligible to participate in the Plan on the first day of the month after they have completed 120 days of service. Full-time quality assurance and maintenance employees who are members of Local 695 continue to be eligible after completing 60 days of service.

Note 3. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to change or discontinue its contributions and to terminate the Plan subject to the provisions of ERISA and the union contracts with Local 695 and Local 953.

Note 4. Information Certified or Provided by Fidelity

The following is a summary of the Plan's investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Fidelity, the trustee. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following investments:

Note 5. Fair Value Measurements

Accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds and money market mutual fund: Mutual funds and the money market mutual fund are valued at the unadjusted quoted market prices for identical assets in active markets for the shares of the funds held by the Plan at year-end.

Collective fund: The collective fund is valued at the net asset value (NAV) of the shares of the fund held by the Plan at year-end, as reported by the fund's investment managers. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. The practical expedient would not be used if it is determined to be probable that the Plan will sell the fund for an amount different from the reported NAV. The underlying assets of the collective fund include fixed-income securities, corporate bonds, mortgage-backed securities, asset-backed securities, bond funds and money market funds.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain assets could result in a different fair value measurement at the reporting date.

Note 6. Tax Status

The Plan has adopted a non-standardized pre-approved plan sponsored by FMR LLC. FMR LLC has received an opinion letter, dated June 30, 2020, from the Internal Revenue Service, as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan. The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain income tax positions that require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party and Party-in-Interest Transactions and Administrative Expenses

The Plan has investments in mutual funds, a money market mutual fund and a collective fund, which are managed by affiliates of Fidelity. Fidelity is the trustee of the Plan's assets. Transactions with the aforementioned trustee qualify as party-in-interest transactions. Certain expenses paid by the Plan to the trustee, as well as other service providers, are included in administrative expenses in the accompanying statement of changes in net assets available for benefits.

Certain administrative functions are performed by employees of the Plan Sponsor. No such employees receive compensation from the Plan. Certain other administrative expenses are paid directly by the Plan Sponsor and are excluded from these financial statements.
