Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audits of the accompanying financial statements of One 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of One 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTE 1 – DESCRIPTION OF PLAN

The following description of the One 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document, as amended, for a complete description of the Plan's provisions.

General

Realty One Group, Inc. adopted the Plan effective January 1, 2015. The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Realty One Group and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Realty One Group, Inc. (the “Company”) is the Plan’s sponsor and serves as plan administrator.

On March 27, 2020, Congress passed the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”) which included several relief provisions to tax qualified plans and their participants that were put into operation by the Plan at that time. The Plan has adopted certain provisions of the CARES Act. Formal adoption of such provisions of the CARES Act is required to occur on or before December 31, 2025.

Eligibility

Employees of the Company are eligible to participate in the Plan upon reaching age 21 and after completing three months of service during the plan year. The Plan allows employees to begin participating on the first day of the month coinciding with or next following the date the eligibility requirements are met. Participants must complete six months of service and be employed as of the last day of the plan year to be eligible to receive employer profit sharing contributions.

Contributions

The Plan permits eligible participants to contribute up to 100% of compensation, subject to certain Internal Revenue Code limitations (\$23,000 and \$22,500, respectively, for 2024 and 2023, \$30,500 and \$30,000, respectively, for employees over the age of 50 for 2024 and 2023). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants may elect to make Roth contributions utilizing after-tax compensation. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Unless elected otherwise by the participant, deferrals are automatically increased annually by 1%, up to a maximum auto-deferral of 6%.

NOTE 1 – DESCRIPTION OF PLAN, CONTINUED**Contributions, continued**

The Plan provides for discretionary matching and profit-sharing contributions and nonelective employer contributions, which are allocated based on the participant's eligible compensation. Effective January 1, 2022, the Company elected to make discretionary matching contributions equal to 1% of the participant's eligible compensation and the Company also elected to make discretionary profit-sharing contributions equal to 1% of the participant's eligible compensation. Effective November 9, 2023, the Plan made an election to suspend the employer discretionary matching contributions and discretionary profit-sharing contributions. During the year ended December 31, 2024, the Company made employer matching true-up contributions of approximately \$7,967.

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect each participant's contributions and any employer contributions, as well as the participant's share of his investment income or loss, less an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution is based on years of continuous service. Participants are 100% vested in the Company's matching and profit-sharing contribution portion of their accounts after two years of credited service.

Notes Receivable from Participants

Effective May 15, 2019, no new loans will be allowed out of the Plan. Prior to the date, participants may have borrowed from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed ten years. Under the terms of the Plan Agreement, plan loans will bear a rate of interest equal to the U.S. Prime Rate plus 1%. Principal and interest are paid ratably through monthly payroll deductions. As of December 31, 2024, there are no outstanding notes receivable.

Hardship Withdrawals

A withdrawal from a participant's account may be permitted if the participant has a financial hardship as defined in the Plan document.

NOTE 1 – DESCRIPTION OF PLAN, CONTINUED**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount or non-recurring partial payments equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Terminated participants with a vested balance of \$1,000 or less will have their vested balances automatically rolled over into an Individual Retirement Account selected by the plan administrator if the participant does not consent to a distribution of his or her vested account balance. Participants may also elect an in-service distribution after attaining age 59½.

Forfeited Accounts

Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan, may be used in the plan year in which the forfeitures occur or in the subsequent year, and may be used at the discretion of the Company to reduce employer contributions. During the year ended December 31, 2024, \$1,582 from forfeited non-vested accounts were applied to reduce employer contributions. As of December 31, 2024 and 2023, there were forfeitures of \$8,611 and \$2,937, respectively of that have not yet been applied.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**Basis of Accounting**

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 – Fair Value Measurements.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUEDInvestment Valuation and Income Recognition, continued

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at amortized cost which represents the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent participant loans are recorded as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

Effective April 1, 2025, the Plan was amended to allow participant loans.

Payment of Benefits

Benefits are recorded when paid.

Plan Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Date of Management's Review

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value on a recurring basis in the statement of net assets available for benefits in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 – "Fair Value Measurements and Disclosures." This pronouncement defines fair value, establishes a framework for measuring fair value, enhances fair value disclosure requirements and creates a three-level valuation hierarchy for disclosure of fair value measurement. This valuation hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date.

The three levels of the inputs to the valuation methodology are defined as follows:

- Level 1 – Observable, quoted market prices (unadjusted) in active markets for identical assets and liabilities that the reporting entity has the ability to access at the measurement date.
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data. This input level includes those financial instruments that are valued using models or other valuation methodologies where substantially all of the assumptions are observable in the marketplace, can be derived from observable market data, or are supported by observable levels at which transactions are executed in the marketplace.
- Level 3 – Unobservable inputs that are not corroborated by market data. This level of input includes financial instruments whose fair value is estimated based on internally developed models or methodologies utilizing significant inputs that are generally less readily observable from observable sources.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 – EXCESS CONTRIBUTIONS PAYABLE

At December 31, 2024 and 2023, a liability of \$0 and \$56,895, respectively, was recorded for amounts refundable by the Plan to participants for contributions made in excess of amounts allowed by the Internal Revenue Service.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain administrative functions are performed by officers or employees of the Plan sponsor and, therefore, these transactions qualify as party-in-interest transactions. No officer or employee of the Company receives compensation from the Plan. Certain Plan expenses are paid directly by the Plan Sponsor.

Certain administrative functions are performed by the investment broker of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid directly to the investment advisors totaled \$14,651 for the year ended December 31, 2024 and are included in administrative expenses on the statement of changes in net assets available for benefits.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS, CONTINUED

Certain administrative functions are performed by the Plan’s custodian and third-party administrator. Plan expenses include participant loan fees, distribution fees and fund (custodial) fees, which are paid by Plan participants. Fees paid to the custodian and third-party administrator were \$7,564 for the year ended December 31, 2024 and are included in administrative expenses on the statement of changes in net assets available for benefits.

NOTE 7 – TAX STATUS

The IRS has determined and informed the plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTES TO FINANCIAL STATEMENTS

NOTE 10 – PROHIBITED TRANSACTION

During the year ended December 31, 2023, the plan administrator became aware that \$72,455 of participant contributions related to 2023 plan activity had not been forwarded to the plan custodian on a timely basis (see Schedule H, Line 4a). The participant contributions were remitted to the custodian, however, as of October 8, 2025, they have not been corrected for lost earnings.
