


To Whom It May Concern:

The Form 5500 for Plan Year 2024 will be the final filing for the above referenced Plan.

Mission Church Pennsylvania has mistakenly filed a Form 5500 in the past for this Plan. The Plan is a church plan within the meaning of ERISA section 3(33). Mission Church Pennsylvania has never made an election for the Plan to be subject to ERISA and to forego church plan status for Internal Revenue Code purposes, as is permitted by Code section 410(d).

ERISA section 4(b)(2) provides that a "church plan" is exempt from the provisions of Title I of ERISA (including the annual reporting requirements). The IRS has confirmed that church plans that do not make a Code section 410(d) election are not required to file the annual Form 5500. *See* IRS Announcement 82-146, 1982-47 I.R.B. 55.

Since Mission Church Pennsylvania maintains a church plan for which the election under Code section 410(d) has not been made, the Plan Year 2024 Form 5500 is the final filing for the Plan. Effective with Plan Year 2025, which begins January 1, 2025, no further Form 5500s will be filed for the Plan. Please adjust your records accordingly.
