Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Salud Para La Gente 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Salud Para La Gente 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

General

The following description of Salud Para La Gente 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Salud Para La Gente (the "Health Center") for the benefit of its employees. The Plan is available to all employees, excluding employees who are regularly scheduled to work less than 24 hours a week, leased employees, on-call employees and limited-term employees. Other than leased employees, excluded employees become eligible upon completion of a year of service (1,000 hours during an eligibility period) and may enter the Plan on the next entry date.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Newport Trust Company, LLC, serves as the Plan's trustee and Newport Group, Inc., serves as the Plan's recordkeeper (collectively, "Newport"). On April 8, 2022, Newport merged into Ascensus, LLC. During 2023, Newport hired its affiliate Ascensus Trust Company to serve as the Plan's sub-custodian. At the same time, Newport delegated responsibility for servicing the Plan to its affiliate Ascensus, LLC, and the Plan migrated to Ascensus, LLC's recordkeeping platform in June 2023. In connection with the recordkeeping platform migration, there was a brief "blackout period" starting June 21, 2023, which ended during the week of June 26, 2023. During the blackout period, participants were unable to direct or diversify the assets held in their account or obtain distributions or loans until the new recordkeeper had time to accurately complete the migration.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Health Center make pre-tax contributions up to the maximum allowed by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted.

The Health Center may make discretionary employer matching and nonelective profit-sharing contributions, as determined by the Health Center. For the plan years ended December 31, 2024 and 2023, the Health Center made discretionary employer nonelective profit-sharing contributions of 2% of eligible compensation and made no discretionary employer matching contributions.

Contributions are subject to certain limitations.

Participant Investment Account Options

Participants have the option of directing their contributions into any of the investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Health Center's contributions, and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, plus earnings thereon. Vesting in the Health Center's contribution portion of their accounts, plus earnings thereon, is based on years of credited service. Participants hired on or before July 1, 2022, are fully vested after 3 years of credited service. Participants hired after July 1, 2022, are fully vested after 5 years of credited service. If a participant is an active employee on or after attainment of normal retirement age of 65 or the date they terminate due to death, they become fully vested at that time.

Payment of Benefits

Upon termination of service, vested participants with account balances that do not exceed \$5,000 will have their balance directly rolled over to an individual retirement account as designated by the plan administrator, absent an election by the participant. Participants with account balances exceeding \$5,000 may elect to receive a lump-sum distribution equal to their vested value. Effective January 1, 2024, the small balance cash-out threshold was increased from \$5,000 to \$7,000 under the provisions of the SECURE Act 2.0.

Withdrawals for reasons other than terminations are permitted under circumstances provided by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$267, respectively. Forfeitures may be used to pay plan administrative expenses or reduce future employer contributions. During the years ended December 31, 2024 and 2023, forfeitures of \$18,329 and \$19,786, respectively, were used to reduce employer contributions and \$7,411 and \$0, respectively, were used to pay plan administrative expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are covered by demand notes and are repayable over a period not to exceed five years (except loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. The loans are secured by the balance in the participant's account and bear an interest rate of prime rate plus 2%. Starting with new loans issued in November 2019, the maximum number of loans a participant may have outstanding at one time is two.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds, including a money market fund, are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the Health Center are recorded in the year in which the plan compensation is paid and the employee contributions are deducted.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants before March 15, 2025 and distributed the 2023 excess contributions to the applicable participants during 2024. The Plan's 2021 and 2022 excess contribution refunds were paid after December 31, 2022 and 2023, respectively, so the Health Center also contributed qualified nonelective contributions for the non-highly compensated participants during 2024 for the 2021 and 2022 plan years with earnings. The difference between the estimated employer's qualified nonelective contribution receivable as of December 31, 2023, and the amounts ultimately contributed during 2024 resulted in \$59,369 employer qualified nonelective contributions reported during 2024.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Health Center or the Plan, at the Health Center's discretion.

Note 3. Certification of Plan Trustee and Trustee's Agent

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Newport Trust Company, LLC, a qualified institution, and Ascensus, LLC, an agent for Newport Trust Company, LLC, and Ascensus Trust Company, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan paid certain direct custodial, plan administration and recordkeeping fees of \$68,550 and \$58,320 during the years ended December 31, 2024 and 2023, respectively. Certain fees incurred by the Plan for plan consulting services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Health Center directly pays any other fees related to the Plan's operations and provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed an intention to do so, the Health Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, affected participants would become 100% vested in all accounts.

Note 7. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved profit-sharing plan document sponsored by Newport Group, Inc. This pre-approved plan document has been filed with the Internal Revenue Service and has obtained an opinion letter dated June 30, 2020, stating that the form of the Plan is acceptable for use under Internal Revenue Code (IRC) Section 401. Therefore, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions and loan repayments to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Health Center remitted all employee contributions and loan repayments to the Plan, contributions and loan repayments of \$171,973 were not remitted within the required time period during the year ended December 31, 2023, and are pending full correction with lost earnings.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11. Subsequent Events

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.
