INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Ave Maria Home Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Ave Maria Home Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Ave Maria Home Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Ave Maria Home Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note 1 – Description of Plan

The following description of the Ave Maria Home Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan adopted on July 1, 1982, amended and restated on June 1, 2021, covering the employees of Ave Maria Home Retirement Plan (the “Organization” or “Plan Administrator”) who are twenty years of age or older and have completed six months of service, excluding union employees, nonresident alien employees, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Administrator is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings, and monitoring investment performance.

Contributions

Participants may elect to contribute a percentage of their annual pre-tax compensation up to annual limits as prescribed by the Internal Revenue Code and may make rollover contributions. Participants who are at least age 50 may elect to defer additional “catch-up contributions.” The Organization contributes a match up to 100% of the first 2% of compensation that a participant contributes to the Plan as a safe harbor matching contribution.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and Plan earnings (losses) as stated in the Plan Document. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments

Participants may direct contributions in several mutual fund investment options. The Plan offers various mutual fund options. Participants may change their investment options and transfer previously contributed amounts between fund options at any time.

Vesting

Participants are always 100% vested in all contributions plus actual earnings thereon.

Payment of Benefits

Upon termination of service due to termination of employment, death, disability, or retirement, a participant or his or her beneficiary may elect to receive the vested account balance as a lump-sum payment or in partial payments and special distribution rules apply to transferred pension assets. Benefit payments to participants are recorded when paid. Hardship distributions are allowed by the Plan to satisfy certain immediate and heavy financial needs as described by the Plan and result in certain account restrictions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested benefits up to \$50,000. The loans are secured by the balance in the participant’s account and bear interest at a rate determined at the time the loan is made. The term of the loan may not exceed five years unless the loan is for the purchase of the participant’s primary residence, in which case the repayment period will be established by the Plan Administrator at the time of the loan. Loan repayments and related interest are deducted from participant’s paychecks over installment periods.

Forfeited accounts

For years ending December 31, 2024 and 2023, there were no forfeited employer contributions. Forfeiture accounts will be used to pay plan expenses and reduce future employer contributions. After payment of Plan expenses, forfeitures may be reallocated to participants in the same manner as employer contributions.

Note 2 – Summary of Significant Accounting Policies*Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”). Investment income is recognized when earned and administrative fees are recognized when incurred.

Cash and Cash Equivalents

The Plan considers money market funds to be cash and cash equivalents.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements.

Realized and unrealized appreciation (depreciation) in the fair value of investments is based on the difference between the fair value of the assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Plan Expenses

The Plan pays various transaction fees and administrative expenses whereas the Organization pays other basic investment and administrative expenses of the Plan as provided in the Plan document.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Events Occurring after Reporting Date

Management has evaluated subsequent events through October 14, 2025, which was the date the financial statements were available to be issued, for possible recognition of disclosure in the financial statements. Management has determined that there are no material events or transactions that would require recognition or disclosure in the Plan’s financial statements.

Note 3 – Information Prepared and Certified by Custodians

The following is a summary of the information included in the Plan’s financial statements and supplemental schedule for 2024 which was prepared by the trustees of the Plan assets, Mid Atlantic Trust Company and Equitable Financial Life Insurance Company, and furnished to the plan administrator. The plan administrator has obtained a certification from the trustee that such information is complete and accurate.

- A. Investments at the beginning and end of the year.
- B. Changes in net assets resulting from investment activities.
- C. Information included in the supplemental schedule of assets (held at end of year).

Note 4 – Fair Value Measurements

FASB Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement and Disclosures*, provides a common definition of fair value and establishes a framework for measuring fair value. ASC 820 defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market

participants on the measurement date. ASC Topic 820 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value, and describes three levels of inputs that may be used to measure fair value.

- Level 1 - Quoted prices for identical assets in active markets that the entity has the ability to access as of the measurement date
- Level 2 - Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, and other inputs that are observable or can be correlated by observable market data.
- Level 3 - Significant unobservable inputs that reflect a plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued daily at the closing price reported on the active market on which the funds are traded.

Money market funds: Money market funds are classified in Level 1 of the fair value hierarchy as fair value is based on quoted prices in active markets for identical securities

Guaranteed Interest Option: Valued using the method disclosed in the annuity contract. These inputs are generally considered obtainable/ observable through the review of existing contracts and readily obtainable financial information from the issuing financial institution.

Variable investment options: Investments in open-ended mutual funds (such as EQ/T. Rowe Price Growth Stock and Multimanager Aggressive Equity) in AXA Equitable Separate Account are determined by quoted prices in active markets for identical securities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Corrective Distributions

For the year ended December 31, 2023, the Plan required corrective distributions totaling \$15,200 as a result of failing the 401(k) Average Deferral Percentage (ADP) test. The excess deferrals were recharacterized by the Plan's Third-Party Administrator in accordance with IRS regulations. The corrective distributions were completed as of the financial statement date. There were no corrective distributions required for the year ended December 31, 2024.

Note 6 – Tax Status

The Internal Revenue Service has determined that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the Internal Revenue Code. The plan has been amended since receiving the determination letter dated June 30, 2020. However, the Plan Administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be substantiated upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2022.

Note 7 – Plan Termination

Although the Organization has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the plan, all amounts credited to the affected participant's accounts shall become 100% vested. Distributions are to be made as soon as administratively feasible.

Note 8 – Related-Party Transactions and Party-in-Interest Transactions

The Retirement Plan Company, LLC was the third party administrator and Equitable Life Insurance Company was a custodian during the years ended December 31, 2024 and 2023, as defined by the Plan and, therefore, these services qualify as exempt party-in-interest transactions.

For the years ended December 31, 2024 and 2023, administrative fees paid to The Retirement Plan Company, LLC totaled \$19,575 and \$16,351, respectively.

For the years ended December 31, 2024 and 2023, administrative fees paid to Equitable Life Insurance Company, LLC totaled \$147 and \$145, respectively.

Note 9 – Separated Participants

For the years ended December 31, 2024 and 2023, the Plan held balances for participants who have terminated totaling \$1,020,129 and \$760,769, respectively.

Note 10 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
