Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Central Oregon Pediatric Associates 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTES TO FINANCIAL STATEMENTS

1. Plan Description

The following description of Central Oregon Pediatric Associates 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The most recent amended and restated provisions of the Plan became effective January 1, 2022.

General

The Plan was established January 1, 1984, as a defined contribution plan covering all employees of Central Oregon Pediatric Associates, LLP (the Employer), except for union employees, who are excluded as defined by the Plan. Employees who have completed one year of service and are age 21 or older are eligible for matching and profit sharing contributions. Employees who have completed 90 days of service and are age 21 or older are eligible for deferral contributions and Safe Harbor Non-Elective contributions. Entry dates occur on the first of each month for employee deferrals and Safe Harbor and January 1 or July 1 for Employer matching and profit sharing. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute pre-tax and Roth deferrals of compensation up to the limits provided by the Internal Revenue Code (IRC). The Employer makes Safe Harbor contributions in such amounts as may be determined by the Employer each year. The Employer Safe Harbor contribution is equal to 3 percent of eligible compensation. In addition, the Employer may make discretionary profit sharing contributions allocated on an employee by employee basis in amounts determined by the Employer. For December 31, 2024 and 2023, the Employer made a discretionary profit sharing contribution of 2 percent of eligible compensation to non-owner employees and individually determined amounts to physician owners based on a cross-tested formula. For December 31, 2024 and 2023 the Employer did not elect to make a discretionary matching contribution. All contributions are limited to the applicable amounts as prescribed by the IRC. Under the SECURE 2.0 Act, the Plan elected out of providing the minimum top heavy contribution to otherwise excludable employees in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Employer's contributions, (b) the Plan's investment earnings or losses, and (c) certain Plan administration costs not paid by the Employer. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investments of their accounts between several investment alternatives available through the custodian, John Hancock Life Insurance Company. For certain Plan participants, investments may be held and directed by the participant in a self-directed brokerage account.

Vesting and Forfeitures

Participants are immediately vested in their elective deferral and Employer Safe Harbor contributions plus actual earnings thereon. Vesting in the Employer's profit sharing contribution portion of their accounts is based on years of continuous service or rehire status. A participant is 20 percent vested after each year of credited service up to five years. Unvested portions of account balances for participants who leave employment are forfeited.

Vesting and Forfeitures, continued

The Employer may elect to use all or a portion of forfeitures to pay Plan expenses or reduce Employer contributions. Any remaining amounts unused will be applied to restore previous forfeitures to participant accounts.

For the years ended December 31, 2024 and 2023, \$22,938 and \$10,731 respectively, were used to reduce Employer contributions. Available forfeited accounts totaled \$3,379 and \$668 at December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan transactions are treated as a transfer (from) the investment fund from (to) the participant's loan fund. Loan terms range from one to five years or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate at the time of loan issuance plus 1 percent. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of Benefits

On termination of service, death, disability, or attainment of retirement age, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or a direct rollover to an eligible qualified retirement plan or IRA or as an annuity. The Plan allows in-service distributions after a participant has reached normal retirement age, as defined by the Plan. In-service distributions for hardships are also available on account of an immediate and heavy financial need of the participant, subject to the Plan's rules governing hardship withdrawals.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 7 for additional information on fair value measurements.

Purchases or sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Participant contributions are recorded in the year in which they are withheld from compensation. Employer Safe Harbor and profit-sharing contributions are recorded in the year in which the underlying compensation is paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. The loans are secured by the remaining balance in the participant's account and bear interest at the prime rate plus 1 percent. Principal and interest is paid ratably through payroll deductions for a period generally not to exceed five years, unless proceeds are used for purchase of primary residence. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Fees

Expenses of maintaining the Plan are generally paid by the Employer and are therefore excluded from these financial statements. Certain custodial and recordkeeping fees or other related professional fees may be paid from Plan assets. Investment related expenses are included in net change in fair value of investments, other than directly paid management fees, which are reported as investment expenses.

3. Information Certified by Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company, acting as a custodian for a portion of the Plan's assets, has certified that the following information included in the accompanying financial statements and supplemental schedules are complete and accurate as of and for the years ended December 31:

4. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Employer contributions.

5. Tax Status

The Plan has been restated to a prototype plan through execution of an adoption agreement. Pension Planners Northwest, the sponsor of the prototype plan, has received an opinion letter from the IRS dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan provides for various investment options that have different investment strategies. These investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to its fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: A portion of the Plan's investments are units of mutual funds held either within a group annuity contract through John Hancock or in a self-directed brokerage account. These funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan, including those held in self-directed accounts, are deemed to be actively traded and considered to have a readily determinable fair value.

Government, Municipal, and Corporate Bonds: Valued at the market value of the obligation based on quoted market prices.

Common stocks and exchange-traded funds: Valued at fair value as determined by quoted market prices. All common stocks and exchange-traded funds held by the Plan, including those held in self-directed accounts, are traded on active markets.

Corporate debt instruments: Valued at the market value of the obligation. These assets are treated as Level 2 because there is not an active market for them.

Interest-bearing cash: Cash equivalent funds held by the Plan are valued at the contract value of the cash instrument. Because these inputs are not observable, these assets are considered to be valued at Level 2 in the hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. Related Party Transactions

Certain Plan investments are shares of mutual funds held in group annuity contract managed by an affiliate of John Hancock Life Insurance Company, a custodian of the Plan, and therefore these transactions qualify as party in interest transactions. Administration fees paid directly to John Hancock Life Insurance Company for the years ended December 31, 2024 and 2023, totaled \$186 and \$164, respectively. These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Non-exempt Transactions

During the year ended December 31, 2023, it was discovered that participant contributions and loan payments totaling \$5,962 were not remitted to the Plan within the appropriate time period by the Employer. These transactions constitute prohibited transactions as defined by ERISA. The Employer has taken the appropriate steps to correct the situation by reimbursing employees for lost earnings and interest and has further implemented a procedure to ensure that all future remittances are made within the prescribed time period. Fully corrected as of and for the year ended December 31, 2023 were \$1,000 of these late remittances, while the remaining \$4,962 were fully corrected during 2024.

10. Subsequent Events

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.

In July 2025, the Plan transitioned to Empower, the new custodian of the Plan.
