### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Independent Southern Bancshares, Inc. Amended and Restated Profit Sharing and 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1 – PLAN ADMINISTRATION AND DESCRIPTION**

The following brief description of the Independent Southern Bancshares, Inc. Amended and Restated Profit Sharing 401k(k) Plan is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

**A. General**

The Plan was established by Independent Southern Bancshares, Inc. (the “Company” or “Sponsor”) effective January 1, 1971 and was amended and restated as of January 1, 2012 because of the merger of the Employee Stock Ownership Plan (ESOP) and the Plan. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan sponsor is the Company.

The Plan Sponsor is responsible for administering the Plan and may appoint an administrative committee to act as its agent in administering the Plan. The Company’s Employee Benefits Committee meets quarterly to discuss employee benefits, including the Plan. The Plan’s assets were held and invested by Voya Retirement Insurance and Annuity Company (VRIAC) or InSouth Bank Trust Department, the custodians of the Plan, in 2024 and 2023. The custodians have the authority to hold, invest and distribute the assets of the fund in accordance with the terms and provisions of the Plan. Contributions are invested at the participants’ direction in one or more investment funds.

The Plan is available to all employees of the Company having completed 60 days of service and having attained the age of 18. Participation may be elected by the employee on a quarterly entry basis after the eligibility requirements are met.

**B. Contributions**

Each participant may contribute up to the maximum percentage allowed by the IRS for the plan year (January 1 to December 31). The Company determines the percentage it will match at the end of each Plan year. The employer matching contribution was 100 percent of the participant’s contribution up to 6 percent of eligible compensation for 2024 and 2023. To receive the matching contribution, participants must be employed at the end of the Plan year and have worked 1,000 or more hours during the Plan year.

The Company is also permitted to make discretionary profit-sharing contributions to the Plan as approved by the Board of Directors. This discretionary amount shall be allocated according to the ratio that each eligible active participant’s compensation bears to the total compensation paid to all eligible active participants for the Plan year. The Company made no discretionary contribution for the Plan years ended December 31, 2024 and 2023.

Participants are eligible to make Roth contributions effective July 1, 2024. The Plan also permits in-plan Roth conversions.

**C. Participants’ Accounts**

Each participant account is credited with the participant’s contribution and allocation of the Company’s contribution, plan earnings and forfeitures of terminated participants’ non-vested accounts. Allocations are based on participant compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

**D. Voting Rights**

Generally, the custodian of the Company stock, as directed by the Company, votes all of the stock held in the Plan. However, each participant will be asked to direct the custodian on how to vote the shares credited to his or her account in the event of a corporate merger, consolidation, reorganization, recapitalization, liquidation, sale of substantially all the assets of the Company or similar transaction.

**E. Vesting**

Participants are vested immediately in their contributions plus actual earnings on them. Vesting in the Sponsor-contributions portion of their accounts plus earnings is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

**F. Notes Receivable from Participants**

Participants may borrow up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. Terms are generally for five years or less. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are normally paid by payroll deductions. Interest rates on borrowings outstanding as of December 31, 2024 were between 3.25-8.50 percent.

**G. Payments of Benefits**

Upon termination of service due to death, disability, retirement or other reasons, a participant (or the participant's beneficiary, if applicable) may elect to receive benefits in the form of a lump-sum distribution, installment payments or part lump-sum and part installment payments, if the vested account balance is greater than \$1,000. For vested account balances less than \$1,000, a lump-sum distribution will be made to the participant equal to the value of his or her account. For account balances of \$1,001 to \$5,000 an IRA will be created for the participant and the balance rolled into that IRA.

For participants of the Plan that are invested in Company stock, distributions are made in full shares of Company common stock or, if the participant elects, in the form of cash. Any fractional shares are paid in cash.

**H. Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$15,934 and \$5,912, respectively. Forfeitures of non-vested employer discretionary profit-sharing contributions are allocated to participants based on compensation. Forfeitures attributable to matching contributions will be used to reduce any matching contributions made by the employer. Forfeitures used were \$0 and \$9,499 for the years ended December 31, 2024 and 2023 respectively.

**I. Put Option**

Under Federal income tax regulations, the Company stock held by the Plan includes a put option because it is not traded on an established market. The put option provides participants with the right to demand that the Company buy shares of Company stock distributed to them upon termination, at estimated fair value based upon independent appraisal.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**C. Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully-benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**D. Contributions**

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

**E. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**F. Payment of Benefits**

Benefits are recorded when paid.

**G. Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation (depreciation) of the fair value of investments.

**H. Subsequent Events**

The Plan has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Life Insurance and Annuity Company, a qualified institution.

The employer stock is not included in the plan assets covered by the certification.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Pooled separate accounts:* Measured using their accumulation unit value ("AUV"). These are valued daily as the number of accumulation units held multiplied by the AUV. The AUV is determined daily based on the net asset value of shares of the underlying fund, the fund's dividends, and the contract's separate account charges.

*Fixed account:* Valued at the approximate amount that would have been paid if the contract had been terminated as of December 31, 2024 and 2023 and potential surrender charges and market value adjustments were applied as of such date.

*Employer stock:* Valued at fair value as determined by annual independent appraisals using the Guideline Company Transactions Method and the Guideline Public Company Method under the market approach.

**NOTE 5 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Voya Retirement Life Insurance and Annuity Company (VRIAC) and InSouth Bank Trust Department (custodians) for the Plan, and therefore, those transactions qualify as party in interest transactions.

Administrative services to the plan provided by VRIAC (recordkeeper) included in the statements of changes of net assets are \$9,237 and \$7,384 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE 7 – TAX STATUS**

The Employer has adopted the Wyatt, Tarrant & Combs, LLP Defined Contribution Volume Plan and has elected to rely upon their opinion letter dated June 30, 2020. Although the Plan has been amended since receiving this opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
