Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of KoMiCo Technology, Inc. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 – PLAN DESCRIPTION

The following description of the KoMiCo Technology, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

General

The Plan is a defined contribution plan which was established on February 1, 2007 and most recently amended on January 1, 2023. The Plan is sponsored by KoMiCo Technology, Inc. (the Company). Generally, employees of the Company who have reached the age of 21 and have completed three months of service are eligible to participate in the Plan. Employees may enter the Plan immediately upon satisfying such requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan is administered by the Company. Among other duties, it is the responsibility of the administrator to interpret the Plan, decide on questions of eligibility, determine the amount and manner of benefit payments and maintain administrative records of the Plan. All Plan assets as of and for the years ended December 31, 2024 and 2023 were held by Principal Life Insurance Company (Principal).

Trustee

The trustee of the Plan is the Company. The primary duties of the trustee are to authorize investments and monitor payment of contributions and benefits as directed by the Plan administrator.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's contribution, when applicable, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Contributions

Participants – The Plan permits each participant, at the participant's option, to elect to contribute a dollar amount or a percentage of annual pre-tax compensation as a basic contribution or after-tax compensation as a Roth contribution, not to exceed the Internal Revenue Service (IRS) limitations. For the year ended December 31, 2024, the maximum salary deferral permissible under IRS limitations was \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various common/collective trusts and pooled separate accounts as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of pretax compensation and will increase by 1 percent each year up to 10 percent. Participants are vested immediately in their contributions plus actual earnings thereon.

Employer – The Company makes safe harbor matching contributions equal to 100 percent of the participant’s annual contribution up to the first 4 percent of the participant’s eligible annual compensation, and then 50 percent of the participant’s annual contribution up to the next 2 percent of the participant’s eligible annual compensation. Safe harbor matching contributions are fully-vested after 2 years.

The Company may also make discretionary matching and nonelective contributions. No matching or nonelective contributions were made during the year ended December 31, 2024. In order for a participant to share in employer contributions, the participant must have completed one year of service. Total contributions for each participant are subject to certain IRS limitations. Discretionary matching and nonelective contributions vest according to the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates at the time of borrowing, as determined by the Plan administrator. Principal and interest are paid ratably through semi-monthly payroll deductions.

Payment of Benefits

Participants may receive distributions from their accounts upon attainment of age 59½, retirement as a result of disability, incurrence of a financial hardship (as defined), termination of their employment with the Company, death, or termination of the Plan. The participant may elect to receive a lump-sum amount equal to the vested value of the participant’s account balance or the participant’s vested balance paid out in installments. For eligible participants receiving a required minimum distribution, the vested balance will be paid out in installments over a period not to exceed the participant’s assumed life expectancy.

Forfeitures

Forfeitures are created when a participant terminates employment before becoming entitled to 100 percent of the amounts derived from the Company’s contributions. Amounts forfeited are used to fund administrative expenses or future Company contributions. During the year ended December 31, 2024, \$27,338 in forfeited amounts were utilized to reduce employer contributions or pay Plan administrative expenses. As of December 31, 2024 and 2023, there were \$0 and \$27,506, respectively, in forfeited amounts available for future utilization by the Plan.

Plan Termination

Although the Company has not expressed any intent to discontinue the Plan, the Company may do so at any time subject to provisions of ERISA. In the event of termination, participants will become fully vested in their Company contributions, and assets of the Plan will be allocated to all participants and distributed in lump sum payments.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully-benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan does not have any fully-benefit responsive investments.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, as determined by Principal. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net increase in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Plan investments are subject to certain investment fees based on a percentage of invested assets. Such fees are included within the net increase in fair value of underlying investments in the accompanying statement of changes in net assets available for benefits. Fees incurred for the administration of the Plan and participant requested services are reflected as administrative expenses on the accompanying statement of changes in net assets available for benefits. The Plan pays the majority of its administrative expenses.

Use of Estimates

The preparation of financial statements requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

Plan management has evaluated subsequent events through the date of the auditors' report, October 13, 2025, which is the date the accompanying financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under the Financial Accounting Standards Board's *Accounting Standards Codification (ASC) 820* are described as follows:

- a. Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- b. Level 2 Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- c. Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for investments measured at fair value at December 31, 2024 and 2023. There were no changes in the methodologies used at December 31, 2024 and 2023.

Common/collective trusts: Valued at the net asset value (NAV) of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner.

Pooled separate accounts: Valued at the NAV of units of pooled separate accounts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sold) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with *ASC 820*, investments utilizing NAV as a practical expedient to estimate fair value are not required to be classified in the fair value hierarchy.

The following table summarizes investments for which fair value is measured using the NAV per share as a practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

NOTE 4 – TRUST CERTIFICATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivables from participants held at December 31, 2024 and 2023, net increase in fair values and interest income from investments, and interest from notes receivables from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in the net increase in fair value of the respective investments on the accompanying statement of changes in net assets available for benefits.

During the year ended December 31, 2024, the Plan paid fees of \$26,148 to Principal for administration services, which have been included within administrative expenses on the accompanying statement of changes in net assets available for benefits.

NOTE 6 – TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified and the related trust is tax-exempt.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
