## Notes to Financial Statements

December 31, 2024 and 2023

### Note 1 - Plan Description

The following description of Scioto County Counseling Center 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of Scioto County Counseling Center, Inc. (the "Company"). There is no minimum age or service requirement to enroll in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan has an effective date of July 1, 2022, which is when assets were transferred into the Plan from the previous Compass Community Health Plan.

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 85 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 85 percent of their compensation on an after-tax basis (Roth deferrals). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2023 and 2022 were paid after the time frame required by the Department of Labor. The Company remitted these contributions during 2023 and 2022 and expects to remit related lost earnings to the Plan in 2025.

In addition, certain participant contributions in 2022 and 2021, while the employees were participating in the Compass Community Health Plan, were paid after the time frame required by the Department of Labor. The Company expects to remit lost earnings related to those delinquent contributions to this plan in 2025.

The Plan provides for employer safe harbor matching contributions equal to 100 percent of the amount of the elective deferrals that do not exceed 3 percent of participant's compensation and 50 percent of the amount of the elective deferrals that exceed 3 percent but do not exceed 5 percent of participant's compensation.

The Company may make annual discretionary contributions. Participants who continue employment through the end of the plan year will be eligible to receive an allocation of the company discretionary contribution. There were no discretionary contributions for the year ended December 31, 2024.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

**Note 1 - Plan Description (Continued)**

***Vesting***

Participants are immediately 100 percent vested in employee salary contributions, rollover contributions, and employer safe harbor matching contributions and any income or loss thereon. Vesting in the Company's discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in discretionary contributions made by the Company 20 percent after two years of service and another 20 percent per year thereafter until they become fully vested after six years of service.

***Benefit Payments***

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$112,447 and \$102,411, respectively.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Empower Trust Company, LLC; Empower Annuity Insurance Company of America; or their affiliates (collectively, Empower). Empower is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive investment contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. All other investments are valued based on quoted market prices reported in active markets. See Note 6 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Cash***

The Plan considers all investments with a maturity of three months or less to be cash. Cash is recorded based on the outstanding balance and is non-interest bearing.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 9, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Effective January 1, 2024, the Plan changed its trustee from Reliance Trust Company to Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, the "Trustee"). The Trustee of the Plan held the Plan's investments and executed all investment transactions during the periods under audit. The investment balances and related investment results included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee. Effective January 1, 2024, participant notes receivable and related income and losses are also certified by Empower Trust Company, LLC.

**Note 4 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 5 - Liquidation of Assets in Preparation for Change in Custodian**

Effective December 29, 2023, the Plan liquidated its assets in the process of transferring funds to a new custodian, Empower Trust Company, LLC. The subsequent transfer of assets did not occur until January 2, 2024. As such, the investment accounts are cash as of December 31, 2023.

### Note 6 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following table presents information about the Plan's assets measured at fair value on a recurring basis at December 31, 2024. At December 31, 2023, all assets were held in cash.

There were no unfunded commitments or redemption restrictions on the investments described above.

### Note 7 - Investment Contract

The Plan has a benefit-responsive investment contract with Empower Annuity Insurance Company of America (EAICA). EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 0 percent. When establishing interest crediting rates for this product, EAICA considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and which require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.
