We have performed audits of the financial statements of Coats, Rose, Yale, Ryman and Lee, P.C. NOTE 1 - DESCRIPTION OF PLAN

The Coats, Rose, Yale, Ryman and Lee, P.C. Salary Deferral and Profit-Sharing Plan and Trust (the Plan) is a qualified retirement plan adopted by Coats Rose, P.C. (the Company) effective January 1, 1990, to enable eligible employees to save for retirement. The plan was amended August 1, 2024. Baldwin Title is a participating employer in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The summary of significant provisions of the Plan presented below provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility: With the exception of residents of Puerto Rico, leased employees, and independent contractors, participation in the Plan is available to all employees who have completed six months of service. Employees satisfying the service requirement may enter into the Plan the first day of each month.

Contributions: Participants may elect to defer a percentage or a flat dollar amount of their eligible compensation into the Plan. Participant contributions are subject to an annual limit of the lesser of 60% of eligible compensation or an annual dollar limit set by law. Participants may increase, decrease, suspend, or resume their contributions at any time. Participants who are projected to be age 50 or older by the end of the taxable year may also make additional catch-up contributions into the Plan.

The Company may make matching contributions and discretionary nonelective contributions to the Plan. Employer contributions are determined annually by the Company. For 2024, the Company made matching contributions and discretionary nonelective contributions of \$1,286,250 to various groups of eligible employees.

Participants can also roll over part or all of an eligible rollover distribution they received from an eligible retirement plan into this Plan as a rollover contribution.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions (b) Plan earnings and losses, and (c) forfeitures of discretionary contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Investment Options: Participants direct the investment of their entire interest in the Plan into various investment options offered by the Plan. The Plan currently offers various mutual funds, a money market fund, and a self-direct brokerage program as investment options for participants.

Notes Receivable From Participants: Participants may apply for a loan by contacting the trustee and accessing their account online. Loans will be allowed for any purpose. The minimum loan is \$1,000 and the maximum amount is the lesser of one-half of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve-month period. The loans are secured by the participants' vested account balance. All loans bear a reasonable rate of interest and are repaid in level payments through after-tax payroll deductions over a five-year period unless it was for the purchase of a principal residence. A participant may have only 2 outstanding loans at any given time.

Payment of Benefits: Distributions can be made to participants due to death, disability, retirement, or termination of employment from the Company. If the vested account balance is \$5,000 or less, the Company will direct the trustee that any amount exceeding \$1,000 be distributed to an IRA for the participant's benefit. If the vested account balance is \$1,000 or less, the Company will direct the trustee to distribute it to the participant as a lump sum distribution. Prior to such distributions, participants have the right to request the amounts be distributed directly to themselves in the form of a lump sum payment or to request that it be rolled directly to a different IRA provider or another retirement plan eligible to receive rollover contributions. A participant's consent will be required for any distribution in which the vested account balance is greater than \$5,000.

Participants are entitled to receive an in-service distribution from all or a portion of their vested accounts upon reaching age of 59½. Hardship withdrawals may be made to satisfy specific and heavy financial needs. Participants must first exhaust all other assets reasonably available to them prior to obtaining a hardship withdrawal.

Plan Termination: The Company has no legal or contractual obligation to make annual contributions to or to continue the Plan. The Company reserves the right to terminate the Plan at any time. In the event the Plan should terminate, each participant affected by such termination shall have a vested interest in their account of 100%. The Company will facilitate the distribution of account balances in single lump sum payments to each participant in accordance with plan provisions until all assets have been distributed by the trustee.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Vesting: Participants are always 100% vested in their contributions, employer matching contributions, rollovers, and actual plan earnings thereon. Vesting in employer nonelective contributions and plan earnings thereon are subject to the following schedule:

Forfeited Accounts: Participants forfeit the non-vested portion of their employer account when they terminate employment with the Company. Forfeitures are retained in the Plan and may be used to pay administrative expenses and to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$17,950, respectively. During 2024, employer contributions were reduced by \$0 from forfeited non-vested accounts.

Subsequent Events: The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures, and actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. See Note 3 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis.

Notes Receivable From Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- *Level 1* – Quoted prices (adjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- *Level 2* – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- *Level 3* – Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1 inputs).

Money Market Fund: Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the SEC. This fund is required to publish its daily NAV, and to transact at that price. The money market fund is deemed to be actively traded.

Self-Directed Brokerage Account: The underlying investments, which consist primarily of interest-bearing cash accounts, individual corporate common stocks, and mutual funds, are valued at the closing price reported on the open market and are classified within level 1 of the valuation hierarchy.

NOTE 5 - PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain investments managed by the trustee and notes receivable from participants reflect party-in-interest transactions.

NOTE 6 - TAX STATUS

The Company adopted a non-standardized pre-approved profit-sharing plan with CODA sponsored by FMR LLC. The non-standardized pre-approved profit-sharing plan with CODA obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the form of the non-standardized pre-approved profit-sharing plan with CODA was acceptable under section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
