### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Vista Hill Foundation Money Purchase Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Vista Hill Foundation Money Purchase Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for, the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**Note 1 - Description of Plan:**

The following brief description of Vista Hill Foundation Money Purchase Pension Plan (the “Plan”) is provided for general information purposes only. For additional information concerning the Plan’s provisions, participants should refer to the Plan Agreement and Summary Plan Description.

**General**

The Plan is a defined contribution plan covering all employees of Vista Hill Foundation (the “Foundation” and “Employer”) who have reached age 18 and completed 250 hours of service. The Foundation adopted the Plan on January 1, 1968. The Plan was restated on November 2, 2021.

Excluded employees include those covered under a collective bargaining agreement, leased employees, and reclassified employees as defined by the Plan. An eligible employee becomes a participant effective as of the first day of the Plan Year quarter following the date in which the employee meets the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Foundation serves as the Plan Administrator. The Foundation appointed Empower Annuity Insurance Company of America (formerly known as ‘Great-West Life & Annuity Insurance Company’ prior to August 1, 2022) and Empower Trust Company, LLC (formerly known as ‘Great-West Trust Company, LLC’) (collectively the “Custodian”) to hold and invest Plan assets and execute Plan transactions.

**Contributions**

The Foundation contributes an amount equal to 6% of each participant’s annual compensation plus 5.7% of each participant’s annual compensation in excess of the Social Security Taxable Wage Base. Participants may contribute amounts representing distributions from other qualified plans. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant’s account is credited with the Foundation’s contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are made in a manner which recognizes each participant’s account balance, investment selection, and timing of contributions and withdrawals. Participants may direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

The Plan currently offers a variety of mutual funds, pooled income accounts and guaranteed interest accounts (“GIA”).

**Forfeitures**

Forfeitures are used to pay Plan administrative expenses or reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$512,707 and \$44,703, respectively. During 2024 forfeitures of \$35,929 were used to reduce employer contributions and pay Plan expenses.

**Note 1 - Description of Plan: (Continued)**

**Vesting**

Vesting in the employer contributions is based on years of service. Participants must work 250 hours during a Plan year to be credited with a year of service. A participant is 100% vested in the Foundation matching portion of their accounts after six years of credited service, as follows:

Years of Service (As Defined)	Percentage Vested
Less than 2 years	0%
2 but less than 3 years	20%
3 but less than 4 years	40%
4 but less than 5 years	60%
5 but less than 6 years	80%
6 or more years	100%

Regardless of the vesting schedule, a participant will become fully vested upon attainment of normal retirement age while an employee or upon disability, death, or termination of the Plan. Any amount not vested upon a participant's separation from service is forfeited.

**Notes Receivable from Participants**

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less, subject to certain restrictions, in accordance with borrowing procedures established by the Foundation. The repayment terms provide for loan payments to be made through payroll deductions and for loans to be amortized over a reasonable period not to exceed five years, unless for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with rates charged by commercial lenders for loans made under similar circumstances. The interest rates were 4.25% to 9.50%, for the years ended December 31, 2024 and 2023.

**Payment of Benefits**

Upon termination of service due to any reason, for vested account balances that do not exceed \$5,000, the participant may only receive a single lump-sum payment equal to the value of the participant's vested interest in his or her account. For vested account balances that exceed \$5,000, upon termination of service due to death, the beneficiary may elect to receive a lump-sum amount or annual installments at least equal to the required minimum distribution amount. For vested account balances that exceed \$5,000, on termination of service for any reason other than death, a participant may elect to receive a lump-sum amount, installments over a period of not more than the participant's assumed life expectancy, or an alternative annuity. Participants with vested benefits of greater than \$5,000 may elect to delay their distributions, but distributions are required to begin no later than April 1st following the end of the year in which the Participant reaches age 73.

**Note 2 - Significant Accounting Policies:**

**Accounting Method**

The financial statements of the Plan have been prepared on the accrual basis of accounting which is in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). Employee and Employer contributions are recognized in the period that contributions are due.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Fair Value Measurements**

Fair value accounting standards define fair value, establish a framework for measuring fair value, outline a fair value hierarchy based on inputs used to measure fair value, and enhance disclosure requirements for fair value measurements. The fair value hierarchy distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity (observable inputs that are classified within Level 1 or 2 of the hierarchy) and the reporting entity's own assumptions about market participant assumptions (unobservable inputs classified within Level 3 of the hierarchy).

- Level 1 inputs are quoted prices in active markets for identical investments that the Plan has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the investment, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the investment.

The Plan's statements of net assets available for benefits includes the following financial instruments that are required to be measured at fair value on a recurring basis:

- Investments in mutual funds are considered Level 1 assets, and are reported at fair value based on quoted net asset values of the shares held by the Plan at year-end.
- Pooled separate accounts ("PSA") represent units held in pooled separate accounts that are valued using the net asset value ("NAV") of the fund. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a PSA is calculated based on a compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund.

**Note 2 - Significant Accounting Policies: (Continued)**

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants**

Participant loans are reported at their unpaid principal balances plus any accrued and unpaid interest.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Expenses of the Plan, including legal, audit, administrative, and trustee expenses, are generally paid by the Foundation, with the exception of certain administrative expenses which are paid for by the Plan and charged to participants' accounts. The Plan incurred \$40,775 of administrative expenses for the year ended December 31, 2024.

**Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

**Note 4 - Information Prepared and Certified by the Custodian:**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to the Plan's investments disclosed in the accompanying financial statements, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividend income, and notes receivable for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, collectively the Custodian of the Plan.

**Note 5 - Guaranteed Interest Contract:**

The Empower Guaranteed Fixed and Interest Funds are fully benefit-responsive investment contracts (the Contracts) with Empower Annuity Insurance Company of America (“Empower”). Empower maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the Contracts plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract values of the contracts at December 31 are listed below:

The crediting rate is based on a formula established by the contract issuer, but may not be less than 0 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes, or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; (4) a material amendment to the agreement without the consent of the issuer.

**Note 6 - Party-In-Interest Transaction:**

Certain Plan investments include pooled separate accounts and guaranteed investment contracts managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. Additionally, Canterbury Consulting provides investment advisory services to the Plan. Transactions with these entities qualify as party-in-interest transactions and are exempt from the prohibited transaction rules under ERISA.

**Note 7 - Plan Termination:**

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 8 - Tax Status:**

The Internal Revenue Service has determined and informed the Plan's volume submitter sponsor by an opinion letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA sponsored by Empower Trust Company, LLC, which has been adopted by the Plan, is acceptable pursuant to section 401 of the Internal Revenue Code (IRC) and in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the Internal Revenue Service. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan believes that it has appropriate support for any tax position taken, and, as such, does not have any uncertain tax positions that are material to the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.
