Pacific Offshore Labor Company Retirement Plan**

The Pacific Offshore Labor Company Retirement Plan had started the plan termination process several years ago; however, the process is not complete due to a number of outstanding checks. For the 2019 to 2023 Forms 5500, there were discrepancies with what was reported to the Form 5500 preparer from the recordkeeper on the amount of the outstanding checks. This was mainly due to many of the outstanding checks being reissued as wires instead of checks once the missing participant was located. As we were auditing the current list of outstanding checks, the discrepancies were discovered between the outstanding amount and what was included on the recordkeeper’s Form 5500 reports. Below is a summary of the results of the audit:

We have adjusted these amounts on the 2024 Form 5500 to be correct going forward until we locate the remaining outstanding checks.
