NOTE A - DESCRIPTION OF PLAN

The following description of the Riley Spence Management Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions. The Plan was approved and adopted effective April 1, 2010.

General - The Plan is a defined contribution plan covering all employees of Riley Spence Management Company, LLC (the "Company"). To be eligible for salary reduction contributions, matching and discretionary profit-sharing contributions, an employee must be a non-union employee age twenty-one or older, completed six consecutive months and 500 hours of service.

Upon reaching the eligibility requirements, employees can begin to participate on the first day of the month coinciding with or following the date the eligibility requirements are satisfied.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants may contribute a portion of their compensation as a pre-tax deferral, not to exceed maximum amounts as defined in the Plan and as stated in the Internal Revenue Service Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless affirmatively elect not to participate, with a default rate set at 2% of eligible compensation.

The Company, at its discretion, may contribute a match to the elective deferrals in the amount equal to that of contributing participant's percentage or a discretionary amount of profit-sharing contribution. Any company contribution is invested with pro rata formula that is allocated to the individuals' accounts in the ratio that each qualifying participant's compensation for the plan year bears to the total compensation of all qualifying participant's compensation for the plan year. For the year ended December 31, 2024, the Company made no discretionary contributions.

Contributions are subject to certain statutory limitations.

Participants' Accounts - Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is based on the participant's vested account balance.

The contributions to the Plan, both employee and employer, are allocated to various funds at the direction of the participant. The Plan currently offers various registered investment companies (i.e., mutual funds) as investment options for participants. Participants should refer to each fund's prospectus for a description of the fund's investment objectives.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions plus earnings is based on years of continuous service.

Forfeited Accounts - The non-vested balance of a participant's account is forfeited upon termination of service. The Company may use forfeitures to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. For the years ended December 31, 2024 and 2023, no forfeitures were used to reduce employer contributions. The Plan had unused forfeitures totaling \$12,205 and \$11,039 at the end of December 31, 2024 and 2023, respectively.

Benefits Paid to Participants - On termination of service, death, disability, retirement, or severance of employment, a participant may request a distribution equal to the value of the vested interest in his or her account. The participant may elect to receive the distribution as a lump-sum or non-recurring partial payments.

The Plan Administrator will direct the custodian to process a lump sum distribution if the vested account balance is less than or equal to \$5,000 regardless of whether a request for a distribution is made. Written consent will be required for any distribution if the vested account balance is greater than \$5,000. In the event of a distribution greater than \$1,000 that is made without the participant's consent, the Plan Administrator shall pay the distribution in a direct rollover to an individual retirement plan.

A participant may also elect to receive an in-service distribution upon attaining age 59 ½ or having incurred a financial hardship as defined by the Plan. Participants may only receive a distribution from the employee deferral portion of their account for a hardship distribution.

SECURE 2.0 Act - On December 29, 2022, Congress passed the SECURE 2.0 Act of 2022 ("Act") to increase retirement savings, improve retirement rules, and lower employer costs of setting up a retirement plan. Plan Amendments required by the Act generally need not be made until the end of the first plan year beginning on or after January 1, 2026 (by December 31, 2026). However, plans must be operated in accordance with the effective date of each new provision.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Current Expected Credit Losses - In June 2016, the Financial Accounting Standards Board ("FASB") issued ASU No. 2022-02, Financial Instruments - Credit Losses (Topic 326), which became effective for the Plan on January 1, 2023. The guidance in this ASU significantly changed how entities will measure credit losses for most financial assets and certain other instruments that aren't measured at fair value through net income. The most significant change in this standard is a shift from the incurred loss model to an expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing an entity's exposure to credit risk and the measurement of credit losses. Financial assets held by the Plan that are subject to the guidance in FASB ASC 326 are employer contributions receivable. Plan management has evaluated employer contributions receivable as of December 31, 2024 and determined that no allowance for credit losses is necessary. Topic 326 had no impact on the Plan upon adoption on January 1, 2023.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Administrative Expenses - All operating expenses of maintaining the Plan are paid by the Plan Sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Participant's pay an administrative expense associated with their distribution.

Concentrations - The Plan had investments in two investment funds: Blackrock Health Sciences Opportunity Portfolio Fund and iShares S&P 500 Index Fund, which represented collectively approximately 23% of net assets available for plan benefits as of December 31, 2024. The Plan had investments in two investment funds: Blackrock Health Sciences Opportunity Portfolio Fund and iShares S&P 500 Index Fund, which represented collectively approximately 24% of net assets available for plan benefits as of December 31, 2023.

Management's Review of Subsequent Events - For the year ended December 31, 2024, the Plan evaluated subsequent events for potential recognition and disclosure through October 14, 2025, the date the financial statements were available to be issued.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement and accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs consist of quoted prices for similar assets in active markets, and Level 3 inputs would only be used when Level 1 or Level 2 inputs were not available. There were no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1 Fair Value Measurements - The fair value of mutual funds is based on quoted net asset values for the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The funds held by the Plan are considered to be actively traded.

NOTE F - PLAN TERMINATION

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE G - TAX STATUS

The Company adopted the Plan under a master plan agreement. The master trustee obtained its latest determination letter dated January 1, 2018, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and Internal Revenue Service. The Plan Administrator analyzes tax positions taken by the Plan, as applicable, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
