### 1. Description of Plan

The following description of DeVal Lifecycle Support, LLC 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of DeVal Lifecycle Support, LLC (the "Company" or "Employer") or any affiliate who has adopted the Plan. The Plan is intended to satisfy the applicable sections of the Internal Revenue Code ("IRC"). An employee becomes eligible to make elective contributions and start receiving the employer matching contribution along with employer non elective and safe harbor match upon attainment of age 20.5 years. There is no minimum service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

#### ***Contributions***

Each year, eligible employees may elect to have a percentage or specified dollar amount deducted from their eligible compensation, as defined by the Plan document. Participant's contributions may be deducted on a pre-tax basis. After-tax contributions, also known as "Roth Contributions" are also permitted under the Plan. Participants who are age 50 years or older may also make catch up contributions as allowed by the IRC. Participants may make a rollover contribution of amounts distributed from another tax-qualified pension or profit-sharing plan.

The Company makes matching contributions and non elective employer match at its discretion to the Plan on behalf of eligible participants. Non-elective contributions are made when an employee completes 1,000 hours of service and remains employed as of the last day of the plan year. In 2024 and 2023, the Company elected not to make additional employer contributions. Also, safe harbor matching contributions are made at 100% of "matched employee contributions" not in excess of 3% of the participants eligible compensation and 50% of the participant's "matched employee contributions" that exceed 3% of the participant's eligible compensation but that do not exceed 5% of the participants eligible compensation. "Matched employee contributions" are any elective deferral contribution or catch up contribution that is made during the year.

#### ***Participant Accounts***

Each participant's account is credited for participant and Employer matching contributions, investment earnings and charged for allocated administrative expenses. The contributions are allocated among the investment options according to the participant's instructions. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. Description of Plan (*continued*)

#### ***Vesting***

Participants are fully vested in that portion of their account which represents their contributions, safe harbor matching contributions and the income earned thereon. Participants vest in the Employer matching contributions and non-elective contributions plus actual earnings thereon as per the following schedule:

<u>Years of Service</u>	<u>Vested percentage</u>
0-3 years	0%
3 or more years	100%

#### ***Forfeitures***

In the event that a participant terminates before becoming fully vested in his or her account balance, the non-vested portion of the participants' account balances will be forfeited as of the termination date. Forfeitures of terminated non-vested accounts will be used to reduce future employer contributions made to the Plan or used to pay any administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited nonvested amounts totaled \$4,007 and \$3,817. During 2024 and 2023, no forfeitures were used to offset employer matching contributions or administrative expenses.

#### ***Notes Receivable from Participants***

Participants may borrow from their vested fund accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the participant's vested account balance and bear interest at the prime rate plus one percent. Loan repayments must be made through payroll deductions over a term not to exceed 5 years unless the proceeds of the loan are used to purchase the participant's principal residence, in which case the plan administrator may permit a longer repayment period. Principal and interest is paid ratably through periodic payroll deductions.

#### ***Withdrawals and Benefit Payments***

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Participants may elect a lump sum distribution, cash or in kind, partial withdrawals. A participant may also request a withdrawal upon attainment of age 59 ½ or upon demonstration by the participant to the plan administrator that the participant is suffering from a hardship. A force -out provision for amount not exceeding \$5,000 applies.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. All investments at December 31, 2024 and 2023 were level 1 inputs under the fair value hierarchy.

#### ***Reclassification***

Certain amounts in the 2023 fair value leveling have been reclassified to conform to the 2024 presentation.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Mutual funds and the money market fund are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission and are deemed actively traded. These funds are required to publish their Net Asset Value (“NAV”) and to transact at that price. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent notes receivable from participants are recorded as deemed distributions when a distributable event occurs.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Expenses that are paid by the Company are excluded from these financial statements. Investment related fees are included in the net appreciation in fair value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 10, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company, a qualified institution.

### 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer matching contributions.

### 5. Tax Status

The Plan was formed using a prototype plan which the IRS has determined and informed the applicant by letter dated June 30, 2020 that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. Plan management believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions however, there are currently no examinations for any tax periods in progress.

### 6. Party-in-Interest

Certain investments of the Plan are managed by American Funds which is related to Capital Bank and Trust Company, and, therefore these transactions qualify as exempt parties-in-interest transactions under ERISA.

Certain employees of the Company may also be participants in the Plan and perform administrative services to the Plan at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

### 7. Prohibited Transactions

For the plan years 2019, 2020, 2021, 2022 and 2023, the Employer failed to transmit to the Plan contributions for participants totaling \$145,480 within the period prescribed by Department of Labor regulations. The Company made the necessary corrections for all the delinquent contributions during 2024.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
