INDEPENDENT AUDITOR'S REPORT

To the Trustees of

Opinion

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Oliver DeSilva Group Health Care Plan (the Plan) prepares its financial statements on the modified cash basis, whereby, contributions are recorded when received rather than when earned, and benefits and administrative expenses are recognized when paid rather than when the obligation is incurred. A modification to this is for benefits paid through Anthem’s Jointly Administrated Agreement (the JAA). Benefits are recognized when cash is disbursed and when the benefit is paid on behalf of the Plan by the JAA. Consequently, a contribution and a contribution receivable from the Plan Sponsor is recorded based on benefits paid.

Plan Expenses

Significant Plan expenses, such as audit fees, and expenses to administer the Plan, are paid by the sponsor.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Income Tax Status

The Plan has not applied for a determination letter from the Internal Revenue Service or the California Franchise Tax Board for tax exempt status; therefore, the Plan is subject to income taxes. Any income taxes attributable to the Plan are paid by the Plan’s sponsor, Oliver DeSilva, Inc.

Subsequent Events

Subsequent events have been evaluated through September 30, 2025, the date the financial statements were available to be issued, noting no matters requiring disclosure in the financial statements for the year ended December 31, 2024.

NOTE 2: DESCRIPTION OF THE PLAN

The following description of the plan provides only general information. Participants should refer to the Plan documents for a more complete description of its provisions.

The Plan is a part of the Oliver DeSilva Employee Benefits Program and is subject to the provisions of the Employee Retirement Income Security Act of 1974 and subsequent amendments (ERISA). The Plan pays for specified medical, dental and vision care expenses considered necessary to the wellbeing of covered persons.

The Plan’s assets are maintained in a trust fund administered by HealthComp Administrators, Inc. (the Contract Administrator), executed under a trust agreement dated January 1, 1992. Benefit payments are processed and administered by the Contract Administrator, who receives a fee for these services from the Plan. Insurance premiums are paid by the Contract Administrator to the applicable insurance carrier or benefit provider and reimbursed by the Plan Sponsor. The Plan was amended, effective May 12, 2023, to amend the COVID 19 language used in the cost sharing, preventive care section and eligibility, funding, effective date and termination provisions sections.

Contributions

The Employer contributes for employees who are participants in the Plan and their eligible dependents at a rate that is sufficient to pay reported benefits when due. In situations where claims paid are in excess of stop loss limits, the insurance proceeds received by the Employer are used for contributions. For the year ending December 31, 2024, the Employer received a stop loss reimbursement of approximately \$4.6 million to cover a single claim paid by the Plan. Participant contributions are limited to those amounts required to be paid by persons electing coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA).

Eligibility

All active full-time, salaried, non-union employees of the employer or certain other affiliated companies become eligible for participation in the Plan on the first day of the month following the first day of full-time employment. If the employee is an hourly employee, they become eligible for participation in the Plan on the first day of the month following 30 days after hire. Participants may elect to cover their spouse, domestic partner, and children under twenty-six years of age. Participation ends at the earliest of Plan termination, the date the covered person is no longer in an eligible class, or the end of the month in which an employee terminates employment. Covered persons who are terminated or become ineligible may elect continuation of coverage in compliance with COBRA.

Benefits

Payment of Employer-funded benefits is based on predetermined amounts and percentages as specified by the Plan. Generally, under such coverage option, the Plan pays for 90% (80% for non-Preferred Provider Organization “PPO” expenses) of eligible medical expenses after giving effect to a \$100 deductible per covered person (maximum of \$200 per family) per calendar year. Additional deductibles apply when pre-hospitalization, surgical and outpatient review guidelines are not followed. When \$2,000 per covered person (\$4,000 per family) of eligible medical expenses under the Plan has been reimbursed at 90% (80% for non-PPO expenses), the Plan will pay 100% of eligible medical expenses for the remainder of the calendar year for that person.

The maximum annual benefit available to any one individual under the Plan is unlimited. Claims incurred in excess of \$125,000 per participant, per Plan year, are covered by specific excess reinsurance. In addition, the Employer carries aggregate excess reinsurance coverage to provide reimbursement to the Plan when the group’s claims exceed the annual aggregate deductible amount for the Plan year. No amounts related to this arrangement are included in the financial statements.

At December 31, 2024 and 2023, there was approximately \$527,005 and \$463,350, respectively in outstanding benefit obligations, which had not yet been paid by the Plan as of these dates. These obligations were paid in subsequent years.

Benefit obligations are estimated based on claims that were incurred prior to the year ending and paid after the year ending December 31, 2024 and 2023, respectively. The estimated benefit obligations for the years ending December 31, 2024 were estimated based on claims paid between January 1, 2025 through July 23, 2025.

NOTE 3: PAYABLE TO ANTHEM

The payable to Anthem is for advances received from the JAA to pay benefits.

NOTE 4: PLAN TERMINATION

While it has not expressed any intention to do so, the Employer has the right to discontinue contributions at any time and to terminate the Plan, subject to provisions set forth in ERISA.

In the event the Plan terminates, reasonable notice of such discontinuance shall be given to all participants as to the date that benefits and contributions shall cease. The rights of participants to benefits will be limited to eligible health and welfare costs incurred up to the date of termination.

NOTE 5: RECONCILIATION OF THE 5500 TO FINANCIAL STATEMENTS

There were no differences between the information in the separate financial statements and the assets, liabilities, income expenses, and changes in net assets reported in the Schedule H of Form 5500.
