Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pharmacy Data Management, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF PLAN

The following description of Pharmacy Data Management, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined-contribution plan that covers substantially all employees of Pharmacy Data Management, Inc. and Internet Data Management, Inc. (Companies) who are 21 years of age or older and have completed 90 days of service for eligibility purposes. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Under the Plan's provisions, each participant may contribute an amount of their annual pre-tax or post-tax (Roth) compensation up to the elective deferral dollar limit and the Section 415 limitation of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also roll over amounts representing distributions from other qualified defined benefit or contribution plans. Newly eligible employees are automatically enrolled in the Plan at a 6% deferral rate unless they elect an alternative amount or elect not to defer. During 2024, the Companies elected to make safe harbor matching contributions equal to 100% of the participant's contributions up to 4% of the participant's plan compensation. Employer contributions, net of forfeitures, totaling \$509,842 were made to the Plan during the year ended December 31, 2024.

Upon enrollment in the Plan, a participant may direct employee and the Companies contributions to any of the available investment options. Participants may change their investment options at their discretion. All the balances of the Plan represent participant directed investments.

Participant Accounts:

Each participant's account is credited with the participant's contribution and the appropriate employer contribution, as well as allocations of the Companies discretionary contributions and plan earnings (losses), as defined. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested account.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Vesting:

A participant is 100% vested after six years of credited service. Participants are immediately vested in their deferrals, safe harbor contributions and amounts rolled over from other qualified defined benefit or contribution plans plus actual earnings thereon. Vesting in the Companies' matching contributions prior to January 1, 2024 is based on years of credited service.

Benefit Payments:

On termination of service, a participant may elect to receive either a lump-sum distribution or a direct rollover distribution equal to the value of the participant's vested interest in his or her account.

Non-terminated employees may make withdrawals from their elective deferral account balance upon reaching normal retirement age or as a hardship withdrawal prior to reaching normal retirement age. Hardship withdrawals are subject to additional rules and conditions as outlined in the Plan agreement.

Forfeitures:

The Companies' contributions that are forfeited may be allocated to participants, used to pay administrative expenses, restore amounts previously forfeited by former participants who have resumed participation in the Plan or reduce Companies contributions. During the year ended December 31, 2024, forfeitures totaling \$6,704 were used to reduce Companies contributions. Forfeitures available at December 31, 2024 and 2023 totaled \$-0-.

SECURE Act 2.0:

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. The Plan is required to be amended in regard to the requirements of SECURE 2.0 by December 31, 2025.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles general accepted in the United States of America.

Benefit Payments:

Benefits are recorded when paid.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition:

The Plan's investments are stated at a fair value, except the fully benefit-responsive investment contract which is reported at contract value. Pooled Separate Accounts (PSA) with underlying investments containing shares of mutual funds are valued at the net asset value of the shares and units held by the Plan at year end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See NOTE D for a discussion of fair value measurements. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions of the Plan. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent Events:

The plan sponsor evaluated all activity of the Plan through October 9, 2025, the date the financial statements were available to be issued and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements or notes.

NOTE C - CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024, and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024 were obtained by management and agree to or derived from information certified as complete and accurate by Empower Trust Company and Empower Annuity Insurance Company of America. The insurance contract was certified by Empower Annuity Insurance Company and all other investments were certified by Empower Trust Company.

NOTE D - INVESTMENTS AND FAIR VALUE MEASUREMENTS

FASB ASC 820 requires the Plan to classify its assets and liabilities based on valuation methods using three levels. Level 1 inputs are based on quoted prices in active markets for identical investments. Level 2 inputs are based on significant observable market inputs, such as quoted prices for similar investments and quoted prices in inactive markets. Level 3 inputs are based on significant unobservable inputs that reflect the Plan's determination of assumptions that market participants might reasonably use in valuing the investments. The valuation levels are not necessarily an indication of risk or liquidity associated with the underlying investments.

The following tables are in accordance with Subtopic 820-10, all investments are classified as Level 2 and included in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has entered into a fully benefit-responsive contract with Empower Annuity Insurance Company of America, the insurer of the Plan. The insurer maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The declared interest rates for each of the years ended December 31, 2024 and 2023, were 2.80% and 1.35%, respectively.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula established by the issuer. Such interest rates are reviewed on a quarterly basis for resetting. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact with the issuer at contract value. Such events include, but may not be limited to, a participant termination of employment due to (1) amendments to the Plan documents (including complete or partial termination or merger with a another plan); (2) bankruptcy of the Sponsor or other Sponsor event (e.g., divestures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan; (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.; or (4) cessation of an employment relations resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring.

In addition, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract or (4) a material misrepresentation. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring.

NOTE F - TAX STATUS

The Plan has adopted a non-standardized pre-approved profit sharing plan document and trust. The pre-approved plan obtained a determination letter date June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The pre-approved has been amended since receiving the determination letter; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets are invested in funds managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America is the third-party administrator as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Recordkeeping, custodial and other expenses paid by the Plan were incurred with parties-in-interest as defined in Section 3(14) of ERISA.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - PLAN TERMINATION

While it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.
