### **Opinion**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Cement Masons Southern California Individual Retirement Account Defined Contribution Trust (the “Plan”) is a defined contribution multiemployer pension plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan provides retirement benefits to its participants and is available to all union members employed in the jurisdiction of the participating local unions.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**C. Employer Contributions**

Employer contributions as reported are contributions made by employers on behalf of employees for hours worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts.

**D. Employer Payroll Compliance Program**

Remittance reports were accepted as submitted, without examination or verification of employers’ payroll records. The system of internal control provides for examination of employers’ records under a separate payroll compliance program.

**E. Investment Valuation and Income Recognition**

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Purchases and sales of securities are recorded on the trade date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Net appreciation of investments includes gains and losses on investments bought and sold as well as held during the year.

**F. Tax-Exempt Status**

No provision for federal or state income tax is made. The Plan administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**G. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$10,000 or 50% of their vested account balance. A participant may only have one outstanding loan at any time. The term of repayment may not be greater than five years. A loan is secured by a participant's vested account balance and bears interest at the prime rate plus 1%. The Plan administrator established the specific terms and conditions of loans to participants. Notes receivable from participants at December 31, 2024 carry interest rates of 4.25% to 9.50%.

**H. Vesting**

A participant becomes 100% vested in the employer contributions paid on his/her behalf after completing 300 hours of service in a twelve-month period. No forfeitures reverted to the Plan in 2024 or 2023 for employees who did not meet Plan eligibility requirements. The forfeiture balance was \$258,708 and \$246,107 at December 31, 2024 and 2023, respectively.

**NOTE 3 - RELATED PARTY TRANSACTIONS**

The Plan shares common expenses with four related trust funds (Cement Masons Southern California Health and Welfare Fund, Cement Masons Joint Apprenticeship Trust, Eleven Counties Cement Masons Vacation Savings Plan and Cement Masons Southern California Pension Trust) (collectively the "Trust Funds") and other related organizations based on allocation percentages periodically approved by the Board of Trustees.

Employer compliance audits and collection services are performed by Zenith American Solutions. The Plan is charged its allocable share of the \$61,999 per month. The allocation percentages are periodically approved by the Board of Trustees.

**NOTE 4 - PLAN TERMINATION**

Upon the termination of the Plan, per the Agreement and Declaration of the Trust, any and all monies remaining in the Plan after payment of all expenses and obligations of the Plan shall be either expended and used for the continuance of purposes of the Plan, until such monies have been exhausted, or transferred to another trust or trusts providing similar benefits.

**NOTE 5 - RISKS AND UNCERTAINTIES**

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risk. Some estimated values may differ from values that would have been used had a ready market existed for the investment. Due to the level of risk associated with investments and the level of uncertainty with respect to the changes in the value of investments, it is reasonably possible that changes in risk in the near term would materially affect the amounts reported in the financial statements.

**NOTE 6 - FUNDING POLICY**

The Board of Trustees has established a funding policy and method in order to promote the purpose of the Plan and to ensure compliance with ERISA. Each employer contributes to the Plan such amounts and at such times as are required by the applicable provisions of the collective bargaining agreement or such other agreements as are approved by the Board of Trustees. Employer contributions are based on hourly contribution rates and are made on a monthly basis. The annual contributions for the year satisfied the minimum funding requirements of ERISA.

**NOTE 7 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 6, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
