Opinion

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The Cement Masons Southern California Health and Welfare Fund (the "Plan") is a multiemployer welfare benefit plan providing medical, vision, dental, prescription, life and accidental death and dismemberment insurance benefits to participants on whose behalf employers contribute to the Plan in accordance with their collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective July 1, 2001, \$.02 per hour is payable to Alternative Dispute Resolution (ADR).

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

C. Postretirement Benefits

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation was determined by an actuary from Rael & Letson and is the amount that results from applying actuarial assumptions to historical benefit cost data to estimate future annual incurred benefit costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions and methods used were as follows for 2024 (2023): (a) Discount Rate: 5.50% (4.75%) per annum, (b) Mortality: RP-2000 Blue Collar table, (c) Retirement Age: 65 and 10 years of pension credited service and (d) Actuarial Cost Method: Modified Projected Unit Credit actuarial cost method.

C. Postretirement Benefits (Continued)

The health care cost trend rate and retiree contribution trend rate have a significant effect on the postretirement benefit obligation. A 1% increase in the health care cost trend rate would increase the net postretirement benefit obligation as of December 31, 2024 and 2023 by \$2,538,200 and \$3,053,000, respectively.

The effect to the Medicare Prescription Drug, Improvement and Modernization on the Plan was determined based on the actuary's interpretation of the current regulations and guidance. The benefits provided under the Plan are at least actuarially equivalent to Medicare Part D benefits. Thus, the Plan is eligible for the Medicare Prescription Drug subsidy. The gross Medicare subsidy received by the Plan in 2024 and 2023 was \$84,159 and \$101,047, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations.

D. Employer Contributions

Contributions as reported are made for hours worked during the year. Contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts.

E. Employer Payroll Compliance Program

Remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

F. Investment Valuation and Income Recognition

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments include mutual funds valued at their quoted prices in an active market. Level 2 investments consist of a short term investment fund valued at amortized cost which approximates fair value.

Purchases and sales of securities are recorded on the trade date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Net appreciation of investments includes gains and losses on investments bought and sold as well as held during the year.

G. Tax-Exempt Status

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701(i).

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

H. Risks and Uncertainties

Benefit obligations are reported based on assumptions pertaining to health care inflation rates, participant demographics and other assumptions which are subject to change. Due to the uncertainty of the assumption process, it is at least reasonably possible that changes in these assumptions in the near term would be material to the financial statements.

H. Risks and Uncertainties (Continued)

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risk. Due to the level of risk associated with investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would be material to amounts reported in the financial statements.

NOTE 3 - RELATED PARTY TRANSACTIONS

The Plan shares common expenses with four trust funds (Cement Masons Southern California Pension Trust, Cement Masons Joint Apprenticeship Trust, Eleven Counties Cement Masons Vacation Savings Plan and Cement Masons Southern California Individual Retirement Account Defined Contribution Trust) (collectively the "Trust Funds") and other related organizations based on allocation percentages periodically approved by the Board of Trustees.

Excess contributions were inadvertently transferred to the Plan from the Cement Masons Southern California Pension Trust Lockbox Account ("lockbox") during the year ended December 31, 2024 in the amount of \$394,441. The excess contributions were refunded to the lockbox in the subsequent year.

Employer compliance audits and collection services are performed by Zenith American Solutions. The Plan is charged its allocable share of the \$61,999 per month. The allocation percentages are periodically approved by the Board of Trustees.

Amounts currently payable to or for participants, dependents, and beneficiaries are reported on the Form 5500 for benefits that have been earned prior to December 31, but not yet paid as of that date.

NOTE 5 - CONCENTRATION OF CREDIT RISK

During 2024, the Plan maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

NOTE 6 - ALLOCATED RESERVES

The Plan allocates a portion of its reserves to provide for retiree life and operating expenses. The following reflects the reserve allocations:

NOTE 7 - PRIORITIES UPON TERMINATION

In the event of termination, Plan assets are to be used first for the payment of expenses and benefit payments incurred up to the date of termination and expenses incident to such termination.

Any remaining assets will be distributed in such a manner as the Board of Trustees determine will carry out the purpose of the Plan, including but not limited to the purchase of existing insurance benefits on a pro-rata basis or the transfer of such funds to a successor trust having the same or similar purposes for the benefit of employees. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of participants.

NOTE 8 - PLAN AMENDMENTS

On December 7, 2023, the Plan was amended to make ABA Therapy a covered treatment.

Effective January 1, 2024, the Plan was amended to waive the initial eligibility requirements in order to provide immediate eligibility to newly bargained employees.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 6, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that require recognition or additional disclosures in these financial statements.



