INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of the

401(k) and Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Rothschild & Co North America Inc. 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Charles Schwab Trust Bank, a qualified institution, as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Report on Supplemental Information

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF PLAN

The following is a brief description of the Rothschild & Co North America Inc. 401(k) and Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a profit sharing, defined contribution, participant directed plan with a cash-or-deferred arrangement covering all eligible employees of Rothschild & Co North America Inc. and its Subsidiaries, Five Arrows Managers North America LLC, Redburn (USA) LLC and Five Arrows Managers, (USA) LLC (the Company). Employees are eligible to become Plan participants once they meet certain criteria as described in the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended.

The Trustee is responsible for the oversight of the Plan, including determining the appropriateness of the Plan's investments in coordination with the Investment Custodian.

In November 2022, the Board of Trustees amended the Plan to remove Safe Harbor status from the Plan effective January 1, 2023.

Contributions

The Company contributes to the Plan for each Plan year (or portion of a Plan year) that an employee is a participant in the Plan: (a) a matching contribution of 100% of up to 4% of salary which a participant elects to contribute to the Plan (Safe Harbor match); and (b) may make an additional discretionary contribution in such amount as the Company shall determine. For the years 2024 and 2023, the Company did not make a discretionary contribution. Participants may make a total contribution of up to 60% of salary on a pretax basis, but no more than the amount permitted by law. Certain participants (age 50 and older) can make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contribution into various investment options offered by the Plan.

NOTE 1. DESCRIPTION OF PLAN (continued)

Vesting

Participant accounts shall be fully vested at all times in their contributions and the Company's match, plus actual earnings thereon and shall not be subject to forfeiture for any reason. Vesting in the remainder of their accounts is based on years of credited service. Under the Plan agreement, vesting begins on a pro rata basis, after the participant has completed two years of service. A participant is fully vested after five years of service.

Participants Loans

Participants may borrow against their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of the participants' vested account balance. The loans are secured by the balance in the participants' accounts and bear interest at rates ranging from 9.50% to 8.50% at December 31, 2024 and 2023.

Loans must be repaid in level payments generally through after-tax payroll deductions at least on a quarterly basis over a period not to exceed five years, except when the loan is used for the purchase of a primary residence, in which case the repayment period cannot exceed ten years. In the event of termination of service of a participant before the vested balance is paid in full, the unpaid loan balance and interest shall immediately become due and payable.

Benefits

Upon termination of employment, retirement, or disability, participants may elect to have vested benefits under the Plan paid in a lump sum distribution to the participant either in cash, as a direct rollover, or a combination of both. In the event of a participant's death, the lump sum distribution of the deceased participant's balance will be made in cash to the beneficiary.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The financial statements are prepared using the accrual basis of accounting.

Investments and Income Recognition - Investments are carried at fair value which generally represents the net asset value of the mutual funds and self-directed brokerage accounts (common stock) as of the last business day of the year as provided by the investment company.

Purchases and sales are recorded on the trade date basis. Interest and dividends are recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Fully benefit - responsive investment contract - The guaranteed investment contract is carried at contract value, which equals deposits made plus interest credited under the terms of the contract less any withdrawals.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Contributions Receivable - Contributions due and not paid prior to year-end are recorded as contributions receivable. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded.

Notes Receivable from Participants - Participant notes are measured at their principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Forfeitures - When certain terminations of participants in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. As of December 31, 2024, the forfeited non-vested account totaled \$40,463 and \$275, respectively. This account will be used to reduce future Company contributions. During the years ended December 31, 2024, the Company used \$275 of forfeitures to reduce the Company's matching and discretionary profit sharing contribution.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Administrative Expenses - Plan administrative expenses are primarily comprised of investment management advisory fees and recordkeeping fees. These expenses are paid directly by the Plan. The Plan's audit fees are paid by the Company.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Charles Schwab Trust Bank, the Custodian of the Plan for the years ended December 31, 2024 and 2023, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and supplemental Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment and notes receivable from participants activity reported in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

NOTE 4. PRIORITIES UPON TERMINATION

Although it has not expressed any intent to do so, the Trustees have the right to terminate the Plan subject to the provisions of ERISA. Upon termination, each affected participant would become 100% vested in their account.

NOTE 5. TAX STATUS

The Plan obtained its latest determination letter on October 6, 2016 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 401(a) of the Internal Revenue Code, and was, therefore, exempt from federal income taxes under Section 501(a).

The Plan's administrator and the Plan's counsel believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

NOTE 6. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 6. FAIR VALUE MEASUREMENTS (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

For the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2, or 3.

All of the investments held by the Plan, except for the fully benefit-responsive insurance contract held with New York Life disclosed in Note 7, are measured at fair value, without adjustment by the Plan, based on the net asset value (NAV) or NAV equivalent as of December 31, 2024 and 2023, respectively.

The Plan's investments are participant directed. Participants can initiate transactions in and out of their accounts at any time without prior notice.

NOTE 7. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan is party to a fully benefit-responsive insurance contract with New York Life Insurance Company (NYL). NYL maintains the investment in a general account. The contract, which is included in the financial statements at contract value as reported to the Plan by NYL, is credited with contributions made under the contract, earnings on the underlying investments, and charged for Plan withdrawals and administrative expenses. The contract value of the investment contract at December 31, 2024 and December 31, 2023 was \$5,067,445 and \$5,985,860. The rate of return before expenses was 3.25% and 2.80% for the years ended December 31, 2024 and 2023, respectively.

The investment contract provides that withdrawals for benefit payments at death, retirement, disability, termination of employment, and for loans, hardship withdrawals or in-service withdrawals as permitted by the plan at contract value. Transfers to other funds are also made at contract value. At contract termination, a plan may elect to receive either an immediate lump-sum distribution subject to a market value adjustment or receive a contract value distribution in 6 annual installments over a period of 5 years. Certain distributions, distributions resulting from employer-initiated events such as plan termination, merger, spin-off, lay-off, early retirement incentives, etc., may be subject to a market value adjustment. An event that limits the plan's ability to transact at contract value with participants in the plan must be probable of not occurring for the contract to be considered benefit-responsive. The plan sponsor is responsible for making this determination. Participant-initiated transactions are permitted on a daily basis. Transfers to competing funds must first go through a non-competing investment option for at least 90 days; however, such short-term administrative restrictions do not necessarily affect a contract's categorization as benefit-responsive.

NOTE 8. RELATED PARTIES

Certain administrative duties are provided by the employer, Rothschild & Co North America Inc. for which no fees have been charged to this Plan. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.

NOTE 9. RISK AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 10. TRANSFER OF ASSETS

Effective October 1, 2024, the Plan merged with Redburn (USA) LLC 401(k) Plan. The assets transferred to the Plan totaled \$10,766,442.

NOTE 11. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
