We have audited the financial statements of Sheet Metal Workers Local No. 20 Defined Contribution Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Sheet Metal Workers Local No. 20 Defined Contribution Pension Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Responsibilities of Management for the Financial Statements (continued)

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

December 31, 2024 and 2023

Note 1. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements of Sheet Metal Workers Local No. 20 Defined Contribution Pension Plan (the Plan) have been prepared using the accrual basis of accounting.

Investments - The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of investments are reflected on a trade-date basis.

Dividend income is recorded on the ex dividend date. Interest income is recorded on the accrual basis.

Contributions Receivable - Employer contributions due and not paid prior to year end are recorded as contributions receivable. Employer contributions due as determined by payroll compliance audits are recorded upon settlement with the employer. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Property and Equipment - Property and equipment are recorded at cost. Major additions are capitalized while replacements, maintenance and repairs which do not improve or extend the lives of the respective assets are expensed currently. Depreciation and amortization are computed on the straight-line method over estimated useful lives of three to five years for computer equipment, five to ten years for office furniture and equipment, and five years for leasehold improvements.

Depreciation and amortization expense was \$1,264 in 2024 and \$1,347 in 2023.

Revenue Recognition - Revenue derived from employer contributions is recognized in the period in which covered work is performed, based on the number of hours worked in covered employment and the contribution rates set forth in the collective bargaining agreements. Employers are required to remit contributions monthly. The Plan carries out its purpose described in Note 2 within a jurisdiction primarily located throughout the state of Indiana.

Payment of Benefits - Benefit payments to participants are recorded upon distribution. Amounts allocated to participants who elected a withdrawal from the Plan but were not yet paid at December 31, 2024 and 2023 totaled \$20,860 and \$30,829 respectively.

Note 1. Summary of Significant Accounting Policies (continued)

Expenses - Certain investment related expenses are included in net appreciation in fair value of investments.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

Note 2. Description of the Plan

The Plan was established during 1999 as a result of a collective bargaining agreement between Sheet Metal Workers Local Union No. 20 and various employer associations to provide retirement, disability and survivor benefits for eligible participants. The Plan is a multiemployer defined contribution retirement plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation.

An individual account is established for each participant. Participants' accounts are credited with employer contributions made on their behalf, and are adjusted for Plan earnings or losses less administrative fees. As defined, allocations are based on individual account balances. An annual administrative fee of \$10 is charged to participants. The benefit to which participants are entitled is the benefit that can be provided from their account.

Participants may direct contributions and rollovers into various investment options. In the absence of participant direction, contributions are invested in a designated target fund until changed by the participant. Participants may change their investment options as permitted under the Plan provisions. Participants must evaluate their own investment goals and objectives and choose the investment options best suited to achieve those goals and objectives. Poor investment performance by the investment options selected by the participants may cause their vested account balances to be lower than the employer contributions made to the Plan on their behalf.

Under current Plan provisions, each participant's account is immediately vested in all employer contributions paid on the participant's behalf. Upon death, disability, retirement or separation from service for more than two years, participants are entitled to receive their account balance, subject to the payment provisions of the Plan.

The Plan's net assets available for benefits at December 31, 2024 and 2023 include unallocated accounts of \$526,009 and \$448,947 respectively. These amounts are available to pay administrative costs incurred by the Plan.

Participants should refer to the summary plan description for more complete information.

Note 3. Priorities upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, the right to discontinue the Plan is reserved to the Trustees. Termination shall not permit any part of the Plan assets to be used for or diverted to purposes other than the exclusive benefit of the participants and their beneficiaries, except that provision may be made for the payment of necessary expenses resulting from termination of the Plan.

In the event of termination, the net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations. Benefits would be distributed to the participants and their beneficiaries as if the Plan had not been terminated.

Note 4. Tax Status

The Plan's latest determination letter is dated August 5, 2015, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of Section 401(a) of the Internal Revenue Code and was, therefore, exempt from federal income taxes under the provisions of Section 501(a). The Plan has been amended since receiving the determination letter. The Plan's administrator and Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Funding Policy

The Plan is primarily funded by employer contributions as specified in the collective bargaining agreement. Participants may elect a wage classification and increase employer contributions in \$1 increments up to \$7 per hour, depending on worker classification, by taking a corresponding reduction in their hourly rate of pay. The contribution rates per hour worked for the years ended December 31, 2024 and 2023, including additional amounts elected, ranged from \$0.20 to \$8.98.

Note 6. Fair Value Measurements

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The following tables set forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. In accordance with generally accepted accounting principles, certain investments that are measured at fair value using the net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the following tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

Level 1 Measurements

The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value on the last business day of each period presented.

Measurements Using Net Asset Value as a Practical Expedient

The common collective trusts are valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value is based on the fair values as of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

The common collective trusts are direct filing entities (DFEs) and file a Form 5500 annual report with the U.S. Department of Labor. The Plan is not required to disclose the significant investment strategies of DFE investments. There are no significant withdrawal restrictions imposed on these funds.

Note 7. Related Organizations

The Plan is related to a number of organizations including a local union, a health and welfare plan, an apprenticeship fund and several pension plans, all of which are tax-exempt.

Common Administrative Expenses

The Plan shares facilities, equipment and staff with certain of the related organizations. Common administrative expenses incurred with related Sheet Metal Workers Local No. 20 Welfare and Benefit Fund (the Welfare Fund) are initially paid by the Welfare Fund and allocated periodically based on estimates of time spent, space used and costs incurred. Common administrative expenses allocated to the Plan for the years ended December 31, 2024 and 2023 totaled \$153,340 and \$163,445 respectively. The amount due to the Welfare Fund at December 31, 2024 and 2023 for common administrative expenses was \$129,340 and \$67,753 respectively. In addition, there was an amount due to Sheet Metal Workers Local No. 20 Indianapolis Area Pension Fund for common administrative expenses in the amount of \$3,846 and \$7,692 at December 31, 2024 and 2023, respectively.

Collection of Contributions

The Welfare Fund collects contributions on behalf of the Plan throughout the year. On a regular basis, contributions due to the Plan are transferred to the Plan. Amounts due from the Welfare Fund for contributions totaled \$448,991 and \$528,112 at December 31, 2024 and 2023, respectively.

Note 8. Participation in Multiemployer Plans

The Plan's shared full-time employees participate in various multiemployer benefit plans. Contributions to these plans are initially paid by the related Welfare Fund and are allocated to the Plan based on estimates of employee time. The Plan's share of contributions is included in the common administrative expenses described in Note 7.

The Plan's shared full-time employees are covered by a multiemployer defined benefit pension plan that is not considered to be individually significant. The Plan's share of contributions to the multiemployer defined benefit pension plan for the years ended December 31, 2024 and 2023 was \$10,047 and \$7,553 respectively. Contributions are made monthly under terms of a participation agreement.

Shared full-time employees are also covered by one of two multiemployer defined contribution retirement plans. The Plan's share of contributions to the multiemployer defined contribution retirement plans for the years ended December 31, 2024 and 2023 was \$2,210 and \$1,224 respectively. Contributions are made monthly under terms of a participation agreement.

Shared full-time employees are covered by a multiemployer welfare plan that provides medical benefits to retirees and to eligible employees and their dependents. The Plan's share of contributions to the multiemployer welfare plan for the years ended December 31, 2024 and 2023 was \$17,397 and \$15,221 respectively.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

Two of the Plan's investment funds represented approximately 65% and 62% of the Plan's net assets available for benefits as of December 31, 2024 and 2023, respectively. The Plan's exposure to concentration of credit risk is limited by the diversification of across the participant directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial investments. Investment decisions are made, and the resulting risks are borne, exclusively by the Plan participant who made such decisions.

Note 10. Party-in-Interest Transactions

John Hancock Trust Company LLC is responsible for participant recordkeeping and distributions to Plan participants at the direction of the Board of Trustees and the custody of the Plan's investment assets. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

Note 11. Major Employer

During the years ended December 31, 2024 and 2023, contributions from one employer accounted for approximately 14% and 11%, respectively, of total employer contributions. In the event this employer suspended contributions, the Plan would retain the risk of having to pay current fixed administrative expenses until the appropriate adjustments were made.
