Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

A. DESCRIPTION OF PLAN

The following brief description of the North Mill Equipment Finance Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General

The Plan is a defined contribution plan covering all eligible employees of North Mill Equipment Finance LLC (the "Company"). The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The inception date of the Plan was January 1, 2013. Effective January 1, 2022, employees are eligible to participate upon achieving 18 years of age and completing six months of service. Voya Retirement Insurance and Annuity Company ("Voya" or the "Trustee") is the Plan's trustee.

The Plan completed the required Cycle 3 restatement effective January 1, 2022.

During the year ended December 31, 2024, BriteCap Financial LLC was added as a participating employer and its participants were merged into the Plan. Effective April 1, 2025, the Plan was amended to recognize service with additional previous employers as defined in the Plan document.

Contributions

Each year, participants are able to contribute up to 100% of eligible compensation, as defined in the Plan document, subject to certain limitations under the Internal Revenue Code ("IRC"). Unless an employee is excluded from participating, or elects to not participate, the Company will withhold 5% of the employee's compensation each payroll period. Effective January 1 of each Plan year, the amount withheld will increase by 1% up to a maximum of 10% withholding. Contributions can be made as pre-tax contributions or as Roth contributions. Catch-up contributions and rollover contributions are also permitted. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a variety of mutual funds, pooled separate accounts, and a guaranteed investment contract as investment options for the participants.

The Company makes a safe-harbor matching contribution equal to 4% of an employee's eligible compensation. For the year ended December 31, 2024, employer matching contributions totaled \$783,781. The Company, at its discretion, may also make discretionary nonelective profit sharing contributions each year. The profit-sharing contribution for the year ended December 31, 2024, was \$136,951.

Participants' Accounts

Each participant's account is credited with the participant's contributions, the Company's matching and profit sharing contributions, and Plan earnings (losses) and is charged with an allocation of investment expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions, all rollovers and transfers from qualified plans, the employer safe-harbor matching contribution and actual earnings or losses therein. Participants become vested in employer profit sharing contributions based on a graded-vesting schedule, with participants becoming fully vested after six years. In addition, participants become fully vested in their accounts upon reaching normal retirement age (as defined in the Plan) prior to termination of employment or in the event of death or permanent disability.

A. DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants

Participants are allowed to borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of (i) 50% of their vested account balance, or (ii) \$50,000. The notes receivable are secured by the balance in the participant's account. Interest is charged at a rate of the prime rate plus 1% at the time of borrowing. Terms range from 1-5 years for personal borrowings. Participants are permitted to have a maximum of one loan outstanding at a time. The interest rate on the notes receivable from participants ranged from 4.25% - 9.50% at December 31, 2024 and 2023.

Payments of Benefits

On termination of service due to death, disability or retirement, a participant is to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, subject to Internal Revenue Service ("IRS") regulations, a participant is to receive the value of the vested interest in his or her account as a lump-sum distribution or have the balance deposited directly into another qualified retirement account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$7,430, respectively. Forfeited non-vested accounts are available to reduce future employer contributions or pay Plan expenses. During the year ended December 31, 2024, \$7,489 of forfeitures were used to pay Plan expenses.

Administrative Expenses

Expenses related to the administration of the Plan are primarily paid by the Company. Investment related expenses are borne by the participants.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive guaranteed investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Management has evaluated subsequent events for potential recognition and disclosure that occurred through October 9, 2025, the date the financial statements were available to be issued. Except for the matter disclosed in Note A, no items were determined by management to require disclosure.

C. INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Total investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Notes receivable from participants as of December 31, 2024, were not certified and were subject to additional procedures by the Plan's independent auditors.

D. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures to Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: The Plan invests in a group annuity contract with the Trustee. The Plan's investments are stated at net asset value (“NAV”) as report to the Plan by the Trustee, based on market values of the underlying assets. Because the pooled separate accounts invested in by the Plan do not publish a daily NAV, the NAV is a practical expedient in determining the fair value of the funds.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Because the Plan holds investments in a pooled separate account that does not publish a daily NAV, the investments are not subject to the fair value hierarchy classification requirements of U.S. GAAP. Total investments at fair value were \$11,146,602 and \$7,487,597 at December 31, 2024 and 2023, respectively.

Changes in Fair Value Levels

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

E. GUARANTEED INVESTMENT CONTRACT

The Plan maintains an investment in a guaranteed investment contract, the Voya Fixed Account. The Voya Fixed Account is a fully benefit-responsive investment contract and is stated at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Contributions to the Plan under this contract are maintained in a general account that is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. There are no reserves against contract value for credit risk. The Voya Fixed Account guarantees minimum rates of interest and may credit interest that exceeds the guaranteed minimum rates. Withdrawals from the Voya Fixed Account for reasons other than payment of benefits may be subject to a market value adjustment and a surrender charge.

There are no unfunded commitments. Under the terms of the contract, the Plan sponsor must provide a minimum of 90 days' notice to the Trustee prior to redemption of the contract. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (2) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (3) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

F. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities in general are exposed to various risks such as those involving interest rates, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

G. RELATED PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are units in a guaranteed funds managed by an entity related to the Trustee. The Trustee holds the assets of the Plan through an agreement; therefore, these transactions qualify as party-in-interest transactions.

H. TAX STATUS

The IRS has determined and informed the Plan by a letter dated and June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company reserves the right to terminate the Plan, in whole or in part, at any time, subject to the provisions of ERISA. In the event that such termination occurs, all amounts credited to participant accounts will become 100% vested and the Trustee, in accordance with the Plan document, will distribute the net assets of the Plan in a uniform and non-discretionary manner.
