NOTE 1 • DESCRIPTION OF THE PLAN

The following description of the Advanced Healthcare Management, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Advanced Healthcare Management, Inc. (the "Sponsor") and the related companies, Lafayette LTC, Inc., Union LTC, Inc., Pontotoc LTC, Inc. and Paradigm LTC, Inc., who have one year of service and are age twenty-one or older. One year of service is defined as 1,000 hours of service within a twelve-month period. Empower Retirement served as the Custodian of the Plan through November 6, 2023. Effective November 2023, Principal Trust Company began serving as the Custodian of the Plan. The Sponsor's Board of Directors and the Plan Administrator control and manage the operation and administration of the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA").

The Sponsor was founded in 2003 and is headquartered in Magee, Mississippi. Its primary services include helping facilities to provide active, compassionate and cost-effective inpatient short-term rehabilitation services and long-term care to multiple locations throughout Mississippi and Alabama.

Contributions

Participating employees may contribute up to the tax law dollar limit (\$23,000 for 2024 and \$22,500 for 2023) of their compensation to the Plan. Additionally, participants age 50 and older can elect to make additional catch-up deferrals limited to \$7,500 for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Sponsor may elect to make discretionary matching contributions. During 2024 and 2023, the Sponsor elected to make discretionary matching contributions of 50 percent of the participant's elected deferral contribution up to 6 percent of the participant's compensation. Additional discretionary contributions may be contributed at the option of the Sponsor's Board of Directors. During 2024 and 2023, no additional discretionary contributions were made by the Sponsor.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Sponsor's contributions and Plan earnings and is charged with an allocation of service and investment fees expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus earnings thereon. Vesting in the Sponsor's contribution portion of their accounts, plus earnings thereon, is determined as follows:

Investment Options

Contributions to the Plan are invested in any of the investment funds available under the Plan provisions, in such proportions as directed by the participants. Participants may change investment options at any time.

Payment of Benefits

Benefits are generally payable on termination, retirement, death or disability and hardship distributions based on the participant's vested balance. Hardship withdrawals are limited to the amount of the participant's elected deferral contribution. Benefits may be paid in the form of a lump sum, installments, alternative annuity or ad-hoc distributions.

Forfeited Accounts

Forfeitures, which generally result from employees withdrawing from the Plan prior to vesting in Sponsor contributions and earnings thereon, may be used to reduce the Sponsor's contributions to the Plan or to reduce administrative expenses charged to participant accounts. At December 31, 2024 and 2023, forfeited non-vested accounts available to offset Sponsor contributions or reduce administrative expenses totaled \$0. During December 31, 2024 and 2023, amounts totaling \$0 and \$1,893, respectively, were forfeited and used to reduce Sponsor contributions during the year.

Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Administrative Expenses

Custodial expenses incurred by the Plan are generally paid by the Plan. Fees not paid by the Plan are paid by the Sponsor.

NOTE 2 • SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates. Significant estimates include the fair value measurement of investments. It is at least reasonably possible that the significant estimates used will change within the next year.

Employee and Employer Contributions

Employee deferrals and respective employer matching contributions are recognized as additions to net assets on the date on which such employee deferrals would otherwise have been payable to the participant. Employee rollover contributions are recognized as additions to net assets on the date transferred from other qualified plans.

Investment Valuation and Income Recognition

Investments are stated at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized gains and losses on the Plan's investments are included in net appreciation in the fair value of investments at year-end in the statements of changes in net assets available for benefits.

Concentration of Market Risks

The Plan assets include a significant amount of registered investment companies, pooled separate accounts, and common collective trust which invest primarily in marketable equity securities and fixed income securities. Accordingly, the performance of the investments is dependent on the equity and debt securities markets which involve price volatility. The Plan assets also include investment in a fixed annuity option fund, which invest primarily in fixed interest options. All guarantees are backed by the claims-paying ability of Principal Trust Company. The values of these contracts are sensitive to the ability of Principal Trust Company to meet guaranteed interest obligations. Additionally, the registered investment companies, pooled separate accounts and common collective trust may invest in securities with contractual cash flows, such as asset-backed securities, collateralized mortgage obligations and commercial mortgage-backed securities, including securities backed by subprime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

Excess Contributions Payable

Amounts paid to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants in the subsequent year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Subsequent events were evaluated by the Plan through October 10, 2025, which is the date the financial statements were available to be issued.

NOTE 3 • INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company and Empower Retirement, the Custodians of the Plan.

NOTE 4 • FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, Fair Value Measurements and Disclosures establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at fair value, determined by multiplying the number of shares of the respective underlying fund by the closing net asset value per share quoted by that fund.

Common collective trust: Valued at the NAV of units of the collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods may produce a fair value calculation that may not be indicative of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 • INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

The Plan has entered into a traditional fully benefit-responsive investment contract with The Principal Insurance Company (the "Insurer") totaling \$1,241,670 and \$1,057,755 for December 31, 2024 and 2023, respectively. The Insurer maintains the contributions in a general account which invests primarily in synthetic investment contracts. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This fixed annuity contract meets the fully benefit-responsive criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Insurer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) material misrepresentation or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 7 • PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, certain Plan investments were shares of guaranteed investment contracts and mutual funds managed by the Custodian. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan to the Custodian totaled \$39,420 and \$48,150 during 2024 and 2023, respectively.

NOTE 8 • INCOME TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by the Insurer. The prototype plan has received an opinion letter dated June 30, 2020, from the Internal Revenue Service as to the prototype plan's qualified status. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

There were no uncertain tax positions identified related to the current year and the Plan has no unrecognized tax benefits at December 31, 2024 and 2023, for which liabilities have been established. The Plan recognizes interest and penalties, if any, related to unrecognized tax benefits as a component of income tax expense.

NOTE 9 • NON-EXEMPT TRANSACTIONS

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Plan remitted all employee contributions to the Plan, contributions of \$4,794 and \$27,723 were not remitted within the required time period for the years ended December 31, 2024 and 2023, respectively. The Plan has started the process to correct the matters through the Voluntary Fiduciary Correction Program and make the participant accounts whole for the years ended December 31, 2024 and 2023.

NOTE 10 • PLAN AMENDMENT

The Plan was amended effective January 1, 2025, for employees to have one year of service to meet eligibility requirements. One year of service is defined as 1,000 hours of service within a twelve-month period.

NOTE 11 • SECURE 2.0 ACT

On December 29, 2022, the Securing a Strong Retirement Act of 2022 ("SECURE 2.0") was signed into law. SECURE 2.0 has key effective dates which vary by provision. The plan has adopted and implemented all mandatory provisions to date with other provisions to be phased in over the next few years in accordance with applicable law and IRS guidance. Written amendments to the Plan to reflect these operational changes will be adopted at a later date.
