Opinion

We have audited the financial statements of Groom Law Group Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of the Plan

The following description of the Groom Law Group Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document and any amendments thereto for a more complete description of the Plan's provisions.

General

The Plan was established on July 1, 1981 to provide benefits to the employees of the Groom Law Group, Chartered (the Company). The Plan is a contributory defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

The trustee and recordkeeper of the Plan are Fidelity Management Trust Company and Fidelity Workplace Services, LLC, respectively, (collectively, Fidelity). The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The administrator of the Plan is the Company. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees of the Company are considered eligible for participation, except for: (1) individuals covered by a collective bargaining agreement as to which retirement benefits are subject to good faith bargaining; (2) individuals who receive compensation solely in the form of a retainer or consultant fee; (3) summer law clerks; (4) individuals who are residents of Puerto Rico or a nonresident alien with no income from a US Source; (5) individuals who are leased employees; and (6) independent contractors. Generally, employees become eligible to participate on the first date of the month following the 90th day after the employee's employment commencement date. Participants must be 18 years of age to participate in the Plan. Additionally, the participant must complete one year of service defined as 1,000 hours of service to participate in the Plan.

Contributions

Each year, participants may contribute up to 60% of pretax eligible compensation, as defined in the Plan. Participants may also make after-tax contributions (Roth). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make an employer discretionary profit-sharing contribution to the Plan. If such discretionary contributions are made, they are allocated as follows: (1) If the eligible employee is: (i) an associate attorney or law clerk, or (ii) an employee who's first anniversary of employment occurs during the plan year or within the pay period, then the employee receives 3% of the compensation paid to them during the pay period, or 7.5% if they are considered "Highly Compensated", as defined in the Plan document; (2) if the eligible employee is an attorney who becomes a principal (other than non-equity principals) during the Plan year with or within such pay period, then the employee receives 5% of the compensation paid to them during the pay period;

(3) for all other eligible employees, they will receive a contribution equal to 10% of their “base compensation”, as defined in the Plan document, plus 15.4% of compensation that exceeds the base compensation limit.

The Company may also make a non-elective discretionary contribution to the Plan. Participants must have performed one year of service (defined as 1,000 hours of service during the Plan year) and be employed on the last day of the plan year, except in the event of death, disability or retirement during the year, to be eligible for the non-elective discretionary contribution. No non-elective discretionary contribution was made for the year ended December 31, 2024.

During the year ended December 31, 2024, the Company made contributions of \$3,740,135 to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, including amounts rolled over from other qualified plans, and the Company’s contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to a self-directed brokerage account and/or a variety of different fund options, which include, among others, money market, capital appreciation, and growth and income funds, and a common/collective trust. Fidelity has custody of the funds. Participants may change their investment options daily.

Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions, plus actual earnings thereon. Each employee who was a participant in the Plan prior to August 5, 2005, shall continue to have a 100% vested interest in their profit-sharing contributions. Each other employee who becomes eligible to participate in the Plan on or after August 5, 2005, shall become fully vested in their profit-sharing contributions on the last day of the month immediately preceding the first anniversary of the participant’s employment commencement date.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the balance in the participant’s account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence which may be repaid up to 10 years. Each participant may not have more than one loan outstanding at any time. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the Internal Revenue Code (IRC).

Payment of Benefits

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, hardship or termination of service. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account, or annual installments. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA. If the account balance is less than \$1,000, the distribution shall be paid in the form of a lump-sum benefit.

Forfeitures

At December 31, 2024 and 2023, forfeited accounts totaled \$4,292 and \$3,785, respectively. Forfeited accounts are utilized first to reduce Plan expenses and second to reduce employer contributions. Remaining forfeitures are allocated to participants in proportion to each participant's compensation for the year. In 2024, \$9,315 of forfeitures were used to reduce the employer's expenses or employer contributions.

Revenue Credits

The Plan's trust agreement with Fidelity provides for a participant revenue credit arrangement, whereby the trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds. Unallocated revenue credits at December 31, 2024 and 2023 are \$29,084 and \$10,680, respectively. During 2024, the Plan received credits of approximately \$102,478, of which \$84,869 was allocated to the participants and used to pay administrative expenses. Administrative expenses are presented net of revenue credits in the statement of changes in net assets available for benefits.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from estimated amounts.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plans Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These

funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts are valued at the net asset value (NAV) of units held. The NAV, as provided by the trustee of the CCTs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCT less its liabilities. This practical expedient is not used when it is determined to be probable that the CCTs will sell for an amount different than the reported NAV. The CCTs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. These are direct filing entities.

One of the Plan's investment options includes a participant-directed brokerage account which allows participants to establish a brokerage account and select various investments consisting of mutual funds, which are recorded in accordance with the methods described above, and common stocks. Investments in common stock are stated at fair value based on the last reported sales price on the last business day of the year in the active market in which the security is traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's Retirement Plans Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 or 2023.

4. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Fidelity or their subsidiaries and affiliates. Participant loan and distribution processing fees are paid to Fidelity by participants. The Plan also receives revenue credits from Fidelity. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

5. Income Tax Status

The IRS has determined and informed the Company by a letter dated March 22, 2016, that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is exempt from federal taxes.

GAAP requires the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.
